Appropriations to Odawa Economic Development Management, Inc. (OEDMI) in the amount of \$50,000 to come from prior period funds

- **WHEREAS** the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- WHEREAS OEDMI was created as a Tribally Chartered Corporation through WOS 2009-24 for nongaming economic development;
- WHEREAS OEDMI was charged with the development of the property at 1966 US 131 S, Petoskey, MI;
- WHEREAS OEDMI has secured a grant through the Michigan Economic Development Corporation to remove the building located on the property, in an amount not to exceed \$75,000.00 with a financial match that equal 2/3 of the cost of the total project costs;
- **WHEREAS** the matching financial contribution is \$50,000.00 in order to be awarded the grant through the Michigan Economic Development Corporation.
- WHEREAS The Appropriations and Finance Committee motioned, at its regularly scheduled meeting held on February 22, 2013, to recommend to Tribal Council to approve the appropriation of funds requested from OEDMI, in the amount of \$50,000.00 to come from prior period funds.

THEREFORE BE IT RESOLVED that Tribal Council through its Constitutional duty "authorizes the appropriation" of funding to the Odawa Economic Development Management, Inc. (OEDMI) in the amount of \$50,000.00, to come from prior period funds and the Tribal Chairman shall administer his oversight authority to the extent necessary to ensure the administration of such funds.
