TRIBAL RESOLUTION # 122018- 01

**Supplemental Funding to Enjinaaknegeng in the Total Amount of \$384,645.02 for Legal Settlement Payment**

**WHEREAS** the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

**WHEREAS** in order to settle a potential law suit, Enjinaaknegeng was requested by Tribal Council to negotiate a settlement;

**WHEREAS** supplemental funding will need to be added to Enjinaaknegeng- General Fund budget for FY 2019 in order to pay out the settlement.

**THEREFORE, BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and supplements funding to the Enjinaaknegeng- General Fund budget for FY 2019 in order to pay out the settlement in the total amount of \$384,645.02 to come from the General Fund, Fund Balance-Supplemental.

**FURTHER BE IT RESOLVED** that in accordance with the Constitution the Executive Branch shall administer such funds as appropriated by Tribal Council.




