# COUNTY EXECUTIVE OAKLAND L. Brooks Patterson Offers Apology to Native American Tribes in Michigan

L. Brooks Patterson, an Oakland County, MI, Executive, drew criticism from Native Americans in Michigan when the New Yorker magazine published a profile of him and quoted Patterson saying, "I made a prediction a long time ago, and it's come to pass. I said, 'What we're gonna do is turn Detroit into an Indian reservation, where we herd all the Indians into the city, build a fence around it, and then throw in the blankets and the corn."

As was reported in the March issue of Odawa Trails in an article by LTBB Tribal Citizen Andrea Pierce, Patterson's comments prompted an Idle No More - Oakland County round dance and press conference held on January 21, 2014, prompted Saginaw Chippewa Tribal Chief Steve Pego to write a letter condemning the remarks and prompted the LTBB Tribal Council and LTBB Tribal Chairman Fred Kiogima to sign a declaration condemning his remarks.

In a letter dated February 11, 2014, Patterson wrote an apology to Matthew Wesaw, the Executive Director of the Michigan Department of Civil Rights, and the United Tribes of Michigan. Wesaw read the letter to tribal leaders from around the



state at the United Tribes of Michigan annual meeting held in late February 2013.

In the letter, Patterson stated he met with Wesaw privately on January 30, 2014, and he (Wesaw) informed me why my statements from three decades ago, recently resurrected in the New Yorker magazine, were so hurtful to the Native American com-

Patterson went on to write, "I was unaware of the entire sordid episode of Native Americans facing extinction through the imposition of disease filled blankets. I apologize for my ignorance of history and I want you to know that it was never my intent to disrespect Native Americans. I hope that my record shows that I have been a longtime supporter of the Native

# Maria's Confections, Owned by LTBB Tribal Citizen Maria SARGENT, OFFERS DELICIOUS DESSERTS AND MORE IN PETOSKEY, MICHIGAN

In 2002 when they were planning their wedding, Maria Sargent and her husband, Rob, had a hard time finding someone to do their wedding cake.



"We found there weren't a lot of people in this area (Northern Michigan) who made wedding cakes from scratch," said Sargent, an LTBB Tribal Citizen who lives in Petoskey, MI. "It was a niche no one was filling."

In 2005, she and her husband built a commercial kitchen with four restaurant-size ovens behind her parents' house in Petoskey, MI, and she started making wedding cakes and special-order cakes from scratch.

Sargent, who graduated from the New England Culinary Institute in Vermont, normally does three wedding cakes every weekend during the wedding season (from the Fourth of July to Labor Day) and has done up to five wedding cakes in

a weekend. Kim Patrick assists her in the summer with dec-

"Most people will bring in a picture of what they want their wedding cake to look like, and I go from there," Sargent said. "Most want simple, textured cakes right now, but it varies from season to season. Last summer, cupcakes were more popular than cakes. I thought it was a temporary trend, but "Sweet Maria's" continued on page 27.



# Rebecca Lessard from Wings of Wonder, Based in Empire, MI, Release REHABILITATED BALD EAGLE RESCUED BY PASSERBY IN EAST JORDAN, MI

On February 15, 2014, Rebecca Lessard of Wings of Wonder released a rehabilitated bald eagle back into the wild in East Jordan, MI.

The female bald eagle spent two months recovering from injuries that were believed to be suffered when the eagle was struck by a passing car in mid-December 2013 in the East Jordan, MI, area.

A passerby discovered the eagle, kept her overnight and then took her to Jensen's Animal Hospital in Petoskey, MI, for medical treatment. The eagle

spent 24 hours in intensive care at Jensen's Animal Hospital before being transported to Wings of Wonder, a non-profit raptor sanctuary in Empire, MI, to be nursed back to health.

In addition to providing educational

programs throughout Michigan, Wings of Wonder is also a raptor rehabilitation and release facility. Sick, injured and/or orphaned raptors are admitted for treatment, rehabilitation and eventual release back to the wild. All raptors are seen and evaluated by their team of participating veterinarians. Their primary goal with rehabilitation is to release healthy and strong raptors back into the wild.

Lessard has been a wildlife rehabil-

# Veteran Spotlight In Memory of Roland M

In Memory of Roland Michael Petoskey

Roland Michael Petoskey was born on July 22, 1923 near Five Mile Creek in West Traverse Township, MI, to William and Mary (Keway) Petoskey.

He walked on December 26, 2013 at his home in Center Township, MI, near



Levering, MI.

Roland had nine siblings, Lawrence, Fred, George, Edward, Helen, Betty, Eva, Josephine and Katherine.

He attended school at Five Mile Creek and Holy Childhood of Jesus Catholic School in Harbor Springs, MI. He worked for CC Camp, a program in Petoskey, MI, until the age of 18 when he joined the U.S. Army on January 21, 1943. He served as



a tank driver in North Africa and Europe during World War II. He was awarded the Bronze Star, Good Conduct Medal and a Distinguished Unit Badge.

Following his honorable discharge on October 30, 1945, Roland returned to Harbor Springs, MI, and married Adeline Shawanibin in 1948. He and Adeline moved to the Flint, MI, area where Roland worked for General Motors for 32 years until his retirement. Adeline preceded Roland in death on August 25, 1978.

On April 19, 1980, he married Irene McCary-Gasco. Roland and Irene remained in Flint, MI, for a short time until moving back to Northern Michigan, settling near Levering, MI. Irene continues to live in their home.

He and Irene have 11 children, John Gasco, Marcia Sutton, Harry Gasco, Allen Gasco, Deleta Smith, Regina Gasco-Bentley, Bart Gasco, Stephen Gasco, the late Joseph Gasco, the late Norma Kolodgy and the late Alicia Carson.

Roland and his family held a Ghost Supper and ceremonies at his home for several years.

Roland was a fluent speaker of Anishinaabemowin. He grew up speaking the language because both of his parents only spoke Anishinaabemowin.

Roland enjoyed playing golf, making a hole in one three times, tending to his yard and working in his garden. He was a long-time Detroit Tigers fan.



Well Fellow Citizens, it has been a very eventful and fruitful month.

The weather was uncooperative at best, and enjoyable on rare occasions. The Governmental Complex was closed due to the extreme weather a few times, and we extend apologies for any inconveniences this may have caused anyone. We have experienced one of the most severe winters in a very long time. The Executive Office was very pleased to see all the departments pull together to accomplish their mission despite this harsh winter, that being providing services to our fellow Citizens, whether it be Medical Services, Facilities, Substance Abuse, Policing our Reservation boundary area, and all our other tribal entities. It is very much appreciated!!! Chi Megwetch!

We are pleased to announce the unveiling of the new LTBB website! We have attempted to make it easier to navigate and find what you are looking for, so it should be more user-friendly. I am sure it will take a little time to work all the "bugs" out, so if you encounter any problems, please let us know right away. Please check it out at http://www.ltb-bodawa-nsn.gov and let us know what you think.

On February 1, 2014, the Executive conducted a Meet & Greet in Walker (Grand Rapids), MI. The weather did not cooperate, but several Nishnaw-bekwe showed up and much discussion was had. Reaching out to as many Tribal Citizens as possible will be a hallmark of this Administration's tenure.

On February 7, 2014, the Chairman was honored to give a presentation and speech at the Petoskey Chamber of Commerce's annual "State of the Community" Luncheon, held at the Odawa Casino's Ovation Hall. The theme of my presentation was that we, as Odawa, are an integral part of this community through job creation, we have an enormous financial impact, and that we have always been involved in this community, and will remain so.

On February 8, 2014, was, again, a Meet & Greet -- this time in Escanaba, MI. It was very well attended. In fact, among the four locations, Escanaba, MI, has the smallest population to draw from and they topped with the highest number of attendees. So, let this be a challenge to see who can beat them in attendance when we do this again in six months! And again, the discussion was a significant help in getting the "word" out about the services the tribe provides and what is available to Citizens beyond the tri-county area.

Onward to February 15, 2014, which was the Meet & Greet in Detroit, MI. It was a pleasure to meet the many Tribal Citizens and local Native community service providers who joined us. And, before I forget, kudos for all the hard work that the department heads and staff put into providing upto-date resource information and logistics for these meetings. Their efforts were noticed and much appreciated.

February 22, 2014 was the last in the series of outreach to meet the Citizens, which was held in Lansing, MI. In the process through discussion with a tribal elder, we were able to clarify some issues with the Hearing Aid program and help him on the spot thanks to the department head immediately responding to our e-mail inquiry.

To sum up all the Meet & Greets, it was a pleasure meeting with all the citizens. There was much discussion as to what would be beneficial to the tribe and how can the tribe provide some services to the outlying areas. We fielded questions on many topics, from the farm to medical services to the budget, and to housing. At each Meet & Greet, the question was asked if the Executive coming out to meet them was a "positive step" in establishing a forum that will be done every six months? The resulting "affirmative" response was a key indicator that ensured this will happen every six months.

From February 24-26, 2014, the Executive Office attended the United Tribes of Michigan meeting in Lansing, MI, where we were able to discuss issues directly with the key players from the Legislature, to Economic Development, to Veteran's issues, to Human Services, to the Governor's office, and more with the State of Michigan that have a significant impact for us as a tribe. The continual positive working environment we have with our counterparts at the state will help us progress as a tribe with our future endeavors.

The Executive Office attended a town hall meeting with Congressman Gary Peters who is also running to replace U.S. Senator Carl Levin. Representative Peters is very interested in working with us as a tribe and community to move forward. During that same event, we were also able to meet with Jerry Cannon, retired Sheriff, Major General U.S. Army (Ret), and Marine. He is running for the First Congressional District. We talked jobs, budget, and employment issues, which led to his inviting the Chairman and the Vice Chair to a Jobs Summit in Petoskey, MI, which again was fruitful. Establishing a one-on-one discussion with candidates and current congressional representation will lead to positive results in the future.

The Chairman was in D.C. for the NCAI (National Congress of American Indians) Summit from March 10-14, 2014 to continue the work with Washington concerning all of our issues from health, funding, contract support costs, the Affordable Care Act (ACA), and more.



# Venison is Available to Tribal Citizens



LTBB Tribal Citizens are reminded they have access to treaty hunting and fishing rights, both in the Great Lakes and inland areas. These rights include deer harvest. The treaty rights were secured by the determined and tireless efforts of tribal citizens over the years and are permanently protected by the federal court's 2000 Great Lakes Consent Decree and the 2007 Inland Consent Decree. There are many harvest opportunities available to tribal citizens, ranging from trapping and hunting to spearing and netting of fish. For the exact methods, bag limits and seasons, please consult the approved current set of LTBB Reservation or 1836 Ceded Territory Natural Resource Rules and Regulations.

Tribal citizens who have a need outside of an approved harvest season can contact the Natural Resource Department (NRD) to request a special use permit. The special use permit request must be in writing, must state the need for the permit, and must identify who the intended harvester will be (if different from the person applying for the permit). Permits are commonly granted to allow game to be harvested for ceremonial feasts, Ghost Suppers, nam-

Article 13 of the 1836 Treaty of Washington states: "The Indians stipulate for the right of hunting on the lands ceded, with the other usual privileges of occupancy, until the land is required for settlement."

ing ceremonies, harvests for elders, educational purposes and family hardships. The person requesting the permit and any identified harvester, if different, must both be LTBB Tribal Citizens. The harvester must also have a valid LTBB hunting/fishing license. There is a license fee of \$5 for tribal citizens between the ages of 18-54; however, there is no fee for the special use permit.

The tribal citizen who is issued the special use permit is responsible for the processing and the proper use of the game or fish harvested under the permit. Processing of a typical deer can cost around

\$80. NRD can provide contact information for local deer processors. An average size deer generally yields at least 45 pounds of venison, so the cost per pound after processing is usually approximately \$1.77. The NRD also holds an annual deer processing class for those interested in learning to process their own deer.

Game, fish or other resources authorized for harvest under a special use permit are not to be sold.

# ATTENTION VETERANS - VA ANNOUNCES ROLLOUT OF SECURE VETERAN HEALTH IDENTIFICATION CARDS

Editor's note: The following is a U.S. Department of Veteran Affairs press release dated February 20, 2014.

The Department of Veterans Affairs (VA) today (February 20, 2014) announced the phased roll out of newly designed, more secure Veteran Health Identification Cards. The new cards are distinguished by additional security features and will have a different look and feel.

In addition to being more secure, the card has been transformed into a Veterans Health Identification Card (VHIC). Similar to a typical health insurance card, the VHIC displays the Veteran's Member ID, a new unique identifier, as well as a Plan ID, reflecting the Veteran's enrollment in VA health care.

"VA is committed to providing high quality health care while ensuring the personal security of Veterans," said Secretary of Veterans Affairs Eric K. Shinseki. "These new identification cards are an important step forward in protecting our nation's heroes from identity theft and other personal crimes."

The VHIC is personalized to display the emblem of the Veteran's branch of service. It also provides features that make it easier to use, such as the addition of "VA" in Braille to help visually impaired Veterans, and the printing of VA phone numbers and emergency care instructions on the cards.

The card replaces the Veteran Identification Card (VIC), which was introduced in 2004. As part of a phased rollout, starting this month, the card will only be offered to newly enrolled and other Veterans who have not been issued a VIC. Then, in early April, VA will begin a three month

effort to automatically issue the more secure VHIC to current VIC cardholders. VA recommends Veterans safeguard their VIC as they would a credit card, and cut up or shred the card once it is replaced. While not required to receive VA health care, all enrolled Veterans are encouraged to get a VHIC.

Enrolled Veterans can get more information about the VHIC by visiting their VA medical facility enrollment coordinator or the website www.va.gov/healthbenefits/vhic, calling 1-877-222-VETS (8387) or visiting their local VA health care facility.



# TAX AGREEMENT INFORMATION

The Department of Commerce (DOC) would like to remind the tribal membership about a few items pertaining to the Tax Agreement.

First of all, I cannot express enough how important it is to keep your address updated.

The first step in becoming a Resident Tribal Member (RTM) is to officially change your address with the Enrollment Department. This must be done in writing and as soon as possible.

The DOC cannot and will not change the estimated beginning date (EBD) (which is always the first in any given month) of a member's tax exempt status (see example be-

to file the Annual Resident Tribal Member Sales Tax Credit (Tribal Form 4013). It is to your benefit to be able to file for the maximum number of months for this credit.

In addition, being an RTM will allow you to purchase large items such as vehicles, boats, motorcycles and off the road vehicles tax exempt.

There is a form that needs to be filled out called a "Request for TCE" (Tribal Certificate of Exemption), which is available in my office. Once this form is completely filled out, I will then issue the RTM the actual Tribal Certificate of Exemption (Tribal Form 3998).

If you plan on purchasing any of these items, please contact me FIRST, and I will be happy to get you the form via e-mail or fax. I am also able to fax the TCEs to the dealership you are doing business with.

Being an RTM will also allow you to be tax exempt on utility bills such as phone, cable,

gas, propane, electricity, satellite and cellular service. If you have not filled out a Utility Provider Survey, please contact the DOC, and I will be happy to get one to you.

Also, another important thing to remember is if you do move into the Tax Agreement Area (TAA), your RTM status does NOT take effect until the first day of the following month.

**Example:** I move to Petoskey, MI, (inside the TAA) on September 5, 2010. My RTM (EBD) status begins October 1, 2010. All updates are sent to the State of Michigan as close to the end of the month as possible.

IMPORTANT REMINDER: TRIBAL MEMBERS ARE NOT ALLOWED TO USE THEIR TRIBAL ID SWIPE CARDS FOR PURCHASES OF NON-MEMBERS NOR ARE THEY ALLOWED TO LEND THEIR CARDS OUT TO ANYONE.

The current limit on tobacco purchases is four cartons per week per tribal citizen age 18 and over. The same applies to all other tobacco products (OTP) packaged in similar fashion.

### Tax Agreement Reminder

When moving into the LTBB Tax Agreement Area, in order to become a Resident Tribal Member, you must change your address in writing at the Enrollment Department located in the LTBB Governmental Center in Harbor Springs, MI. Your RTM status will take effect on the first day of the following month in which you moved.

Tribal identification cards now have a hologram. This is an added security feature to eliminate duplication. We are phasing out the old cards. Once your Tribal identification card has expired, you will be issued the new hologram card along with a replacement fee of \$10. Replacement cost includes: address change, lost card, expired cards and minors turning 21. There will be no fee charged for: elders (55 and up), first time picture identification card, name change, defective card, faded or cracked (must bring card to office).

# Michigan is Expanding Medicaid - Effective April 1, 2014

The U.S. Department of Health and Human Services (HHS) approved Michigan's waiver request to expand Medicaid on December 30, 2013 to individuals at 133% of the federal poverty line, which is roughly \$15,000 for an individual and \$34,000 for a family of four. Approximately 450,000 low income Michigan families will gain health insurance and access to preventive and routine care — many for the first time due to the expansion. The Federally-facilitated Marketplace (FFM) started offering health coverage in Michigan starting in 2014. Michigan Medicaid Expansion is called Healthy Michigan and will cover people who are:

- Not currently eligible for Medicaid
- Ages 19-64
- Not eligible for or enrolled in Medicare
- Not pregnant
- Have income up to 133% of the Federal Poverty Level (FPL) this is about \$15,000 for a single

person and \$34,000 for a family of four.

• No assets counted for eligibility.

The FFM will make assessments of Medicaid eligibility and then transfer the applicant's account to the state agency (DHS) for a final determination.

Director of the Michigan Department of Community Health Jim Haveman said people from Michigan should be able to start applying in March to the Marketplace to utilize the Michigan Expansion.

This is great news for many of our tribal citizens who have been denied Medicaid in the past!





# make half your grains whole



10 tips to help you eat whole grains

Any food made from wheat, rice, oats, cornmeal, barley, or another cereal grain is a grain product. Bread, pasta, oatmeal, breakfast cereals, tortillas, and grits are examples. Grains are divided into two subgroups, whole grains and refined grains. Whole grains contain the entire grain kernel—the bran, germ, and endosperm. People who eat whole grains as part of a healthy diet have a reduced risk of some chronic diseases.

make simple switches

To make half your grains whole grains, substitute a whole-grain product for a refined-grain product. For example, eat 100% whole-wheat bread or bagels instead of white bread or bagels, or brown rice instead of white rice.



whole grains can be healthy snacks Popcorn, a whole grain, can be

a healthy snack. Make it with

little or no added salt or butter.

Also, try 100% whole-wheat or rye crackers.

save some time

Cook extra bulgur or barley when you have time. Freeze half to heat and serve later as a quick side dish.

mix it up with whole grains Use whole grains in mixed dishes, such as barley in vegetable soups or stews and bulgur wheat in casseroles or stir-fries. Try a quinoa salad or pilaf.

try whole-wheat versions For a change, try brown rice or whole-wheat pasta Try brown rice stuffing in baked green peppers or tomatoes, and whole-wheat macaroni in macaroni and cheese

bake up some whole-grain goodness Experiment by substituting buckwheat, millet, or oat flour for up to half of the flour in pancake, waffle, muffin, or other flour-based recipes. They may need a bit more leavening in order to rise.

be a good role model for children Set a good example for children by serving and eating whole grains every day with meals or as snacks.

check the label for fiber

Use the Nutrition Facts label to check the fiber content of whole-grain foods. Good sources of fiber

contain 10% to 19% of the Daily Value; excellent sources contain 20% or more



choose products that name a wholegrain ingredient first on the list. Look for "whole wheat," "brown rice," "bulgur," "buckwheat," "oatmeal," "whole-grain cornmeal," "whole oats," "whole rye," or "wild rice."

be a smart shopper The color of a food is not an indication that it is a whole-grain food. Foods labeled as "multi-grain," "stone-ground," "100% wheat," "cracked wheat," "seven-grain," or "bran" are usually not 100% whole-grain products, and may not contain any whole grain.

# healthy eating for vegetarians

10 tips for vegetarians



A vegetarian eating pattern can be a healthy option. The key is to consume a variety of foods and the right amount of foods to meet your calorie and nutrient needs.

think about protein

Your protein needs can easily be met by eating a variety of plant foods. Sources of protein for vegetarians include beans and peas, nuts, and soy products (such as tofu, tempeh). Lacto-ovo vegetarians also get protein from eggs and dairy foods.

bone up on sources of calcium Calcium is used for building bones and teeth. Some vegetarians consume dairy products, which are excellent sources of calcium. Other sources of calcium for vegetarians include calcium-fortified soymilk (soy beverage), tofu made with calcium sulfate calcium-fortified breakfast cereals and orange juice, and some dark-green leafy vegetables (collard, turnip, and mustard greens; and bok choy).

make simple changes Many popular main dishes are or can be vegetariansuch as pasta primavera, pasta with marinara or pesto sauce, veggie pizza, vegetable lasagna, tofu-vegetable stir-fry, and bean burritos.

enjoy a cookout

For barbecues, try veggie or soy burgers, soy hot dogs, marinated tofu or tempeh, and fruit kabobs. Grilled veggies are great, too!

Because of their high nutrient content, consuming beans and peas is recommended for everyone. vegetarians and non-vegetarians alike.

Enjoy some vegetarian chili, three bean salad, or split pea soup. Make a hummusfilled pita sandwich.

A variety of vegetarian products look-and may taste-like their non-vegetarian counterparts but are usually lower in saturated fat and contain no cholesterol. For breakfast, try soy-based sausage patties or links. For dinner, rather than hamburgers, try bean burgers or falafel (chickpea patties).

make some small changes at restaurants Most restaurants can make vegetarian modifications to menu items by substituting meatless sauces or nonmeat items, such as tofu and beans for

meat, and adding vegetables or pasta in place of meat. Ask about available vegetarian options.



Choose unsalted nuts as a snack and use them in salads or main dishes. Add almonds, walnuts, or pecans instead of cheese or meat to a green salad.

get your vitamin B<sub>12</sub>

Vitamin B<sub>12</sub> is naturally found only in animal products. Vegetarians should choose fortified foods such as cereals or soy products, or take a vitamin B<sub>12</sub> supplement if they do not consume any animal products. Check the Nutrition Facts label for vitamin B<sub>12</sub> in fortified products.

find a vegetarian pattern for you Go to www.dietaryguidelines.gov and check appendices 8 and 9 of the Dietary Guidelines for Americans, 2010 for vegetarian adaptations of the USDA food patterns at 12 calorie levels.



Example: 1. Anishinaabemowin **Literal Translation English Translation** 

- 1. Pane gwa gii bi objikaaznaa'an tiginaaganan Anishinaabeg. Always (past) used wooden constructed things Anishinaabe people. The people have always used cradleboards.
- 2. Bebkaan igo gonemaa daa ezhi naagaadoon nindan tiginaaganan. They are different really maybe was how they are built these cradleboards. The cradleboards are all unique.
- 3. Mii maanda gaa ezhichigeyaad Anishinaabeg gii bi kooganaawaad binoojiins. So then, this was did Anishinaabeg did they raised babies. This is what the Native people did when they raised a baby.
- 4. Tiginaaganing maaba binoojiins gii moowejigaazo. In the wooden constructed, this baby did get carried around by someone. In the cradle, they carried the baby around.
- 5. Mii geye wii noondaan waaamdaan miinwa geye wii gikendaan aapichi zaagikchigaazod. And, then to hear things, to see things and to know it very to be loved.

This also was done, so babies would see things, hear things and learn while being loved by someone.





# Housing Department Programs

Services are available to citizens residing within the 27 county service area. An application packet must be completed and returned to the Housing Dept. for processing to determine qualification. To obtain an application, please contact the Housing Dept. at 231-242-1540.

**Short Term Rental Assistance:** This program offers up to \$1,500 for new tenants who need assistance with the first month's rent and/or security deposit. This can be used ONE TIME ONLY and the rent requested must be affordable and can NOT exceed 35% of the household gross monthly income. Please note the application packet must be received and approved in advance of your moving into the rental in order to qualify for this program.

**Home Improvement Program:** This program offers up to \$2,500 for non-cosmetic home repairs and may be utilized once every five years.

**Down Payment Assistance:** This program offers up to \$2,500 or 10% of your mortgage (whichever is less) and can be used to purchase or refinance a home. In order for you to receive any grant dollars, you must be able to match the grant amount with your own guaranteed funds.

**Foreclosure Prevention Program:** This program offers up to \$3,000 to assist in foreclosure prevention.

Well & Septic Assistance Program: Funded by the Indian Health Services located in Sault Ste. Marie, MI this program provides the resources and technical assistance associated with the installation of a new well and sanitation service or replacement of deficient existing well/septic.

**Credit Counseling:** We provide confidential advice and referrals to assist tribal citizens in regaining their financial stability and credibility.

**Tribal Rental Housing Program:** The LTBB Housing Department offers 29 rental units in the Northern Michigan area. These units are available to rent to Tribal Citizens and most rents are based on a family's monthly income. Any Tribal Citizen interested in renting a unit from the LTBB Housing Department should contact our offices for an application. Currently, there is a waiting list for available units.

If you move, please contact the Enrollment Office and we will send you an address verification form.

Forms are also available at www.ltbbodawa-nsn.gov. Click on Offices/Government Center/Enrollment Department and click on the appropriate form. The adult form must be printed on legal size paper and the minor form on letter size paper. We will continue to add forms there in the future.

It is the responsibility of the parent, guardian or custodial parent to complete an address verification form.

If you are a custodial parent, please provide proof by documentation.

Once a minor turns 18, you must contact the Enrollment Office and complete an address verification form or we will mark you as undeliverable.

If you are incarcerated and would like to continually receive the newsletter, you must keep your address current.



Christina has been employed by Allied EMS as a paramedic since 2002. In addition to being a


licensed paramedic, she graduated from Lake Superior State University with a Bachelor's degree in Criminal Justice.

# Michigan Indian Elders Association Student Incentive Program 2013/2014



A student incentive program is being offered by the Michigan Indian Elders Association (MIEA) to recognize students who achieve all "A's" for a marking period as well as students who achieve perfect attendance for a marking pe-

There will be a minimum of \$3,000 available to fund this program this year. \$25 will be awarded for each qualified entry, up to the minimum available funds in the program. In the event the number of qualified entries exceeds the funds available, the winners will be determined by lottery. Here are the conditions to qualify:

• The student must be an enrolled member or be a direct descendant of an enrolled member of one of the MIEA constituent tribes/bands.

- The student must be in grades K-12 at a public or private school. (Home schooling not eligible)
- A student must be in grades 4-12 to qualify for the straight "A" award. (A-, A, A+)
- For a school system using a grading system based on numbers, the equivalent to straight "A's" will be acceptable.
- A student must be in grades K-12 to qualify for the perfect attendance award.
- Perfect attendance means exactly that. A student must be in school or at a school sponsored function each day of the marking period. Excused absences for anything other than a school sponsored/approved function do not constitute perfect attendance.
- The first two marking periods of this 2014 school year will be used to determine the winners for this lottery.
- A student can qualify for both the perfect attendance and straight "A's" for both marking periods. For example, straight "A's" and perfect attendance for both marking periods would mean four chances
- A parent of the student must complete and sign the Student Incentive Program Application Form in order for

the student to qualify for an award.

· A copy of the child's report card signed by the parent or a letter from an administrator of the student's school must be submitted with the completed application form to verify the achievement of straight "A's" and perfect attendance.

The drawing to determine the winners will be held at the April 2014 meeting of the Michigan Indian Elders Association hosted by the Little Traverse Bay Bands of Odawa Indians in Petoskey, MI.



### Michigan Indian Land Claims Settlement CERTIFICATE REDEMPTION UPDATE

Submitted by the Trust Fund Board

It has been more than a decade since the original Michigan Indian Land

Claims Settlement certificates were issued.

All adults have been paid or they have deferred payment to a later date, nowever, tribal children who were enrolled before December 16, 1997 but had not yet turned 18 are still in the process of redeeming their certificates. The following steps are intended to aid in this process. Redeeming cer-

tificates from the Michigan Indian Land Claims Settlement Act, Public aw 105-143, are as follows:

1. Determine your eligibility: Tribal citizens who were enrolled, but had not reached the age of 18 on December 16, 1997 are eligible to redeem their

ertificates upon reaching the age of 18. 2. Sign your certificates with a notary: The tribal citizen redeeming his or her certificates must have a notarized signature.

3. Copy two pieces of identification: One piece of identification (e.g. Driver's license) must have a picture, and the second piece needs at least our signature.

4. Mail your signed certificates, the mailing address you would like your



# KEEP MICHIGAN WOLVES PROTECTED SUBMITS PETITIONS FOR SECOND REFERENDUM TO PROTECT WOLVES AND RESTORE VOTER RIGHTS



# **Keep Michigan Wolves Protected**

Editor's note: The following is a Keep Michigan Wolves Protected press release dated March 13,

Keep Michigan Wolves Protected submitted more than 225,000 signatures to the Secretary of State's Office today (March 13, 2014) to place a second referendum on the November 4 ballot which would protect wolves and restore the right of Michigan voters to weigh in on critical wildlife issues.

Michigan voters from all 83 counties have signed petitions on two ballot referendums expressing their support for the protection of Michigan's fledging wolf population and displeasure with the Legislature's approval of wolf hunting and taking their voting rights away.

The signatures surpass the 161,305 valid signatures needed to qualify for the ballot.

"Our message is clear - vote 'no' on both ballot measures to stop the needless wolf hunt and stop this abuse of power by the legislature," said Jill Fritz, Director of Keep Michigan Wolves Protected. "State legislators relied on exaggerated and even fabricated stories about wolf incidents in authorizing a hunt on the state's small population of wolves. Their treatment of voters is unacceptable, and the whole cooked-up case against wolves amounts to a power grab by special interests working through politicians and unelected political appointees."

The signatures were submitted after the group held a press conference at the capitol. Fritz was joined by State Representative Vicki Barnett; Dr. James Bull, President of the Detroit Audubon Society; Nancy Warren, Great Lakes Director of the National Wolf Watcher Coalition; Dawood Zwink, Executive Direc-

tor of the Michigan Muslim Community Council; John Coupe, Responsible Sportsmen to Keep Michigan Wolves Protected; David Holtz, Chapter Chair for the Michigan Sierra Club; Vicki Deisner, State Legislative Director - Midwest Region, ASPCA; and Aaron Winters, Executive Director of Kalamazoo Humane Society.

Last March, Keep Michigan Wolves Protected submitted more than 255,000 signatures to overturn a wolf hunting law (Public Act 520 of 2012) which was approved during the 2012 lame duck session and based on fabricated stories about wolf incidents in the U.P. Public Act 520 will be on the 2014 ballot, and should be rejected with a "no" vote. The legislature, ignoring the people, then passed a second law (Public Act 21 of 2013) to permit a wolf hunt and to give the political appointees on the Natural Resources Commission the power to choose game species. Public Act 21 will also be on the 2014 ballot, and should be rejected with a "no" vote.


The summary at the top of the petition reads: "A petition for a referendum election to reject Public Act 21 of 2013, which authorizes the Michigan Natural Resources Commission, whose members are appointed by the Governor, to designate animals, such as wolves, as game species."

The Board of State Canvassers has 60 days, with an option of 15 additional days, to determine if the petitions contain 161,305 valid voters' signatures. If so, Public Act 21 of 2013 will be suspended pending the outcome of the November 2014 vote.

# NOTICE: Sex Offender Registration Requirements



it really caught on. People's weddings are more casual these days, and more are held outdoors. Also, cupcakes are less expensive than cakes."

Sargent opened Sweet Maria's Confections, located in downtown Petoskey, MI, in the summer of 2012. Winter hours are Wednesday through Saturday from 10:30 a.m. to 5 p.m., and summer hours, which start in May, are Tuesday through Saturday from 10:30 a.m. to 5 p.m. It is closed the first two weeks of the year, Thanksgiving weekend and the Fourth of




"I made the decision to go to the store front because I wanted to get the everyday business," Sargent said. "I was only doing weddings before, and the wedding season is limited. I wanted a year-round business. In the winter, we have cupcakes, coffee and soups. In the summer, we have more of a selection with tortes, éclairs, cookies and ice cream."

Sargent chose the downtown Petoskey, MI, location at 437 E. Mitchell St. because she wanted to support the local downtown economy and because of its convenience.

"Growing up in Petoskey, I've always wanted to support the local downtown businesses," Sargent said. "Plus, it's close to where we live and where my son goes to school. It helps being close to Jimmy John's and Thai Orchid because neither one of them sell desserts. People stop in after they've eaten there and pick up dessert."

She also supports local charity events sponsored by the Women's Resource Center, Brother Dan's Pantry and the Little Traverse Bay Humane Society. She donates dessert items for tribal events and for other fundraisers.

Her best-selling cupcake is the Petoskey Stone. It is made of chocolate cake, caramel, chocolate ganache and chocolate rocks. All last summer, she made 1,500



cupcakes during six-day periods for the Young Americans.

"People always want cupcakes, so I make

them daily," Sargent said. "We never sell day olds. Everything is always fresh. If there is anything left at the end of the day, we give them away."

Sweet Maria's is truly a family affair. Her husband, Rob, a graduate of the New England Culinary Institute in Vermont, makes all the soups and can make all the batter and fillings. Her mother, Julie Harrington, helps develop recipes; her father, Fred Harrington, Jr. makes deliveries and watches the store on occasions; her niece, Kristie Harrington, works in the store during the summer and did a lot of the artwork in it; and her son, Riley, helps decorate cupcakes. Her uncle, Ken Harrington, and Gary Simon, a family friend, helped renovate the store.

"I thought I would just work in restaurants my whole life, but I like being a business owner and my own boss," Sargent said. "Obviously, I couldn't do it without the help of my family."

Sargent grew up in Petoskey, MI, and is a graduate of Petoskey High School, North Central Michigan College, Wilton Master Cake Decorating and the New England Culinary Institute. She cooked in California and Vermont and worked for various Northern Michigan area restaurants.

"My mom is a good cook, and both of my mom's brothers went to culinary school," Sargent said when asked where her interest in cooking came from. "It's something I've always been around and exposed to."

She met her husband, Rob, when they were both attending the New England Culinary Institute. Rob, a trained chef, works at Barrel Back Restaurant in Walloon Lake, MI, and worked six years as the Head Chef at the Sage Restaurant located inside Odawa Casino Resort in Petoskey, MI. He has spent 19 years in the culinary business. Their son, Riley, will be six in August 2014 and is in kindergarten.


