VETERAN SPOTLIGHT: JOSEPH F. NAGANASHE



Joseph F. Naganashe was born in 1932 at Five Mile Creek. He attended Five Mile Creek Country School for two years, Holy Childhood through Grade 8, and Harbor Springs High School in Harbor Springs, MI.

Joseph was 17 when he joined the U.S. Marine Corps. He completed basic training at Parris Island, SC, then went to Camp Pendleton in California and then received advanced training at demolition school at Camp Lejeune in North Carolina. Afterwards,

he entered the 105 Artillery C-1-12 Outfit, serving active duty as the company clerk in Korea from 1952-1953. From 1953-1954, he returned to Camp Pendleton where he was honorably discharged.

He returned home to Harbor Springs, MI, in 1954 where he worked in carpentry and masonry. Later that year, he received a job at GMC Flint, AC Spark Plug and worked there 29 years as a job setter in machine repair. While working, Joe played pool and softball, bowled and was the manager of the Flintstones. He retired in 1989 and currently lives in Mt. Morris, MI.

Joe continues to be active with the veterans and his communities, serving in pow wow color guards, in the color guard at Davison VFW Post 4087, the American Legion Lorena War Vets color guard and the Marine Corps

League 155 Flint Post.





On January 22, 2014, the Executive Office attended the Odawa Casino & Resort (OCR) Super Star Banquet to honor OCR employees who have gone above and beyond their duties. On January 23, 2014, the Executive attended the Chippewa Ottawa Resource Authority (CORA) meeting and supported a resolution against the Enbridge Oil Pipeline that runs under the Straits of Mackinaw. On February 1, 2014, the Executive hosted a "Meet and Greet" in Grand Rapids, MI. Three brave tribal citizens attended, considering the weather did not cooperate. It was still great to see those citizens come out and voice their concerns and questions. The conversations were about the "farm," budgets, elders, Election Board and many other areas of interest and/or concern.

Some have questioned the Executive's rationale for doing these "Meet and Greet" road trips. The Chairman and the Vice Chair are strong believers that "all" of our tribal citizens should be included in understanding what is available to tribal citizens both in our reservation boundary area and what is available to citizens in our outlying areas. We believe that "all" of our citizens are important, and are a part of us as Odawa, and to intentionally not visit as many citizens as we can, to hear their concerns and gather their input and to consider their voices not equal to those in our reservation boundary area would be a negligence on our part. This administration will always treat all our people as equals. We plan to do these road trips on a six month schedule throughout our term. We look forward to meeting more of our tribal family at all our stops this month (February).

Changing gears now to this frigid weather we have been experiencing! This weather has been a contributing factor in five government vehicle accidents, and we have had to close the governmental complex several times for all or part of the day. The Facilities Department met the challenge of keeping the roads clear through hard work and ingenuity. Thanks a lot Facilities Crew!!

chigan is Expanding Medicaid – Effective April 1, 2014

The U.S. Department of Health and Human Services (HHS) approved Michigan's waiver request to expand Medicaid on December 30, 2013 to individuals at 133% of the federal poverty line, which is roughly \$15,000 for an individual and \$34,000 for a family of four. Approximately 450,000 low income Michigan families will gain health insurance and access to preventive and routine care — many for the first time due to the expansion. The Federally-facilitated Marketplace (FFM) started offering health coverage in Michigan starting in 2014. Michigan Medicaid Expansion is called Healthy Michigan and will cover people who are:

- Not currently eligible for Medicaid
- Ages 19-64
- Not eligible for or enrolled in Medicare
- Not pregnant
- Have income up to 133% of the Federal Poverty Level (FPL) - this is about \$15,000 for a single

person and \$34,000 for a family of four.

• No assets counted for eligibility.



MyPlate snack tips for parents



10 tips for healthy snacking

Snacks can help children get the nutrients needed to grow and maintain a healthy weight. Prepare single-serving snacks for younger children to help them get just enough to satisfy their hunger. Let older kids make their own snacks by keeping healthy foods in the kitchen. Visit ChooseMyPlate.gov to help you and your kids select a satisfying snack.

save time by slicing veggies

Store sliced vegetables in the refrigerator and serve with dips like hummus or low-fat dressing. Top half a whole-wheat English muffin with spaghetti sauce, chopped vegetables, and low-fat shredded mozzarella and melt in the microwave.

mix it up
For older school-age kids, mix dried fruit,
unsalted nuts, and popcorn in a snack-size
bag for a quick trail mix. Blend plain fat-free or
low-fat yogurt with 100% fruit juice and frozen
peaches for a tasty smoothie.

grab a glass of milk
A cup of low-fat or fat-free milk or milk alternative
(soy milk) is an easy way to drink a healthy snack.

go for great whole grains
Offer whole-wheat breads, popcorn, and
whole-oat cereals that are high in fiber
and low in added sugars, saturated fat, and
sodium. Limit refined-grain products such as
snack bars, cakes, and sweetened cereals.

nibble on lean protein
Choose lean protein foods such as low-sodium deli meats, unsalted nuts, or eggs. Wrap sliced, low-sodium deli turkey or ham around an apple wedge. Store unsalted nuts in the pantry or peeled, hard-cooked (boiled) eggs in the refrigerator for kids to enjoy any time.

keep an eye on the size
Snacks shouldn't replace a meal, so look for ways
to help your kids understand how much is enough.

Store snack-size bags in the cupboard and use them to control serving sizes.

fruits are quick and easy
Fresh, frozen, dried, or canned fruits can be easy "grab-and-go" options that

need little preparation. Offer whole fruit and limit

Consider convenience
A single-serving container of low-fat or fat-free yogurt or individually wrapped string cheese can be just enough for an after-school snack.

the amount of 100% juice served.

swap out the sugar
Keep healthier foods handy so kids avoid cookies,
pastries, or candies between meals. Add seltzer water
to a ½ cup of 100% fruit juice instead of offering soda.

prepare homemade goodies
For homemade sweets, add dried fruits like apricots or raisins and reduce the amount of sugar. Adjust recipes that include fats like butter or shortening by using unsweetened applesauce or prune puree for half the amount of fat.

For youth and adults engaging in physical activity and sports, healthy eating is essential for optimizing performance. Combining good nutrition with physical activity can lead to a healthier lifestyle.

maximize with nutrient-packed foods
Give your body the nutrients it needs by eating a
variety of nutrient-packed food, including whole grains,
lean protein, fruits and vegetables, and low-fat or fat-free
dairy. Eat less food high in solid fats,
added sugars, and sodium (salt).

energize with grains
Your body's quickest energy source
comes from foods such as bread,
pasta, oatmeal, cereals, and tortillas. Be sure to
make at least half of your grain food choices whole-grain
foods like whole-wheat bread or pasta and brown rice.

power up with protein

Protein is essential for building and repairing muscle. Choose lean or low-fat cuts of beef or pork, and skinless chicken or turkey. Get your protein from seafood twice a week. Quality protein sources come from plant-based foods, too.

mix it up with plant protein foods

Variety is great! Choose beans and peas (kidney, pinto, black, or white beans; split peas; chickpeas; hummus), soy products (tofu, tempeh, veggie burgers), and

vary your fruits and vegetables

Get the nutrients your body needs by eating a variety of colors, in various ways. Try blue, red, or black berries; red and yellow peppers; and dark greens like spinach and kale. Choose fresh, frozen, low-sodium canned, dried, or 100 percent juice options.

don't forget dairy






The Harbor Springs High School Anishinaabemowin Class is very busy this biboong! There is a beautiful mural painted on the wall by former students in the classroom. The mural isn't finished, but it gives the class the opportunity to complete the wall with their own artistic abilities and vision. The class decided to finish the scenery and add more to the "story." The class has decided to label everything in Anishinaabemowin and have a "conversation wall" with some of the animals to make it interactive and practice dialogue the students are learning. They have been working very hard every day to finish the mural. Once it is done, they will have an open house and invite everybody to come see their classroom!

While painting, we took the opportunity to make this a "teachable moment," and we incorporated our actions into language learning. There is a chart below which shows what we learned and practiced in the classroom during the time we were finishing the mural. The Level 2 students even had a quiz on it and did quite well. They have decided to paint migizi miinwaa nme (eagle and sturgeon) to add to the scene. They have also added wiisgaak miinwaa biishkimkaa (black ash tree and wetlands) for future lessons in the life cycle of the black ash tree and how it is important to Odawa life and it's role in the wetlands. Approximately 30 people attended, and there were several successful trades and barters that took place. Some of the services bartered were skilled labor, cleaning services, running errands, sewing services, gardening services/yard work, mechanical work, bead work and carpentry skills. Items bartered were baskets, a jingle dress, beadwork, a tanned hide, material/broadcloth, leather moccasins, books and blankets.

The event was attended by all ages, from young children to elders. Keep in mind this is not limited to just adults. Our children are born negotiators and will pick up fast on how this works. In fact, we could probably learn a thing or two from THEM.

Traditionally, our people were prolific traders throughout the Great Lakes, trading with a number of tribes before the arrival of Europeans into the western Great Lakes in the 17th century. Tribes the Odawa would trade with included the Ojibway, Potawatomi, Nippising, Huron/Wyandot, Cree, Illinois, Miami and other various tribal nations in the Great Lakes. Odawa villages, situated at the center of the Great Lakes at Manitoulin Island, Mackinac and Waganakising, offered the Odawa an advantageous position in controlling trade routes and goods passing through the critical passage at the Straits of Mackinac. The Odawa would trade their corn, ma-



ple sugar, woven mats, dried berries and fish to other tribes. In return, the Odawa would receive furs, meats, tools and tobacco. The birch bark canoes manufactured by the Odawa were considered some of the best, and these canoes would also be trades. These canoes could haul up to four tons of goods

and 6-8 paddlers.

Upon the first contact with Europeans (which were the French) in the early 1600s, the Odawa immediately struck up a relationship built on trade with the French. The French saw the Odawa had all the skills to carry out business; they knew the lands, had relationships with other tribes and the skill and ability to navigate not only treacherous rivers and the Great Lakes, but also had the right to gain access to other tribal territories. In Odawa communities, good trade was essential for survival. Another group that was willing to trade was seen as extended family many times and treated accordingly. Many times, various individuals would marry into distant communities to have access to natural resources and rights to carry on business. The kinship networks the Odawa had stretched thousands of miles just as their trade routes did. Odawa would trade in Montreal, Detroit, Green Bay and as far west as Manitoba. These routes covered thousands of miles with the hub being at Northern Michigan. When trading, gifts were often exchanged between the Odawa and their respective trading partners.

With this being said, trading helped define the history of the Odawa for centuries. It was a way of life for us and will continue to be. Hence, the next barter day or Odaawe Giizhigat will be held on March 8, 2014 from noon to 4 p.m. at the LTBB Governmental Center off of Pleasantview Road in Harbor Springs, MI. Bring with you your items to barter, or pictures of them, and maybe even some scrap paper or business cards ... something you can jot down your contact information on to hand out to people.

DEPARTMENT OF COMMERCE UPDATE

Aanii kina gwayah (hello everyone). During the month of January 2014, the Department of Commerce (DOC) mailed out the 2013 Michigan Resident Tribal Member Annual Sales Tax Credit forms (Tribal 4013) to more than 500 RTMs. This is a tax credit for RTMs ONLY. Forms were mailed to persons aged 18 and over as of January 1, 2013. To persons under the age of 18, you may contact the DOC office or have your parent(s) contact the office to request the form. I will be happy to mail the form or you may stop by to pick one up.

On the same note, once taxes are filed, some people MAY receive either a denial or reduction/ adjustment letter regarding the Tribal 4013. If you receive this type of letter, please contact my office immediately as there are time constraints pertaining to the letter, and I will assist you with this endeavor.

January 2014 also brought another change to the department. A public use computer was installed in the office foyer so tribal citizens may complete any of the DOC forms electronically. Most forms are available in a PDF type able format.

As a reminder, DOC has notarial services available. If you are outside of the tribal jurisdiction, DOC is also a state notary and can travel to offer this service to tribal citizens outside of the historic reservation boundaries within reason. Meaning, I cannot travel to Flint, MI, or Traverse City, MI, but within Emmet County, MI, or the northern part of Charlevoix County, MI, that is doable, particularly if you're an elder or are disabled.

I also wanted to remind citizens if you have some type of disability which makes it difficult to move or you are unable to get out of a vehicle to come in and physically sign the log sheets for fuel and tobacco purchases, please contact my office to request a "Authorized Use of Tribal ID by a Non-Member" form. This will allow a designee to sign on your behalf to make such purchases.

TAX AGREEMENT INFORMATION

The Department of Commerce (DOC) would like to remind the tribal membership about a few items pertaining to the Tax Agreement.

First of all, I cannot express enough how important it is to keep your address updated.

The first step in becoming a Resident Tribal Member (RTM) is to officially change your address with the Enrollment Department. This must be done in writing and as soon as possible.

The DOC cannot and will not change the estimated beginning date (EBD) (which is always the first in any given month) of a member's tax exempt status (see example be-

It is YOUR responsibility to update your address on file with the Enrollment Department. This date will affect how many months you will be able

to file the Annual Resident Tribal Member Sales Tax Credit (Tribal Form 4013). It is to your benefit to be able to file for the maximum number of months for this credit.

In addition, being an RTM will allow you to purchase large items such as vehicles, boats, motorcycles and off the road vehicles tax exempt.

There is a form that needs to be filled out called a "Request for TCE" (Tribal Certificate of Exemption), which is available in my office. Once this form is completely filled out, I will then issue the RTM the actual Tribal Certificate of Exemption (Tribal Form 3998).

If you plan on purchasing any of these items, please contact me FIRST, and I will be happy to get you the form via e-mail or fax. I am also able to fax the TCEs to the dealership you are doing business with.

Being an RTM will also allow you to be tax exempt on utility bills such as phone, cable,

gas, propane, electricity, satellite and cellular service. If you have not filled out a Utility Provider Survey, please contact the DOC, and I will be happy to get one to you.

Also, another important thing to remember is if you do move into the Tax Agreement Area (TAA), your RTM status does NOT take effect until the first day of the following month.

Example: I move to Petoskey, MI, (inside the TAA) on September 5, 2010. My RTM (EBD) status begins October 1, 2010. All updates are sent to the State of Michigan as close to the end of the month as possible.

Minors who turn 18 by OC-TOBER 31, 2014 must complete an ADULT ADDRESS VERI-FICATION FORM. This form must be returned by OCTOBER 31, 2014.

Attention Disabled Veterans

IMPORTANT INFORMATION: A disabled veteran, with a disability that is 100% service related, honorably discharged from the armed services is exempt from the collection of property taxes.

To obtain the exemption, an affidavit showing the facts is required and a legal description of the real property shall be filed by the property owner or his/her legal guardian with the supervisor or other property assessing officer. Tax Agreement Reminder

When moving into the LTBB Tax Agreement Area, in order to become a Resident Tribal Member, you must change your address in writing at the Enrollment Department located in the LTBB Governmental Center in Harbor Springs, MI. Your RTM status will take effect on the first day of the following month in which you moved.

Tribal identification cards now have a hologram. This is an added security feature to eliminate duplication. We are phasing out the old cards. Once your Tribal identification card has expired, you will be issued the new hologram card along with a replacement fee of \$10. Replacement cost includes: address change, lost card, expired cards and minors turning 21. There will be no fee charged for: elders (55 and up), first time picture identification card, name change, defective card, faded or cracked (must bring card to office).

The LTBB Elders Advisory Board provides a supportive forum for the varied needs for the Elders in the Little Traverse Bay Bands of Odawa Indians. The purpose is to aid and assist in the improvement of the economic, social, healthful and spiritual well-being of Elders. The board acts as an advocate to provide assistance to the performance of the Elders staff. The board also perpetuates a positive influence on the members and works to promote emotional and spiritual well-being through social interactions.

Meeting called to order at 1 p.m. by Chairperson Virgina Lewis.

Officers present: Chairperson Virgina Lewis, Vice Chairperson Janice Shackleford and Secretary Fran Holdorph.

Members signed in: John Kawegoma, Richard Wemigwase and Bill Denemy.

Elders Department staff present: Coordinator Tammy Okuly-Shananaquet.

Guest: Tribal Chairman Fred Kiogima was asked to clarify some issues we had.

A motion was made by Fran Holdorph and seconded by Janice Shackleford to deviate from the agenda for the December 3, 2013 meeting and meet with Tribal Chairman Fred Kiogima.

Motion passed.

Old Business

Originally, we were going to fill baskets for the shutin's, but the supplies were not here. Postponed until next Tuesday. Also postponed: The planning for the upcoming Michigan Indian Elders Association (MIEA) meeting to be hosted by LTBB and to be held in April 2014, setting up next year's schedule and receiving information from the LTBB Elders Association.

New Business

Tribal Chairman Fred Kiogima was asked to attend our meeting to clarify some points that were circulating. It was stated the Tribal Chairman was pushing to dissolve the Elders Department and make it a program again. We asked the reasoning behind this, and he stated he was all for the Elders Program becoming a department, but where was the actual financial planning? He stated Tammy Okuly-Shananaquet should be paid a Director's wages, which was current wages plus \$30,000. There were no funds to do this or any of the other department updates. It was stated in the statute passed the department would continue with current staff and work into a full department. The Elders Advisory Board Chairperson Virgina Lewis noted because the budget is worked on two to three years in advance, there never would be a budget to

make a "department" happen. Also, in prioritizing departments, it was stated all LTBB personnel might not have use for some of the other departments (NRD, Language, Education, etc.), but everyone would be an elder at some point in his or her life and have relatives who would be elders. It was asked, "What department would be most important?"

It was noted the choices the Tribal Council has made spending money on a defunct day care center, money to Mackinaw City, MI, to approve a proposed casino, a water park which was torn down and a recent farm seemed to be more important than elders.

We also asked about Tribal Council wanting to make a "Commission" for the Elders Department. What would this do to the LTBB Elders Advisory Board and the LTBB Elders Association and to us individually? We stated if there was NO money for a department, why pay a group \$22,000 per year to do what we were volunteering to do?

We had a very interesting meeting.

The meeting was adjourned at 2:20 p.m.

and trash removal Utility bills not allowed: cell phone, cable,

satellite, Internet

Hand written receipts, cancelled checks or money order receipts will NOT be accepted.

(This is a reimbursement program; please provide PROOF OF PAYMENT or your application will be denied)

Step 2: How to complete application

- 1. Complete and **sign** the application.
- 2. Double check your 2014 grocery receipts add up to \$200.
- 3. Double check your **2014** utility bills add up to \$200.
- 4. Mail to above address or drop off at the office.

Step 3: How your application is processed

- Please note this process takes about 2 weeks.
- 1. When we receive your application, it is stamped with the date it arrives.
- 2. We review the application to make sure it's complete with signature and add up the grocery receipts and utility receipts.





Michigan Indian Land Claims Settlement CERTIFICATE REDEMPTION UPDATE

Submitted by the Trust Fund Board

It has been more than a decade since the original Michigan Indian Land Claims Settlement certificates were issued.

All adults have been paid or they have deferred payment to a later date however, tribal children who were enrolled before December 16, 1997 but had not yet turned 18 are still in the process of redeeming their certificates.

The following steps are intended to aid in this process. Redeeming cerificates from the Michigan Indian Land Claims Settlement Act, Public Law 105-143, are as follows:

- 1. Determine your eligibility: Tribal citizens who were enrolled, but had not reached the age of 18 on December 16, 1997 are eligible to redeem their certificates upon reaching the age of 18.
- 2. Sign your certificates with a notary: The tribal citizen redeeming his or her certificates must have a notarized signature.
- 3. Copy two pieces of identification: One piece of identification (e.g. Driver's license) must have a picture, and the second piece needs at least your signature.
- 4. Mail your signed certificates, the mailing address you would like your check sent to and two pieces of identification to the following address



Each summer the Sequoyah National Research Center (SNRC) hosts three tribally affiliated student interns for the period of June 1 through July 31. Interns work at least 25 hours per week in the Center doing basic archival and research work under the direction of Center staff.

The SNRC at the University of Arkansas at Little Rock (UALR) houses the papers and special collections of tribal individuals and organizations, the world's largest archival collection of newspapers and other periodicals published by tribal individuals and organizations, and the Dr. J. W. Wiggins Collection of Native American Art, consisting of more than 2,500 artworks.

The goal of the Native American Student Internship Program is to provide students an experiential learning environment in which to acquire an understanding of the value of archives and the research potential of the collections of the Center and to engage in academic research and practical database building activities related to tribal culture, society, and issues. Interns are expected to demonstrate the value of their experience by either a summary report of work, finding aids for collections, or reports of research or other written work that may be shared with their home institutions.

To qualify for an internship, students must

- · Be tribally affiliated
- · Have completed at least 60 college hours
- · Be in good standing at their home institutions

Applications should include

- · An unofficial copy of the student's academic transcript
- \cdot A reference or sponsor letter from the head of the student's major department or from another relevant academic official
- · A statement of no more than one page expressing why the intern experience would likely be beneficial to the student's academic or career goals.

To assist the student in meeting expenses during the two-month tenure of the internship, the Center provides on-campus housing and \$2,000 to defray other living expenses.

OAKLAND COUNTY HELD IN RESPONSE TO L. BROOKS PATTERSON'S RACIST COMMENTS

On January 21, 2014, local Detroit, MI, news stations reported L. Brooks Patterson, Oakland County Executive, stated in the New Yorker magazine, "I made a prediction a long time ago, and it's come to pass. I said, 'What we're going to do is turn Detroit into an Indian reservation, where we herd all the Indians into the city, build a fence around it, and then throw in the blankets and corn."

In direct response to his remarks, there was an IDLE NO MORE round dance and press conference held January 27, 2014 in Oakland County, MI, where we partnered with the National Action Network (NAN).

The minus-7 degree weather could not stop the 30 warriors, all wearing beautiful, colorful blankets and participating in the fight against racism. We danced, sang and the local news interviewed us. We explained to the news reporters about how the blankets and corn represented the Holocaust and genocide which was perpetrated against the Native American people when we were being removed to the reservations. The blankets and corn given to the Natives as gifts were poisoned with small pox which killed thousands of our people. We explained we did not appreciate our history being joked about and used for a publicity stunt.

People wrote letters and called Patterson's office. The Saginaw Chippewa Tribal Chief Steve Pego wrote a letter condemning the racist remarks and asking the Native American people to stand with

LTBB wrote a declaration, signed by all of Tribal

Council and Tribal Chairman Fred Kiogima, against the racist remarks and also asked the Native people to stand up against racism.

L. Brooks Patterson sent out a press release stating an Indian chief came to visit him and explained to him about the corn and blankets. His staff sent out letters, saying he was going to speak to the United Tribes of Michigan. However, when I talked to Frank Ettawageshik, the Executive Director of the United Tribes of Michigan, Ettawageshik said, "L. Brooks Patterson's office has not been in contact with me to be added to the agenda. He is not expected at the meeting."



A partnership between Vision Maker Media and the Nebraska Educational Telecommunications (NET), the project was funded by the Shakopee Mdewakanton Sioux Community in Prior Lake, MN, and Humanities Nebraska.

The 71-page book features audio and video segments from the NET/Vision Maker Media award-winning PBS documentary, Standing Bear's Footsteps, as well as new material. The eBook is divided into two sections the first part is designed for general readers, and the second part is for educators who are interested

in using it for the classroom.

The documentary, produced by Christine Lesiak and Associate Producer Princella Parker (Omaha), premiered in 2012 on

In 1877, the Ponca people were exiled from their Nebraska homeland to Indian territory in present-day Oklahoma. To honor his dying son's last wish to be buried in his homeland, Standing Bear set off on a grueling, 600-mile journey home. Captured en route, Standing Bear sued a famous U.S. Army General for his freedom choosing to fight injustice not with weapons, but with words. The chief stood before the court to prove an Indian was a person under the law.

The story quickly made newspaper headlines attracting powerful allies as well as enemies.



Michigan Indian Elders Association Student Incentive Program 2013/2014



A student incentive program is being offered by the Michigan Indian Elders Association (MIEA) to recognize students who achieve all "A's" for a marking period as well as students who achieve perfect attendance for a marking period.

There will be a minimum of \$3,000 available to fund this program this year. \$25 will be awarded for each qualified entry, up to the minimum available funds in the program. In the event the number of qualified entries exceeds the funds available, the winners will be determined by lottery. Here are the conditions to qualify:

• The student must be an enrolled member or be a di-

rect descendant of an enrolled member of one of the MIEA constituent tribes/bands.

- The student must be in grades K-12 at a public or private school. (Home schooling not eligible)
- A student must be in grades 4-12 to qualify for the straight "A" award. (A-, A, A+)
- · For a school system using a grading system based on numbers, the equivalent to straight "A's" will be acceptable.
- A student must be in grades K-12 to qualify for the perfect attendance award.
- Perfect attendance means exactly that. A student must be in school or at a school sponsored function each day of the marking period. Excused absences for anything other than a school sponsored/approved function do not constitute perfect attendance.
- · The first two marking periods of this 2014 school year will be used to determine the winners for this lottery.
- A student can qualify for both the perfect attendance and straight "A's" for both marking periods. For example, straight "A's" and perfect attendance for both marking periods would mean four chances to win.
- A parent of the student must complete and sign the Student Incentive Program Application Form in order for

A Note from the Chairman on Safety

By the time you read this, I hope we are well into a warm spell, but if it's still cold, Tribal Members should be careful when refueling at Biindigen (or any gas station). Biindigen Manager Don Portman has pointed out that the cold weather makes it very tempting for all of us to get back into our nice warm vehicles while the gas is pumping, but this can be very dangerous. That's because static electricity builds up from the friction of getting in and out of the car, and the static can suddenly ignite gas or gas fumes at the pump. According to the Petroleum Equipment Institute, there have been 176 reports of gas fires while refueling that were most likely caused by static electricity. (A video of a static fire can be seen on the PEI website at www.PEI.org, under the tab "Stop Static.") Just a reminder- stay outside the car while refueling, and stay safe!

Housing Department Programs

Services are available to citizens residing within the 27 county service area. An application packet must be completed and returned to the Housing Dept. for processing to determine qualification. To obtain an application, please contact the Housing Dept. at 231-242-1540.

Short Term Rental Assistance: This program offers up to \$1,500 for new tenants who need assistance with the first month's rent and/or security deposit. This can be used ONE TIME ONLY and the rent requested must be affordable and can NOT exceed 35% of the household gross monthly income. Please note the application packet must be received and approved in advance of your moving into the rental in order to qualify for this program.

Home Improvement Program: This program offers up to \$2,500 for non-cosmetic home repairs and may be utilized once every five years.

Down Payment Assistance: This program offers up to \$2,500 or 10% of your mortgage (whichever is less) and can be used to purchase or refinance a home. In order for you to receive any grant dollars, you must be able to match the grant amount with your own guaranteed funds.

Foreclosure Prevention Program: This program offers up to \$3,000 to assist in foreclosure prevention.

Well & Septic Assistance Program: Funded by the Indian Health Services located in Sault Ste. Marie, MI this program provides the resources and technical assistance associated with the installation of a new well and sanitation service or replacement of deficient existing well/septic.

Credit Counseling: We provide confidential advice and referrals to assist tribal citizens in regaining their financial stability and credibility.

Tribal Rental Housing Program: The LTBB Housing Department offers 29 rental units in the Northern Michigan area. These units are available to rent to Tribal Citizens and most rents are based on a family's monthly income. Any Tribal Citizen interested in renting a unit from the LTBB Housing Department should contact our offices for an application. Currently, there is a waiting list for available units.

If you move, please contact the Enrollment Office and we will send you an address verification form.

Forms are also available at www.ltbbodawa-nsn.gov. Click on Offices/Government Center/Enrollment Department and click on the appropriate form. The adult form must be printed on legal size paper and the minor form on letter size paper. We will continue to add forms there in the future.

It is the responsibility of the parent, guardian or custodial parent to complete an address verification form.

If you are a custodial parent, please provide proof by documen-

Once a minor turns 18, you must contact the Enrollment Office and complete an address verification form or we will mark you as undeliverable.

If you are incarcerated and would like to continually receive the newsletter, you must keep your address current.

Towards the end of the year, we will notify you for purposes of the per capita payment.

Adult verification form must be witnessed.

Minor verification form must be notarized.



"Veteran Spotlight" continued from page 1. Indian Town (Harbor Springs, MI). He grew up in Cross Village, MI, with his parents, Joseph and Helen Samuels, and siblings, Glenna, Margaret (Mickey), Evangeline, Catherine and Edward.

He attended parochial school in Cross Village, MI, and completed one year of high school.

When he was 15, he traveled to Chicago, IL, and began working there.

When he turned 18, he joined the U.S. Navy. He was the only Native in boot camp in Great Lakes, IL. He later



attended Gunnery School and received his Gunner's Mate certificate. He was a Gunner's Mate until World War II ended in 1945 and was honorably discharged. He also served in the Vietnam War as a Merchant Marine delivering supplied overseas.

He retired in 1996 after working several different jobs, one of which was at Victories Casino in Petoskey, MI, as a Housekeeper.

He and his late wife, Frances, have five children, Dean Samuels, Jr., Cheryl Samuels, Karen Norris, Sandra Walker and Terry Samuels.

He currently resides in Harbor Springs, MI.

Justice Department Announces Three Tribes to Implement Special Domestic Violence Criminal Jurisdiction Under VAWA 2013

Editor's note: The following is a U.S. Department of Justice (DOJ) press release dated February 6, 2014.

Three American Indian tribes – the Pascua Yaqui Tribe of Arizona, the Tulalip Tribes of Washington and the Umatilla Tribes of Oregon – will be the first in the nation to exercise special criminal jurisdiction over certain crimes of domestic and dating violence, regardless of the defendant's Indian or non-Indian status, under a pilot project authorized by the Violence Against Women Reauthorization Act of 2013 (VAWA 2013).



"This is just the latest step forward in this administration's historic efforts to address the public safety crisis in Indian country," said Attorney General Eric Holder. "Every day, we're working hard to strengthen partnerships with tribal leaders and confront shared challenges - particularly when it comes to protecting Indian women and girls from the shocking and unacceptably high rates of violence they too often face. With the important new tools provided by the Violence Against Women Reauthorization Act of 2013, these critical pilot projects will facilitate the first tribal prosecutions of non-Indian perpetrators in recent times. This represents a significant victory for public safety and the rule of law, and a momentous step forward for tribal sovereignty and self-determination." Although the provisions authorizing the special jurisdiction take effect generally in March 2015, the law also gives the Attorney General discretion to grant a tribe's request to exercise the jurisdiction earlier through a voluntary pilot project. The authority to approve such requests has been delegated to Associate Attorney General Tony West. Associate Attorney General West today (February 6, 2014) congratulated tribal leaders on this historic achievement in letters to the three tribes.

"The old jurisdictional


scheme failed to adequately protect the public - particularly Native women - with too many crimes going unprosecuted and unpunished amidst escalating violence in Indian country," stated Associate Attorney General West. "Our actions today mark a historic turning point. We believe that by certifying certain tribes to exercise jurisdiction over these crimes, we will help decrease domestic and dating violence in Indian country, strengthen tribal capacity to administer justice and control crime, and ensure that perpetrators of sexual violence are held accountable for their criminal behavior."

Since the Supreme Court's 1978 opinion in Oliphant v. Suquamish Indian Tribe, tribes have been prohibited from exercising criminal jurisdiction over non-Indian defendants. This included domestic violence and dating violence committed by non-Indian abusers against their




Indian spouses, intimate partners and dating partners. Even a violent crime committed by a non-Indian husband against his Indian wife, in the presence of her Indian children, in their home on the Indian reservation, could not be prosecuted by the tribe. In granting the pilot-project requests of the Pascua Yaqui, Tulalip and Umatilla tribes today, the United States is recognizing and affirming the tribes' inherent power to exercise

"special domestic violence crim-



inal jurisdiction" (SDVCJ) over all persons, regardless of their Indian or non-Indian status, for crimes committed on or after February 20, 2014.

As described in the Department of Justice's Final Notice on the pilot project, today's decisions are based on a diligent, detailed review of application questionnaires submitted by the tribes in December 2013 along with excerpts of tribal laws, rules and policies, and other relevant information. That review, conducted in close coordination with the Department of the In-



terior and after formal consultation with affected Indian tribes, led the Justice Department to determine the criminal justice systems of the Pascua Yaqui, Umatilla and Tulalip tribes have adequate safeguards in place to fully protect defendants' rights under the Indian Civil Rights Act of 1968 as amended by VAWA 2013.

The Department of Justice is posting notices of the pilot-project designation on the Tribal Justice and Safety website and in the Federal Register. In addition, each tribe's application questionnaire and related tribal laws, rules and policies will be posted on the website. These materials will serve as a resource for those tribes that may also wish to participate in the pilot project or to commence exercising SDVCJ in March 2015 or later, after the pilot project has concluded.






