### FROM THE EXECUTIVE UFFICE

The following is a letter from the Little Traverse Bay Bands Executive Office dated August 8, 2018.

Dear Tribal Citizens, Little Traverse Supporters, and All Community Members,

It has come to our attention that the Emmet County Lakeshore Association has published its Summer 2018 newsletter, which purports to contain an update on the Little Traverse Bay Bands of Odawa Indians v. Snyder litigation. The update contains misleading and biased information about our Tribe and the lawsuit. Because of the importance of this lawsuit to our entire community, we felt it critical to offer our perspective on the issues addressed.

The decision to bring suit against solely the Governor of the State of Michigan in August 2015 was the culmination of over two hundred years of history between the Little Traverse Bay Bands of Odawa Indians, the Waganakising Odawak, and our neighbors. In 1855, our Tribe negotiated the Treaty of Detroit at the center of this case

### LTBB COMMEMORATES ODAWA CASINO MACKINAW EXPANSION WITH A GRAND OPENING CELEBRATION

At its December 7, 2017 meeting, the Mackinaw City Village Council voted 5-1 to approve Odawa Casino's request to offer Class III gaming at Odawa Casino Mackinaw in Mackinaw City, MI.

LTBB's original compact with the State of Michigan llows the tribe to have a second Class III casino in "eligible tribal lands" as long as it received approval from a local governing body.

Having gained approval for Class III gaming, Odawa Casino expanded its Mackinaw City location by adding 100 new slot machines and the new Mukwa Bar & Grill. A Mackinaw City Expansion Celebration was held on July 26, 2018, which included a ribbon cutting, complimentary cake and food as well as free slot play drawings.

"We are thrilled that we are able to expand this location," Odawa Casino General Manager Eric McLester said. "What started so small is growing into something we are really proud of, and has a positive presence in the area. Being able to expand opens so many doors for us and allows us to continue to give back to this community."

LTBB originally opened Odawa Casino Mackinaw on May 25, 2016 as a 5,000 square foot Class II gaming facility with 120 slot machines after the Mackinaw City Village Council voted 4-3 on October 15, 2015 to decline a request to build a Class III casino within the city limits of Mackinaw City. LTBB was able to move forward with the Class II gaming facility because it did not need the approval of a local governing body to open a Class II casino.

LTBB acquired the land on which Odawa Casino Mackinaw was built in 2012.

### TRIBAL COUNCIL SEEKS TO FILL GAMING ENTERPRISE BOARD POSITIONS

Tribal Council is looking to fill the following Gaming Enterprise Board terms:

Two positions where the three-year terms have already expired.

Two positions whose terms will expire on September 3, 2018.

One position whose term will expire on September 30, 2018.

Waganakising Odawak Statute 2015-009 mandates the purpose of the board is to monitor and provide oversight and direction regarding the management of the Odawa Casino Resort. The board is charged with maximizing both the revenues and associated EBITDA while also maximizing employment opportunities for tribal citizens. The board shall consist of persons with business and gaming experience, including both tribal citizens and others.

#### **REQUIRED QUALIFICATIONS**

To serve on the Gaming Enterprise Board, a person must possess the following seven minimum qualifications and must be licensed under the tribe's Gaming Regulatory Ordinance.

• Associate or Bachelor's Degree in Business Administration, Finance or Hospitality; or in a related discipline; and

#### Either:

A minimum of three years successful work experience in a senior management position in the field of business administration, public administration, hotel management, accounting, finance or law, preferably with specialized knowledge and expertise relevant to the gaming industry; or

A minimum of six years of gaming work experience; and

• Leadership qualities, shows good judgment, is approachable and team oriented; and

• No person can serve on the Gaming Enterprise Board who is an elected official of LTBB;

• No person can serve on the Gaming Enterprise Board who is employed by any Gaming Enterprise of LTBB; and

• No person shall serve as a Gaming Enterprise Board member, who is within seven years of completion of a sentence or probation upon being convicted of a felony in tribal, state or federal court unless such conviction has been vacated or overturned; and

• No person shall serve as a Gaming Enterprise Board member who is on a security ban from the gaming enterprise or who has been banned in the last two years unless the ban is a self-imposed ban.

Once a minor turns 18, you must contact the Enrollment Office and complete an address verification form or we will mark you as undeliverable.

If you are incarcerated and would like to continually receive the newsletter, you must keep your address current.

Towards the end of the year, we will notify you for purposes of the per capita payment.

Adult verification form must be witnessed. Minor verification form must be notarized.

# ATTENTION ALL ELDERS: NEW INFORMATION REGUARDING THE FOOD & UTILITY APPROPRIATION ALLOWANCE

Tribal Elders,

The Elders Department has recently changed the Food and Utility Reimbursement Program title to the Food and Utility Appropriation Allowance. Along with the title change, please note the significant changes made to the process. As of 05/08/2018:

• No receipts OR utility statements are needed to receive the \$400 allowance

The \$400 allowance will not be considered as income, therefore, it will not affect any benefits that you are receiving OR be taxable
 To receive the \$400

allowance in a timely fashion, your address MUST be updated with Enrollment

• The new application will need to be filled out and requires the following to be provided:

∘ Name

 $\circ$  Tribal ID Number

• Current Address (as listed with the Enrollment Department)

- Date of Birth
- Telephone Number
- Signature

If you have received your Food and Utility Reimbursement for 2018, you do not need to apply again. If you did not receive your full amount of \$400, we will be sending you the application in the mail for the remainder of the allowance. If we received your application in the mail after 5-8-2018, a new application will be sent to you.







### HONORARIUM

#### August 7th, 2018

#### Dear Student,

On July 28th, 2018, Tribal Council passed the Michelle Chingwa Education Honorarium (MCEH) Act which has been enacted to provide a gift to honor Tribal Citizens that are obtaining post-secondary educational opportunities. The MCEH Act repeals and replaces the original and amended Michelle Chingwa Education Assistance Act including WOS 2007-005 and WOS 2014-010.

With the passage of the legislation, several changes have been made to the previous Michelle Chingwa Education Assistance (MCEA) Scholarship Program:

- Students attending a post-secondary institution that is accredited by a foreign government accrediting agency are now eligible for MCEH funding.
- Students are no longer required to submit FAFSA information to remain eligible for an honorarium.
- 3. Honorariums will be distributed directly to the student.

These changes became effective on 8/2/2018 for Fall 2018. The new MCEH application can be found on the LTBB website. A direct link to WOS 2018-010 has been provided below:



#### Tax Agreement Reminder

When moving into the LTBB Tax Agreement Area, in order to become a Resident Tribal Member, you must change your address in writing at the Enrollment Department located in the LTBB Governmental Center in Harbor Springs, MI. Your RTM status will take effect on the first day of the following month in which you moved.

#### ATTENTION ALL RESIDENT TRIBAL MEMBERS (RTMs)

If you are planning to purchase a vehicle, ORV or plan on doing any home improvements to your principal place of residence, <u>YOU NEED TO CONTACT ME FIRST</u> before making the actual purchase(s). You must fill out the "Request for TCE" form located on the LTBB website or by contacting my office. I will then issue you a "Tribal Certificate of Exemption" for such purchases. The tribe no longer uses the Refund Method, as indicated in the monthly newsletter, as of January 1, 2008. If you've already made a purchase, there is no recourse! If you have any questions, please feel free to contact me. Thank you. - Theresa Keshick at 231-242-1584.

Member (RTM) is to officially change your address with the Enrollment Department. This must be done in writing and as soon as possible.

The DOC cannot and will not change the estimated beginning date (EBD) (which is always the first in any given month) of a member's tax exempt status (see example below).

It is YOUR responsibility to update your address on file with the Enrollment Department. This date will affect how many months you will be able to file the Annual Resident Tribal Member Sales Tax Credit (Tribal Form 4013). It is to your benefit to be able to file for the maximum number of months for this credit.

In addition, being an RTM will allow you to pur- chase large items such as vehicles, boats, motorcycles and off the road vehicles tax exempt.

There is a form that needs to be filled out called a "Request for TCE" (Tribal Certificate of Exemption), which is available in my office. Once this form is completely filled out, I will then issue the RTM the empt on utility bills such as phone, cable, gas, propane, electricity, satellite and cellular service. If you have not filled out a Utility Provider Survey, please contact the DOC, and I will be happy to get one to you.

Also, another important thing to remember is if you do move into the Tax Agreement Area (TAA), your RTM status does NOT take effect until the first day of the following month.

Example: I move to Petoskey, MI, (inside the TAA) on September 5, 2010. My RTM (EBD) status begins October 1, 2010. All updates are sent to the State of Michigan as close to the end of the month as possible.

### USDA FOOD DISTRIBUTION PROGRAM ON INDIAN RESERVATIONS (FDPIR) UPDATES Shell Egg Pilot Expansion kane Tribe of Indians, Yakama sented the opportunity to pur-



We continue to receive feedback from Indian Tribal Organizations (ITO) participating in the shell egg pilot and to monitor and evaluate how the pilot is working. Tribes use the Fresh Fruits and Vegetables Order/Receipt System (FFAVORS) to place orders for shell eggs as part of their food package benefit. The shell egg pilot replaces the powdered egg mix participants receive each month with one dozen shell eggs. The shell eggs are delivered through the United States Department of Agriculture (USDA) Department of Defense (DoD) Fresh Fruit and Vegetable Program (USDA DoD Fresh) produce vendor.

Based on the positive feedback from the 14 participating ITOs, we are able to expand the pilot to 18 additional ITOs: Acoma Food Distribution Program, Eight Northern Indian Pueblos, Pueblo of Zuni, Five Sandoval Indian Pueblos, Keweenaw Bay Indian Community, Little River Band of Ottawa Indians, Little Traverse Bay Bands of Odawa Indians, Sault Ste. Marie Tribe of Chippewa, Colville Confederated Tribes, Lummi Indian Business Council, Makah Indian Tribe, Small Tribes of Western Indian Nation, Kickapoo Tribe, Prairie Band of Potawatomi Nation and United Tribes of Kansas and Southeast Nebraska.

The addition of these 18 ITOs will increase participation in the pilot to a total of 32 ITOs, which represents almost 31% of ITOs in FDPIR. The 18 ITOs were selected based on the USDA DoD Fresh produce vendor, on-hand local inventory of powdered egg mix and the impact on the inventory of powdered egg mix at the National Multifood Warehouses. We will continue to evaluate the pilot and work collaboratively with DoD to improve and allow for future expansion of the shell egg pilot.

Dried Cranberries to Make FDPIR Debut This Fall



The FDPIR Food Package Review Work Group recently voted to introduce dried cranberries, on a limited basis, to the FDPIR food package benefit. This year, purchasing raisins was sented the opportunity to purchase dried cranberries in the interim while the raisins are not available.

The dried cranberries will come in a 35 pound case with 300 small packs of dried cranberries. USDA plans to make the dried cranberries available in the fall timeframe, and they will be offered as an additional item to all FDPIR participants. Stay tuned for their arrival!

After participants have had a chance to taste the dried cranberries, the FDPIR Food Package Review Work Group will evaluate market conditions for all FDPIR dried fruit and feedback on the dried cranberries to determine which dried fruits will be offered in the future.

Catfish is the Newest Traditional Food Offered to FDPIR



The FDPIR Food Package Review Work Group selected catfish as the next traditional food to offer through FDPIR. The product will be a two-pound package with eight unbreaded, skinless, boneless fillets that will each be approximately four ounces. We expect the product to be available later this summer.

Catfish can be prepared in a variety of ways, from grilled to blackened to pan-fried with a





# BREASTFEEDING: FOLLOWING TRADITION WORKS FOR WORKING WOMEN Inter-Tribal Council of Michigan Releases Traditional Breastfeeding Toolkit

Breastfeeding is a traditional medicine for our babies. In coordination with Breastfeeding Awareness Month, the Inter-Tribal Council of Michigan is re-releasing their culturally tailored toolkit "Breastfeeding: Following Tradition Works for Working Women." The Inter-Tribal Council of Michigan worked with Michigan tribes to create the breastfeeding toolkit which is aimed at helping American Indian employers understand and support breastfeeding employees.

According to 2009 data from the Centers for Disease Control and Prevention, American Indian and Alaska Native youth have the highest prevalence of obesity, and overall, are the only group with increasing rates. In adulthood, these rates are even higher; nearly 40% of AI/AN adults are obese and an additional 30% are overweight. Obesity is known to contribute to type 2 diabetes, high blood pressure, cardiovascular disease and several types of cancer.

Breastfeeding reduces obesity in both the mother and the child. A breastfed child receives the benefit of reductions in the incidence of obesity, type 1 and 2 diabetes, ear infections, asthma in young children, respiratory infections and skin inflammation or infection. For the mother, breastfeeding reduces the risk of not only obesity, type 2 diabetes and postpartum depression, but also reduces the risk for breast and ovarian cancer.

The American Academy of Pediatrics (AAP) and the American Association of Family Physicians (AAFP) recommend babies receive nothing but breast milk for about the first six months of life. They also recommend mothers continue breastfeeding at least until the end of a baby's first year.

In support of this effort, the Michigan Breastfeeding Network has announced a statewide initiative to provide continuity of care for mothers and babies. Supporters of this effort include hospitals; Women, Infants and Children (WIC) agencies; community stakeholders; coalitions; physicians; and the Michigan Department of Health and Human Services (MDHHS). Goals of this collaboration include higher breastfeeding initiation and duration rates, healthier babies and closer families. According to the Centers for Disease Control and Prevention 2016 Breastfeeding Report Card, 80.8% of Michigan mothers have ever breastfed. However, that number drops to 51.6% at six months of age and 31.8% at 12 months.

The Inter-Tribal Council of Michigan's Breastfeeding Toolkit provides information and culturally relevant tools and resources to help tribal employers and employees in their efforts to support breastfeeding in the workplace.

"Tribal worksites are an especially important setting for breastfeeding promotion since they affect a large number of community members," said Cathy Edgerly ITCM Comprehensive Cancer Consortium and REACH Project Manager. "By making reasonable accommodations for breastfeeding employees, employers can help support the many health benefits that breastfeeding provides to the baby as well as the nursing mother. These benefits include a lower risk of weight gain and related chronic disease, along with a decreased risk for breast, cervical, and colon cancer in the mother."

### NATIVE AMERICAN AGRICULTURE FUND LAUNCHED

once received. The settlement resulted in the creation of a \$680 million compensation fund with an additional \$80 million in debt relief. A six-month claims process resulted in approved claims for more than 3,600 Native farmers and ranchers. The settlement also created equitable relief that required USDA to create an advisory body reporting to the Secretary of USDA, enact modifications in the farm loan programs and create technical assistance opportunities for Native producers. After claims were paid, a cy pres fund was created for unclaimed amounts. After further court appeals, a second compensation payment to successful claimants was approved as were \$38 million in grants to non-profit organizations (referred to as the "fast track funds") that support Native farmers and ranchers. Those payments have been completed. In addition to the fast track funds and second compensation payment to successful claimants, the court also approved the establishment of a trust fund to

distribute the remaining *cy pres* funds to charities that support Native farmers and ranchers. Now that all appeals in the case have been exhausted, including denial of a petition of certiorari by the U.S. Supreme Court late this spring, the charitable trust fund has now been established. Trustees recently met to launch the new Native American Agriculture Fund. The NAAF is an outgrowth of the long-standing *Keepseagle v. Vilsack* case which spent more than 18 years in federal litigation.

#### History of the Case

The *Keepseagle* case received considerable attention throughout Indian country and the nation from its filing in 1999 until it was finally settled by the Obama administration. The case was based on discrimination against Native American farmers and ranchers in the U.S. Department of Agriculture (USDA) farm and ranch loan program and in the servicing of loans can be found at www.indianfarmclass.com/CyFunds.aspx The charitable trust fund is called the "Native American Agriculture Fund," and its mission is "to fund the provision of business assistance, agricultural education, technical support, and advocacy services to Native American farmers and ranchers to support and promote their continued engagement in agriculture." The Court approved the appointment of 14 trustees and an Executive Director. With more than \$266 million in funding, the NAAF is the largest philanthropic organization solely devoted to serving the Native American community.

### 14 ODAWA TRAILS DOJ ANNOUNCES EXPANSION OF PROGRAM TO ENHANCE TRIBAL ACCESS TO NATIONAL CRIME INFORMATION DATABASES



The Department of Justice (DOJ) has announced an expansion of the Tribal Access Program (TAP), a program that provides federally recognized tribes the ability to access and exchange data with the national crime information databases for both civil and criminal purposes.

For FY 2019, DOJ offers TAP services through two methods: TAP-LIGHT, which provides software that offers full access (both query and entry capabilities) to national crime information databases such as the National Criminal Information Center (NCIC), the Interstate Identification Index (III) and the International Justice and Public Safety Network (Nlets); and TAP-FULL, which provides the same capabilities as TAP-LIGHT, but also provides an additional hardware/software solution that offers the ability to submit and query fingerprint-based transactions.

Criminal agencies that may participate include law enforcement agencies, prosecutors, criminal courts, jails and probation departments. Civil agencies and programs that may participate include agencies whose staff/volunteers have contact with or control over Indian children; public housing agencies; child support enforcement agencies; Head Start programs; social service agencies that investigate allegations of abuse, neglect and exploitation of children; and civil courts that issue orders of protection, restraining orders or other keep away orders and sex offender registration programs.

The Inter-Tribal Council of Michigan via a grant from the Michigan Cancer Consortium partnered with the George Washington Cancer Institute to adapt Cancer Survivorship Training materials to Anishinaabe culture and the Indian Health Service Tribal Health System.

The focus of this training is to improve the quality of life of Native American cancer survivors and caregivers and reduce death and disability due to cancer by focusing on the importance of helping survivors achieve optimal health and well-being. Physicians, nurses and public health professionals who complete this training provided professional continuing education credits from George Washington University and the Indian Health Service.

"The purpose of this collaboration is to improve Anishinaabe cancer survival rates across the state of Michigan. The Cancer Survivorship Care Training addresses the physical, psychological, social and spiritual needs of patients both during and after cancer treatment," said Beth Sieloff, Program Manager with Inter-Tribal Council of Michigan.

Participating partners include Amanda Leonard, Raeanne Madison, Beth Sieloff, Program Managers at Inter-Tribal Council of Michigan; McKenna Roberts, Intern at Inter-Tribal Council of Michigan from Harvard University; and Mandi Chapman, Associate Center Director of George Washington University Cancer Center.

The Inter-Tribal Council of Michigan is currently scheduled to visit five tribal health centers through the summer of 2018. Inter-Tribal Council of Michigan is available to bring this training to any tribal health center in Michigan upon request.



Odawa Casino presented a check for \$437,803.71 to the Emmet County Treasurer's office on August 2, 2018. The money is part of the semi-annual revenue sharing agreement the tribe has with the county.

The revenue sharing payments began in 1999 and have totaled more than \$50 million to date. Funds from the payments to Emmet County are used locally to support infrastructure projects, education and public safety for its residents.

"We are happy to once again be able to share our revenue to give back," said Eric McLester, Gencheck to Emmet County.

In addition to the revenue sharing payments, the tribe's two casino properties and hotel operations generate tax revenue for the state and federal government through payroll tax and taxes on the goods and services purchased by the Odawa operations.

Owned and operated by the Little Traverse Bay Bands of Odawa Indians, the \$140 million Odawa Casino in Petoskey, MI, opened in June 2007 and features 1,000 slot machines, 25 table games, a poker room, several restaurants, a gift store, a nightclub and a 137-room hotel. **Editor's note:** The following is a National American Indian Housing Council (NAIHC) press release dated August 9, 2018.



The National American Indian Housing Council (NAIHC) has updated and re-launched its widely-used "Pathways Home" course to help Native American home buyers overcome the unique complexities of homeownership on sovereign tribal lands.

Completed in collaboration with Fannie Mae, with contributions from the San Manuel Band of Mission Indians and federal grants, NAIHC's effort aims to address a homeownership gap and broader economic challenges in American Indian communities.

The Pathways Home curriculum consists of a train-thetrainer course for tribal housing and financial professionals and materials for prospective homebuyers. It addresses a range of issues facing American Indians, including credit, finding a home, applying for a loan, predatory lending and foreclosure. It also highlights opportunities including manufactured housing, the Section 184 Indian Home Loan Guarantee Program and homeownership opportunities on trust lands.

"A lot has changed in the last 15 years, both in the American Indian community and in the mortgage marketplace," said Tony Walters, Executive Director, NAIHC. "The new Pathways Home curriculum condenses that knowledge into a single homeownership course for American Indians."

Trainers who complete the course receive a certification and the necessary manuals to use with individuals in their home communities. In return, the trainers will provide feedback to NAIHC on the course's impact on homebuyers in a variety of measurements including loan requests and changes in budgeting behavior.

"We appreciate Fannie Mae's commitment to homeownership

education. This curriculum will not only help educate homebuyers but will also address challenges that face our community and speaks specifically to American Indians," Walters added.

NAIHC will conduct Pathways Home train-the-trainer sessions nationwide throughout 2018. Tribal leaders can bring the benefits of Pathways Home to their community by registering for a session at naihc.net.

About the National American Indian Housing Council: The NAIHC is the only national organization representing the housing interests of Native people who reside in Native American, Alaska Native and Native Hawaiian communities. The NAIHC is composed of more than 267 members representing 498 tribes and housing organizations. 





### NATIVE AMERICAN HERITAGE FUND ANNOUNCES ADDITIONAL 2018 GRANT RECIPIENTS - NAHF FUNDS PROJECTS IN THREE UPPER Peninsula Communities

Editor's note: The following is a Native American Heritage Fund (NAHF) press release dated August 15, 2018.



At its August 10th meeting, the Native American Heritage Fund Board approved grant funds to be awarded to projects in three Michigan communities.

The grants approved include:

1. Bay de Noc Community College in Escanaba - \$2,013 for The Living Circle of Life project.

2. Lake Superior State University in Sault Ste. Marie -\$10,000 for an education initiative to increase local tribal imagery on campus and implement cultural events.

3. Michigan Technological University in Houghton -\$30,488 for a partnership proj-

ect with Keweenaw Bay Ojibwa Community College to co-create curricula.

Michigan's K-12 schools, colleges, universities and local units of government were eligible for funding through the NAHF to defray the costs of projects that promote positive relationships and accurate information about the history and role of Michigan's Indian tribes and Native Americans in the state.

The fund, which was approved in 2016 as part of the Second Amendment to the Tribal-State Gaming Compact between NHBP and the State of Michigan, allocates a portion of NHBP's state revenue sharing payments to the NAHF.

The NAHF Board is composed of Chairperson: Jamie Stuck (NHBP Tribal Council Chairperson); Vice Chairperson: Dorie Rios (NHBP Tribal Council Vice Chairperson); Secretary Elizabeth Kinnart (Sault Ste. Marie Tribe of Chippewa Indians Citizen); Treasurer: Melissa Kiesewetter (Michigan Dept. of Civil Rights Tribal Liaison/ Native American Specialist); Board Member: Kimberly Vargo (Grand Traverse Band of Ottawa

and Chippewa Vice Chairperson).

About The Native American Heritage Fund

The NAHF was established in 2016 as part of the Second Amendment to the Tribal-State Gaming Compact between the Nottawaseppi Huron Band of the Potawatomi (NHBP) and the State of Michigan. The amendment allowed for a portion of NHBP's annual state revenue sharing payment to be deposited into the NAHF.

The fund serves to promote positive relationships between public and private K-12 schools, colleges, universities, local units of government and Michigan's federally recognized Native American tribes. The NAHF provides resources to help improve curricula and educational resources related to Michigan Indian history as well as to replace or revise mascots and imagery that may be deemed as offensive to or inaccurately conveying the culture and values of Native Americans.

Each of these behaviors can deeply wound and often isolates you from your community. If your partner is behaving this way toward you, you may feel removed from your family and support system. WHAT IS CULTURAL ABUSE?

Intimate partner violence, in all forms, is destructive at its heart. Most people can identify the more common forms of abuse, which include physical, emotional, sexual and financial. One of the lesser known forms, cultural or spiritual abuse, is one of the most devastating, yet it is rarely spoken of.

For Native peoples, spirituality is often the core of who we are and our way of life. Our culture and spirituality are intertwined and provide the foundation of our lives - how we live, our family roles and how we interact with others, the meaning we find in our lives and our sense of wellbeing. To have our spirit attacked is as personal as an attack can get.

Spiritual abuse can be used to control how a person interacts with the world. Some of these types of abusive behaviors can



include when your partner:

• Prevents you from participating in spiritual or cultural traditions.

• Forces you to participate in practices (not your own).

• Misstates or misuses spiritual practices against you.

• Practices bad medicine against you.

For our tribal communities, spiritual or cultural abuse can look like this:

• Telling you that you're not "Native enough" or if your partner is non-Native, that you're "too Indian."

• Uses hurtful stereotypes to put you down ("Indians are drunks, lazy," etc.)

• Prevents you from partici-


barrassed, not know where to turn or who to ask for help.

In some cases, you may even feel that the abuse is the direct result of your culture — that you are being abused because you are indigenous. This form of abuse is a directly related to the root causes of violence in our communities: Colonization and genocide. If your partner or loved one is demonstrating any of these behaviors or any type of abuse against you, please know that you have the inherent right to be safe, to lead a life free of abuse and to participate in your cultural practices and traditions.

ANISHINABE ANCESTRAL REPATRIATION OBSERVANCE

### SEPTEMBER 6, 2018

The Saginaw Chippewa Indian Tribe of Michigan and its Ziibiwing Center of Anishinabe Culture & Lifeways will recommit back to the earth the ancestral human remains of one Native American individual from the University of Michigan's Museum of Anthropological Archaeology (UMMAA) from the Garry site of Arenac County, MI. Not subject to NAGPRA, the Arenac County Historical Society will repatriate 15 associated funerary objects to the Saginaw Chippewa Indian Tribe of Michigan.

In August of 1971, human remains representing, at minimum, one individual were removed from the Garry site (20AC19) in Arenac County, MI. Workers contacted the Michigan State Police after encountering human remains while digging a trench for a water main on private land. The human remains are of one adolescent, indeterminate sex, 17-18 years old. No known individuals were identified. Several Post-Contact Period funerary objects were found in association with the burial but were transferred to the Arenac County Historical Society instead of the UMMAA.

The human remains have been determined to be Native American based on burial treatment and diagnostic artifacts. A relationship of shared group identity can be reasonably traced between the Native American human remains from this site and the Chippewa based on multiple lines of evidence. The associated funerary objects noted from the site are typical of the types of goods traded in the region from approximately A.D. 1760 to 1820. Additionally, according to historical records, when the burial occurred, the Chippewa were the predominant tribe in the area. This is further evinced by a treaty creating two Chippewa reservations in the vicinity of the Garry site in 1837. The Saginaw Chippewa were the sole signatories of this treaty. The Notice of Inventory Completion posted to the Federal Register on July 12, 2018.



to secure our right to remain in our ancestral homeland. It created our Reservation-a permanent space for us to maintain our culture and traditions. In the ensuing decades, changes in United States Indian policies upturned this carefully negotiated agreement. By filing this lawsuit, our Tribe seeks only what it was promised: the permanency of our negotiated reservation boundaries, so that we can protect our children, our families, our elders, our ancestors, and the beautiful natural resources that surround us. Just as it is unthinkable for United States citizens to abandon the Constitution because it is "old," so too is it unthinkable for our Tribe to abandon the rights preserved for us in our 1855 Treaty merely because of its age.

Believing that their state government representatives would not faithfully represent their interests, two counties, three cities, eleven townships, and two private organizations-the Emmet County Lakeshore Association and the Protection of Rights Alliance-voluntarily chose to intervene as defendants months after the Tribe first began the suit. The Tribe had worked for many years to create good relationships with these local units of government, and did not sue them when it filed the lawsuit. Rather than continuing to work with the Tribe to develop amenable solutions to the complexities that are an everyday part of governmental co-existence, these entities decided to join the lawsuit as defendants, requiring vast expenditures of time and tax dollars to fight against the rights preserved to the Tribe. For hundreds of years, our Tribe has been a careful steward of the land, culture, and identity of northern Michigan. Despite the divisive marketing efforts of those opposed to the Tribe's case, which attempt to sow fears of chaos and destruction of the character of the area, our Tribe remains committed to protecting our homeland for seven generations and beyond. We ask our neighbors to honestly consider: Why would we permit the destruction of our only homeland? Why, as one of the region's largest employers, would we do anything to jeopardize the quality of life for residents or the appeal of the area for visitors and their families?

natural environmental areas, improve fisheries and wildlife habitats, enhance parkland and community spaces, and draw prudent, sensible, and in-character business investments to the region. The polarizing and apocryphal information disseminated by those opposed to the Tribe omits the myriad legal constraints imposed by the United States Supreme Court on tribal government operations. One of these organizations in particular-The Protection of Rights Alliance-was created solely for the purpose of fighting the Tribe in this litigation, and was organized and incorporated by the very downstate lawyers now representing it in the case.

This litigation is complex, and it is understandable that many of you want to learn more about what the lawsuit means, and what the future holds for the area after the court makes its decision. The recognition of the Tribe's reservation will not mean a drop in property values, a detriment to local businesses, unregulated and unzoned parcels, or a sudden increase in criminal activity. Just consider the areas of Shakopee, Minnesota, within the Minneapolis metropolitan area, Phoenix, Arizona, or Mount Pleasant, Michigan-reservations where business opportunities and property values thrive.

We understand that not all of our neighbors share our Tribe's culture and traditions, but we all share a deep love and connection to northern Michigan. With this connection comes shared concerns about protecting the environment and natural beauty of the area in which we live. Having the promises and treaty obligations made by the United States government fulfilled makes our entire bay-area community stronger-both the tribal community and the communities of our non-Indian neighbors. As responsible stewards of our treaty rights, the Tribe is committed to preserving this beloved space for everyone, both tribal and non-tribal citizens.
