Use of 3rd Party Support Revenues for Expansion of Dental Program

- WHEREAS, The Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and rights of self-governance; and
- WHEREAS, The Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which are the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- **WHEREAS,** The Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and
- WHEREAS, Expansion of the dental care at our Tribal Health Clinic is needed to keep up with the patient load.
- WHEREAS, In accordance with the WOS 2015-016 Tribal Government Budget Formulation and Modification Statute;
- **THEREFORE, BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and approves the use of 3rd party support revenues in the amount of \$274,319.00 for use in FY 2018 for the expansion of the dental program at the Mina Mskiki Guimk Clinic.
