TRIBAL RESOLUTION # 072014-02

Supplemental Funding in the Amount of \$350,000 for the Legislative Branch FY14 Budget
for purchase of four lots in Harbor Springs, Indiantown

WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;

WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);


WHEREAS the Little Traverse Bay Bands of Odawa Indians approved the purchase of parcel 79, consisting of four lots on Second Street in Harbor Spring, known as "Indian Town";

WHEREAS the purchase price with closing cost, surveys and other fees is approximately of \$350,000;

WHEREAS the Tribal Council budget for FY14 has already been approved without funding for the land purchase.

THEREFORE, BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and supplements funding to the Legislative Branch in the amount of \$350,000 for the purchase of parcel 79, consisting of four lots on Second Street in Harbor Spring, known as "Indian Town, with funding to come from prior period funds.

FURTHER BE IT RESOLVED that in accordance with the Constitution the Executive Branch shall administer such funds as appropriated by Tribal Council.
