

## TRIBAL RESOLUTION #081816-QI

## Supplemental Funding for Michele Chingwa Education Assistance (MCEA) in the amount of \$190,044

- WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the Tribe on February 1, 2005;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians, enacted WOS 2014-010, "to enable present and future generations of Waganakising Odawak to obtain post-secondary educational opportunities" and
- WHEREAS In accordance with Waganakising Odawak Statute 2015-016, Process for Appropriations of Supplemental funding, the Appropriations and Finance Committee reviewed information concerning the financial needs of the Michele Chingwa Education Assistance act;
- THEREFORE BE IT RESOLVED that Tribal Council authorizes and supplements the 2016 Michelle Chingwa Education Assistance Act budget, in the amount of \$190,044, with funds to come from General Fund Balance Supplemental Funding for purposes of providing scholarships for Higher Education.
