

- WHEREAS, The Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and rights of selfgovernance; and
- WHEREAS, The Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which are the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- WHEREAS, The Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February I, 2005; and
- WHEREAS, In accordance with the Waganakising Odawak Statute 2020-06 Tribal Government Budget Formulation and Modification Statute, and the modification has been posted to the Tribal Website for (7) days and has been submitted to the Tribal Council;

THEREFORE, BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and approves the budget modifications for FY 2020 for the purpose of funding improvements in the amount of \$40,000.00 that will be reallocated from the Tribal Chair's General Fund Budget to the Capital Expenditure Fund for cost related solely for the market-rate rental homes and the Wilderness cabins.

FINALLY, BE IT RESOLVED that in accordance with the Constitution the Executive Branch shall administer such funds as appropriated by Tribal Council.
