TRIBAL RESOLUTION # 092619- 01

Supplemental Funding in the amount of \$135,286.00 for infrastructure and virtual server for the LTBB Government

WHEREAS, The Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and rights of self-governance; and

WHEREAS, The Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which are the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and

WHEREAS, The Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and

WHEREAS, In accordance with the WOS 2015-016 Tribal Government Budget Formulation and Modification Statute;


THEREFORE, BE IT RESOLVED, that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and approves supplemental funding in the amount of \$135,286.00 for the purpose of providing infrastructure and a virtual server for the LTBB Government Operations come from General Fund balance - Supplemental funding

FURTHER, BE IT RESOLVED, funds shall carry over into FY 2020 for the purpose of this update and infrastructure project and that in accordance with the Constitution the Executive Branch shall administer such funds as appropriated by Tribal Council.


