### **SECTION I. REPEAL:**

#### SECTION XV. TRIBAL COUNCIL

- A. Membership shall be final upon affirmative vote of a majority of the full Tribal Council, provided that the Tribal Council must accept or reject new membership applications within sixty (60) days of receipt of recommendations from appropriate staff and committees. LTBB Constitution, Article V(G)(2).
- 1. The Enrollment Office shall submit their recommendation to full Tribal Council to either approve or disapproval of an application for enrollment along with appropriate documentation. Tribal Council shall only vote on such application when all nine (9) Tribal Council members are present.

#### SECTION XV. TRIBAL COUNCIL

- A. Membership shall be final upon affirmative vote of a majority of the full Tribal Council, provided that the Tribal Council must accept or reject new membership applications within sixty (60) days of receipt of recommendations from appropriate staff and committees. LTBB Constitution, Article V(G)(2).
- 1. The Enrollment Office shall submit their recommendation to Tribal Council to either approve or disapprove an application for enrollment along with appropriate documentation. In order for Tribal Council to vote on the recommendation, there shall not be a vacant seat on Tribal Council, or where the Legislative Leader is acting as Chair and is not considered a Tribal Council Member.

Effective upon signature of the Executive or 30 days from Tribal Council approval whichever comes first or if the Executive vetoes the Statute, then upon Tribal Council override of the veto.
