# News From The Elders Program

Aanii LTBB Elders,

We hope this finds you all well, warm and

Registrations for the Critical Issues Conference and the Anishinaabemowin Teg Camp were requested before we could get this notice in the newsletter. We have the Michigan Indian Elders Conference coming up in April. Rooms at the Grand Traverse Resort have all been filled. If you are interested and would like to attend, we have five slots available. We can provide lodging for the three days, mileage, and meals, if you can find transportation.

We also have two programs available to LTBB Elders. If you are in need of construction of ramp access, grab bars, or rails for your home due to a physical disability, there are funds available to facilitate the construction. Submit a letter explaining your need along with medical verification. I will submit the request to the Tribal Administrator for disposition. Also, if you have a

dire emergency need, you can submit a request with documentation verifying the need. Send your request and documentation to the LTBB Elder's Program, 7500 Odawa Circle, Harbor Springs, MI 49740, attn: Warren Petoskey, Program Coordinator.

We would like all of our Elders to be aware that we are going to initiate the food and utility reimbursement program early this year. We will send out the initial notification beginning in May and have the whole process completed by the end of August 2005. There will be a change this vear that each Elder needs to be aware of. Every application must be completed following the directions on the cover letter and submitted by the closing date for application. There will be no second mailings or phone contact to correct those applications that are not complete. We received a large number of applications that were either not signed or lacked requested information which required extensive second mailings or phone calls and resulted over expendi-

It is our intention to post something in the tribal newsletter each month. I would like to

come to Grand Rapids, Lansing, and Escanaba and meet with those LTBB Elders living in these areas. # Community Health Maazinigan

Aanii Kina gwaya! (hello everyone) We all hope that you enjoyed the holidays with your family and friends and that 2005 is off to a great start. Remember that spring will come. The health department staff wants you to know that we are here to provide services for you. It is an honor. Please feel free to offer any suggestions that would improve our services.

The Health Department staff is dedicated to strengthening the circle. We can help each other heal and become a healthier community. This will be achieved through balance, caring for the mental, emotional. spiritual and physical aspects of your being. One of the greatest gifts that we can give to ourselves is to be active. Just get up and move. Physical activity and nutrition are the tools we need to fight and prevent diabetes, heart disease, obesity and many other diseases. We can help each other to be role models for the younger generations.

Following is a brief summary of the programs and activities that we offer through the health department.

#### NATIVE WAY WELL-NESS AND PREVEN-TION CENTER

Native Way Wellness and Prevention Center (located on West Conway Road next to the Humane Society; the address is 8730 Commerce Court, Harbor Springs, MI Unit #8) has cardiovascular and weight training equipment that can be accessed using a key card at your convenience. You must obtain a medical release from your doctor to exercise. Call Dawn at 231-242-1700 to schedule an appointment for a physical at Mskiki Gumik to obtain your medical release and/or to get your key

Native Way Too Unit #7 is an annex of the Native Way Wellness and Prevention Center Unit #8. Currently we are offering Rez Robics, Tae Kwon Do and Yoga classes. Space is limited, so you must register. Please do not just show up. If there is enough interest and instructors, we will offer more classes.

### **REZ ROBICS**

Rez Robics is a Native American exercise video. It was made by and for Anishnabe as a means to decrease the diabetes epidemic among native people. Physical activity is one of the key factors in preventing and controlling diabetes. It features real people (no Jane Fonda's!) at different levels of physical fitness exercising to pow-wow music. It uses a lot of martial arts moves like punching, kicking and native dance. It is a lot of fun no matter what your level of fitness is. Classes are held Monday and Wednesday at 5:30-6:45 p.m. and Monday, Wednesday from 3:45-5:00 pm at Native Way Too (NWT) and an Elders class is at 11 a.m. Tuesday and Thursday at the LTBB complex commons area. Call Gwen at 231-242-1611 to register.

### TAE KWON DO

Tae Kwon Do is a contemporary martial arts class that teaches self defense and respect. The teachings parallel with the teachings of our ancestors. Classes are held Tuesday and Thursday 6-7 p.m. at NWT for ages 11 and up. Little Ninji's

ages 5-10 is held Friday evening at 6:00 pm. Call Gwen at 231-242-1611 or Cathy at 231-242-1601 to register. Space is limited so you must register to participate. We will make every effort to accommodate everyone.

#### **YOGA**

Yoga is a three thousand year old system of health care which encompasses the body, mind, and spirit. If you are ready for a little physical and mental stretching that will improve your overall sense of well being, come and give us a try. Presently we are holding classes on Mondays and Fridays from 11 a.m. to 12 p.m., and on Tuesdays and Thursdays from 4 p.m. to 5 p.m. All you need to bring is an open mind. Call Regina at 231-242-1664 to register.

#### SMOKING CESSATION Sema Grant

"Freedom from Smoking" sessions will start February 21st at LTBB Health Department. This is a 7 week course, designed by the American Lung Association to help you quit smoking. Two additional sessions will be held this year. There is no cost to you. In addition, assistance with nicotine replacement therapy will be available at low or no cost. Call Gwen at 231-242-1611 register. Watch the newsletter for the date of the next "Freedom from Smoking" class.

#### LTBB HAWKS

### **NAGUMWIN**

Anishnabekwe are gathering to learn and share songs of our ancestors (new ones too). Bring your hand drums, shakers, songs and a willingness to learn Tuesday's at 1:00 p.m. and Friday's at 5:00 p.m. at the Government complex. received a small grant that we will be able to use to host workshops to make hand drums and shakers. In addition, the health department will be utilizing this gathering as a forum for education-we will share what help each of us to heal-strengthening the circle. Watch the newsletter or call Cathy for the details.

### STEPS TO A HEALTHIER USA

STEPS is a five year grant funded by the Centers for Disease Control (CDC). The focus is on prevention activities in the areas of Diabetes, Obesity and Asthma and their related risk factors. Educational activities will target these areas focusing on physical activity and nutrition as primary interventions. FITUP, Bmoseda, Mino'Ode are physical activity programs that are available to you and your family.

### FITUP

Currently, LTBB is competing in "FITUP", an 8 week on line walking program sponsored by the Upper Peninsula diabetes outreach network. It encourages 10,000 steps a day. We have taken more than one million steps so far. All you do is log your points online. If you do not have access to a computer

Health staff will do it for you. A similar program will start in April. This will be a 'virtual walk' from one participating band to another. You will keep track of the steps you have taken and when you reach one destination you will receive information, etc. from that band. More details will follow in the newsletter. If you are interested in this program call Cathy at 231-242-1601.

#### MINO'ODE

(good heart) is a program in which you score points for doing things that are good for you and avoiding those that are not. Exercise, drinking water, relaxation, eating 5 fruits and vegetables a day are some of the ways that you get points. Call Cathy at 231-242-1606 to sign up. Log sheets are due on April 15th, July 15th, October 15th, and January 15th. You can sign up any time.

#### '5 A DAY THE ANISHNABE WAY'

'5 a Day the Anishnabe Way' is an initiative to encourage Native Americans to eat a minimum of 5 fruits and vegetables a day. Many of the diseases that afflict Native Americans can be directly related to the foods that they eat and the amount of energy expended to obtain this food. Our ancestors gathered, harvested, hunted, fished, trapped, or traded for food, medicine and shelter. They worked hard spring, summer and fall to survive the winter. Today we work Eight hours, drive through McDonalds on our way home from work, go home, eat and watch T.V. Day after day. Not much energy expended but a whole lot of calories taken in. Not good. We need to eat foods that are as natural as possible and remember that the plants and animals that we eat gave their life so that we can live. This is the circle of life that we are a part of. Medicine in our language is mskiki-strength of the earth. Call Cathy at 231-242-1601 to sign up.

### **DIABETES**

Diabetes management and prevention education is available by appointment for you and your family. We will give you the tools that you need to take care of yourself. Diabetes is preventable but it is not curable. In the near future diabetes education in a group setting will be offered. We also have foot clinics every Wednesday. Certified diabetes foot specialists are available to care for your feet and nails. Non-diabetics are welcome. Call Cathy to make an appointment.

### **CPR**

If you are interested in CPR classes for yourself, family or friends please contact us. Five members of the health department recently received certification to teach CPR and First aid. If there is an interest we will offer free classes in the community.

### TRADITIONAL FOOD PRESERVATION

We are also looking for tribal members that are interested in organic, sustainable gardening. Also we are putting a call out there for those of you that know how to dry and store foods like our ancestors did-without dehydrators, canning jars and pressure cookers. If you have this knowledge and would be willing to share with us please call and talk to me, Michele Keshick at 231-242-1606. Miigwech



# Human Services Department By Stephanie Howell

The Human Services Department offers many vital services to our community. Our offices are located at 915 Emmet Street in Petoskey. Our hours of operation are Monday through Friday, 8:00 am to 5:00 pm. We are pleased to offer the following programs to our community:

### ❖ PROTECTIVE SERVICES:

This program involves the care and supervision of children and families that are involved with the court system or are in jeopardy of entering into one. This program is responsible for all aspects related to the child and their families regarding intervention, unification, termination or adoption options as outlined with the LTBB Childrens' Code.

### ❖ FOSTER CARE: This program is

This program monitors placement of the child, offers foster parenting preparation and support, and works closely with the Indian Child Welfare Commission. The Indian Child Welfare Commission is a five member commission appointed by tribal council. The commission meets on a monthly basis and serves many vital functions regarding protecting tribal children and their families. They also approve the licensing of a foster care homes

### MSHKO-DODEMWIN FAMILY SERVICES:

The MSHKO-Dodemwin works with children and families who are at risk or who have entered into the state or tribal court system. The philosophy

of this program is to provide services to families so that they are able to remain as one unit. This program offers therapy for families and children, case management and parenting classes emphasizing the Odawa value system.

#### COMMUNITY RÉSOURCES PROGRAM:

The Community Resources Program provides three major services for individuals and The USDA Commodity Food Distribution program, LIEAP program (low income energy assistance/emergency energy assistance) and Child Care Development Fund program for daycare assistance. This program is also responsible for holiday food baskets and the Angel Tree (holiday gifts for children). Please stop by our department or call Theresa Boda at 242-1626, for more assistance on these programs.

# Be Safe *Before* You Drive!

# By Norm Emery Safety Coordinator Safety Check:

One thousand drivers ages 18 and older were surveyed about what they do before they start their cars. Survey participants were asked: Thinking about every time you get in your car and before you turn the key, when going on a short trip or running an errand in your neighborhood, do you always check the following: -

- To make sure your mirrors are properly adjusted?
- To make sure all occupants are correctly belted?
- Do you consider yourself to be a safe driver?
- To make sure your seat and head restraints are properly adjusted?
- To make sure all doors are closed and locked?
- To make sure loose objects are secure?
- Check around and underneath your car for potential obstacles?
- To make sure the car is secure, such as checking to make sure your car has not been broken into or there is no one unusual or suspicious in or around the car?

In the first-ever survey conducted on motorists' pre-start inspections and behaviors to determine if drivers were following proper safety guidelines, before they start up their cars, 99 percent of survey respondents rated themselves as safe drivers. However nine out of ten do not conduct the appropriate safety checks. The survey also questioned respondents on their overall driving behavior and uncovered other surprising findings:

- Distance does not make a difference: Only 9 percent of drivers always conduct the recommended safety checks before they take a two hour or longer driving trip.
- Men put the pedal to the metal: Drivers who reported aggressive driving behavior and exceeding the speed limit tended to be men.
- The cell phone is not off the hook: Less than 20 percent of drivers who use cell phones turn them off before driving, or find a safe place to pull over to make or accept a call. A dri-

ver's first responsibility is the safe operation of the vehicle and that best practice is to not use electronic devices, including cell phones while driving.

- We are a nation of speeders:
   One out of three respondents said it was acceptable to drive more than five miles over the speed limit on interstate highways.
- Women aren't as safe as they think. Women consistently reported that they are safe drivers, yet they fail to follow the recommended maintenance p r o c e d u r e s .

Safe behaviors need to start before turning the key to make sure that

we are doing all we can to ensure safe driving.

Driver surveys reveal that 93 percent of Americans are hitting the roads ill prepared - therefore increasing their chances of a road incident. According the National Safety Council, "For so long, safe driving discussions have centered on safety while driving that we have almost forgotten to take the proper safety precautions before starting our cars". While some may see it as monotonous, the reality is that in a tricky driving situation, having followed the start-up safety precautions before turning the key can make the difference between safety and a disaster."

Correct behaviors conducted before starting the car can help combat two of the leading causes of serious car crashes – not using a seatbelt and incorrectly inflated or unevenly worn tires. In 2003, incorrectly inflated or unevenly worn tires contributed to more than 20,000 serious auto incidents.

### Driving While Impaired:

Impairment is a change in a person's ability to perform routine daily tasks at the normal level of functioning. Driving while impaired from alcohol and illegal drugs is another leading cause of car crashes, but impairment can also be caused by many common prescription and over-the-counter medications such as some antihistamines and antianxiety medications.

The following Public Service

Announcements (PSA) by the National Safety Council talk about the dangers of taking certain medications and then driving. "Some medications, such as some antihistamines that are used to treat allergies and anti-anxiety medications, may affect driving skills by inducing drowsiness or excitability or by altering reaction times. Other medications, including some cold and cough medications, sleeping pills and painkillers, can also impair driving skills." We see or hear other PSA's that talk about the signs and symptoms of impairment, such as drowsiness, excitability, altered reaction times and altered depth perception. The effects of impairment vary with each person and these effects can often be difficult to identify. In fact some people may be drug impaired and not even realize it!

Drivers can protect themselves and others from driving while impaired by following these tips:

- Carefully read the directions and warning labels of all medications.
- Ask your healthcare provider about non-impairing alternatives.
- Never take more than the recommended dose. (Occasionally you will hear someone say "if one is good two is better" WRONG.
- Don't mix medications without first checking with your healthcare provider or pharmacist.
   Don't mix alcohol with
- Don't mix alcohol with medication.
- Talk to your healthcare provider (such as your doctor) or pharmacist to learn the side effects of any medications you're taking. When the medication warning on side effects state "Do not take while operating heavy equipment," they are not assuming everyone is driving a bulldozer your car, truck, van, or SUV are heavy equipment!

PLEASE REMEMBER:

Each of us has a personal responsibility to keep ourselves and others safe on the roads.

Make sure YOU are safe before you start your car!

# Student Incentive Program

A student incentive program is being offered by the Michigan Indian Elders Association (M.I.E.A.) to recognize students who achieve all "A's" for a marking period as well as students who achieve perfect attendance for a marking period.

Since the money available to fund this program is limited to \$2075.00 the award has been set at \$25.00 to keep it meaningful, and yet recognize a reasonable number of students. There will be 83 winners who will be determined by lottery. Furthermore, the LTBB Elder's Association will grant the \$25.00 award to all LTBB students who are not selected in the lottery for both perfect attendance and straight A's. Here are the conditions to qualify:

- The student must be an enrolled member or be a direct descendant of an enrolled member of one of the M.I.E.A. constituent tribes/bands.
- The student must be in grades K-12 at a public or private school (home schooling not eligible).
- A student must be in grades 4-12 to qualify for the straight "A" award (A-, A, A+).
   For a school system that uses a grading system based on numbers, the equivalent to straight "A's"

be

A student must be in grades
K-12 to qualify for the perfect attendance award.
 Perfect attendance means
exactly that. A student must
be in school or at a school
sponsored function each

day of the marking period.

Excused absences for any-

thing other than a school sponsored/approved function do not constitute perfect attendance.

- The first two marking periods of this 2004/2005 school year (or the number of marking periods completed by March 1, 2005 for school systems having something other than four marking periods) will be used to determine the winners for this lottery. A student can qualify for
- A student can qualify for both the perfect attendance and straight "A's" for both marking periods. For example, straight "A's" and perfect attendance for both marking periods would mean four chances to win.
- A copy of the child's report card, signed by the parent, must be submitted to verify the achievement of straight "A's" and perfect attendance.
- Parents assume responsibility for releasing their child's information to the M.I.E.A. by their signature on the report card.

The drawing to determine the winners will be held at the April 2005 meeting of the Michigan Indian Elders Association at Traverse City, MI.

The presentations in the auditorium will provide information on Tribal Council activities, Legal Department, Victories Casino/Hotel,

a Question/answer period from the Tribal membership and other topics to be announced. The 2005 LTBB Community Meeting agenda will follow in a future issue of the Odawa Trails.

This will be a busy year for Tribal Council with the recent passage of the LTBB Constitution. Many planning meetings are being scheduled to address the proper implementation of this all important document.

I am very pleased with the improvements made over the years and the positive input received from concerned Tribal members. Your patience has been appreciated as we move forward with the process. The working group is supported by numerous departments and together we obtain good results for our efforts.

I have also formed a working group to develop personnel policies for the Tribes' enterprises: Kings Inn Motel, Bell's Fishery and Biindigen Convenience Store (excluding Victories Casino and Hotel). 


