Smithsonian's Native American Exhibit Opens September 21, 2004



The Archives/Records and Cultural Preservation staff accompanied thirtyone other LTBB tribal members on a trip to Washington D.C. to experience the grand opening ceremonies for the new National Museum of the American

This national museum is the newest addition to the world-renowned museums within the Smithsonian Institution. It centers on native cultures from this hemisphere and stresses the beauty of our cultures, our vitality, our contributions, and our futures.

While in town for the grand opening, the LTBB contingency also had wonderful opportunities to learn about mainstream American history by having the opportunity to tour many of the memorials and other important sites in D.C. We had an excellent guide on these tours, who was able to give our participants a more detailed view of many of the memorials and

landmarks.

As part of the opening ceremonies, LTBB also participated in the procession that preceded the opening ceremony agenda. There were approximately twenty-thousand native people in the procession who were grouped according to their tribe. We had an excellent and emotional time during the procession. It was an amazing feeling to be surrounded by other native people and to mingle with cultures much different than our own. Following the procession, we were seated at the front of the museum for the opening program that entailed speeches from museum dignitaries and special guests. Later that day, we were able to tour the new museum with our group and explore the new exhibits.

Overall, the trip was a huge success. Everyone that attended had an excellent time seeing the sights and learning a lot. We all felt grateful to have been able to represent our people in the activities and to be a small part of such a historic event. We are also grateful to the American Tour Club who ensured that our trip was jampacked with activity and that we all arrived back home safely.

On behalf of the Elders, Youth, Tribal Members, and Staff that were able to participate, I would like to thank Tribal Council for their generosity. Some of the travelers had never been to Washington D.C. before or never been "around so many Indians!" We are truly grateful!!!!

From the Desk of Tribal Chairman, Frank Ettawageshik

Aanii! I wanted to report on several things in this month's article. First, in September over fifty of our LTBB tribal citizens were in Washington, D.C., for the opening of the new National Museum of the American Indian. This newest branch of the Smithsonian Institution's many museums in the United States' capital city had its official grand opening on the 21st of September but the festivities stretched out over a full week. Joe Mitchell, carrying our community Eagle Staff, Tony Davis, carrying our veterans Eagle Staff, along with our Tribal Flag led the LTBB delegation on Tuesday the 21st, as we were part of nearly twenty five thousand Native people from across North and South America and Hawaii who participated in the Native Nations Procession. We walked from near the Washington Monument on the National Mall up to the new museum building near the Capital. Throngs of spectators lined the route. Few if any of us had ever been in the middle of so many native people at one time. It was a very moving experience. After several speeches and honor songs, the museum doors were opened to the public. So many people were there to view the museum that we had to have tickets to enter at a specific time to help control the crowds. The museum was open all night the first night to accommodate all of the viewers. Our Tribe's name is one of the tribal names etched on the stone wall at the main entrance as one of the many tribes who made a donation to help build the museum. Additionally, as a proud father, I want to mention that my daughter, Marissa, who lives in the DC area is one of the volunteers at the museum and my son, Joseph, has one of his pieces of Indian pottery in the museum's collection.

The second thing in this report is that we recently signed a historic agreement with the Michigan Secretary of State. After nearly a year of negotiating and a site visit by staff from the State, the State agreed to officially accept our Tribal Identification Cards as a proof of identification when applying for a Michigan driver's license or State Identification Card. This sounds simple but it took a lot of work. Our lobbyist in Lansing, Mary Lindemann, of Michigan Tribal Advocates, arranged a

first meeting with tribal consultant, Jim McClurken, several Secretary of State officials and myself. After this we had a site visit during which our Enrollment staff, Pauline Boulton and Linda Keshick, did an excellent job of convincing the State of the thoroughness and security of our enrollment process. Several emails and telephone calls followed over the next several months and eventually we had an acceptable agreement ready. Tribal Council then had to adopt an amendment to our Tribal Enrollment Statute to allow our staff to verify information requests from the Secretary of State's staff. After all of this we were able to sign the agreement. So far, our Tribal ID's are the only ones accepted by the State of Michigan.

The third item in this report is that the expanded parking lot for Victories Casino will be completed by the time you are reading this. We purchased land in the spring that is just to the east of Victories on which we have constructed additional parking spaces to double our parking capacity. This land included a large health building to which we will be moving our clinic and

health offices. Additionally we are expanding the Victories building in order to add over 250 new slot machines along with new air handlers to make the casino much less smoky inside. The expected increase in our business from these expansions will assist us in consolidating our financial position as we continue to make plans for the new Casino to be built on the land to the west of Wal-Mart in Petoskey.

Lastly, our Sovereignty Day Celebration on Saturday, September 18th, was a great success. The Planning Department had assured us that the paving of the second half of Odawa Circle would be done for the festivities. They were right on schedule and we were able to hold our first Sovereignty Day Parade. The food and prizes were excellent with lots of fun and socializing during the afternoon. The feature of the day was the premier showing of the video "Journey to Sovereignty". This video details the history and 10-year anniversary of the signing of Public Law 103-324, the Little Traverse Bay Bands of Odawa Indians and the Little River Band of Ottawa Indians

Act. In the near future, we hope to have copies of this video available for sale. Shirley Oldman chaired the Sovereignty Day Committee and along with Mary Roberts produced the video. Shirley and all of the other members of the committee deserve a "Chii Miigwetch!" for a lot of hard work.

Su Lantz and Ed Nephler have done lots of work to update our Odawa Register and deserve recognition for their excellent work. Our full Tribal Code is on this site, listing all of the Tribal laws in one place for your information.

From the Desk of the Tribal Administrator Albert Colby, Jr.

Aanii Tribal members, fall is upon us and winter is just around the corner. The Tribal Distribution plan (\$500 for each LTBB member) is moving forward. This year the Enrollment Department will be sending address verification forms to all LTBB Tribal members 18 years of age and older, minor LTBB children under the age of 18 years old (enrolled with the Tribe) and LTBB Tribal members presently incarcerated in a state or federal institution. If you have changed your residence or mailing address since last year, contact the Enrollment Department at (231) 242-1520. It is very important to have a correct mailing address on file in the Enrollment Department, in order to receive your LTBB Distribution check in a timely manner. Also, the Tribe has held several successful events since my last article in the newsletter. The Traditional Pow-wow at Osborne Road was a success with the meal served at the LTBB Administration Building. Chi-Miigwetch Harriet Booth for keeping me on task, so the event could be held. The Sovereignty Day celebration was well attended and everyone enjoyed our first parade at Odawa Circle, the first showing of the Tribes video "Journey to Sovereignty" which gives all who view this documentary a better

understanding of the LTBB peo-

ple. The meal and giveaway

closed the activities for the day. The LTBB Administration Building has provided a place of gathering for Tribal members. Meetings, Tribal events, gatherings for funerals, cultural activities and Elders Luncheons are just to name a few of the activities conducted at the facility. The departments and programs continue to put their best efforts forward when serving the membership. I am currently working on a project titled "Culturally Significant Sites" which will create a database for sites identified as culturally significant to the Tribe. This provides the Tribe with a list of areas requiring preservation and protection as development continues in Northern Michigan within the reservation of the Little Travers Bay Bands of Odawa Indians. The research group comprised of Cultural Preservation Coordinator, Joe Mitchell, and GIS Director, Alan Proctor, will seek information from the various departments in the field and Tribal members at-large who have information on culturally significant sites needing protection. We are doing our best to maintain a high level of confidentiality on the gathered information and keeping it for the restricted use of the Tribe. I have also been included in the development process for personnel policies for the Kings Inn Motel, Bell's Fishery and the Biindigen Convenience store.

This will provide more guidance for our managers currently overseeing the businesses. Also, an Ethics working group will be formed to develop a Ethics Policy for governmental operations. This will give proper guidance on acceptable behavior for governmental staff in their pursuit of future development and diversification within Tribal operations. The road around Odawa Circle has been completed including the entrance off Pleasantview Rd. I look forward to the coming months and the accomplishments that go with it.



Gaming Administration

No. of Openings = 1 immediate opening to fill a vacancy, expires 2005

Meetings= Minimum of once per month or as deemed necessary

Compensation:

- 1) Stipend of \$100.00 per meeting
- Per Diem according to the Current Federal Per Diem Rates (for those members who travel from farther than 50 miles for a meeting or training)
- Mileage allowance is paid according to the current mileage rate set out by the LTBB Accounting Department.
- 4) Lodging & Travel is paid for through the Commission, Board or Committee and is approved via motion at a regular meeting

Vehicle Pre-Start Guidelines

The seven pre-start safety precautions that should happen every time a driver gets behind the wheel are:

According to the National Safety council: Buckle seatbelts and make sure they're properly fastened. (In the last 20 years; an estimated 157,500 lives have been saved by wearing safety belts.)

- Adjust mirrors
- Three out of 10 survey respondents do not adjust their mirrors before short driving trips (two hours or less), when it is more likely you will get in a crash.
- Position seat and head restraints
- Correctly positioned head restraints reduce whiplash injuries resulting from crashes by 28.3 percent.
- Secure loose objects
 Only 34 percent of survey respon
 dents regularly secure loose objects
 in their cars, even though, on average,
 loose items-from luggage to soda pop
 cans are responsible for 13,000
 injuries in accidents nationwide in just
 one year.
- Turn off cell phones (or safely pull over to make or receive a telephone call) (In the last five years alone, nearly 300,000 drivers have been

involved in crashes attributed to cell phone use.)

- Look for engine warning lights
 Three out of four respondents said
 they always check to see if their
 check engine light is on; however,
 many admitted to checking the light
 while already driving.
- Check your fuel level
 In preparing for a trip-large or
 small-it's necessary to ensure you
 have enough gasoline in your tank
 to get there and back. Twenty-five
 percent of survey respondents said
 they do not check their gas level.

Start Up Safety Checklist. The START UP Checklist takes about five minutes.

- Secure loose objects
- Turn off cell phone
- Allow enough time to avoid speeding and aggressive driving
- Read fuel/fluid levels
- Tire pressure
- Use safety belts and child restraints properly every time.
- Properly adjust mirrors

Following the vehicle pre-start procedure can also save you money.

With gas prices steadily increasing year

With gas prices steadily increasing year after year, American drivers now have

another reason to pay attention to the start-up guidelines. According to the Department of Energy, following the proper start-up procedures-such as proper tire inflation-can actually save five cents per gallon for each fill-up. Additionally, regularly checking your oil and replacing it with the correct grade during an oil change can improve gas mileage as much as 2 percent, a savings of up to three cents per gallon.

Make sure that your car is prepared for winter driving. When was your car last winterized? Had a tune-up? Or had the tires checked, including the spare? Keep a full tank of gas. How about an emergency kit? Maintain a supply of non-perishable, high energy foods and a means of keeping yourself warm. Be prepared. Emergency situations can happen on the road at anytime. Be prepared for changing weather and road conditions and make sure that safe winter driving is your first priority.

Strict rules will apply. You must submit your report card in a timely manner. ONLY perfect attendance and straight A's will apply. NO EXCEPTIONS.






















Scholarship Fund Presents Check

New Grant Funding for LTBB

The Little Traverse Bay Bands of Odawa Indians has received award notices for several new grant programs. These new grants vary in length and purpose. Take a look and see what they are all about! Here is a list of grants that have been funded within the past few months:

LTBB Court Enhancement Grant: This will provide professional development opportunities for the Court staff and Judiciary and purchase new recording equipment and a public address system for the court room.

Making Connections - Indian Alcohol and Substance Abuse Program: This program serves to help control and prevent crimes associated with the distribution and use of alcohol and controlled substances in tribal communities. The program will develop new strategies that prevent, interdict, and treat alcohol and drug use. The program will identify an advisory team to create a project strategy and implement the strategy by the end of the three year project period. The Substance Abuse and Law Enforcement Departments are actively involved in this new grant program.

LTBB Clean Air Act: This is funding to operate an air quality project through the Tribe's Environmental Services Department.

STOP Violence Against Indian Women Project: This is a two year planning project that will assemble a coordinated community planning team to develop and strengthen the Tribe's response to violence against Indian women and to improve the services available to victims of domestic violence, sexual assault and stalking. The Human Services Department is directly involved in the administration of this program.

LTBB Basic Library Services: This program provides funding for library improvement and to purchase additional materials for the library. The Tribe's library is located in the Education Department - first floor of the Governmental Center in Harbor Springs.

Environmental Services Department: has continued their work through funding for the water quality program and through the GAP (General Assistance Program) program. These two have now been combined by the Environmental Protection Agency into one program called the PPG (Performance Partnership Grant).

Youth Drug Use Prevention Program: will provide classes for parents of youth ages 8 - 13 to help the parents learn how to help their children make good choices when faced with using alcohol or other substances. This program is just beginning and is administered as part of the Substance Abuse/Mental Health Department.

LTBB Injury Prevention Special Project: is funded through the Indian Health Service and focuses on helping the Tribe's Elders receive and place carbon monoxide detectors in their homes. Elders age 66 and older are eligible for assistance through this program. The Tribe's Safety Coordinator will be helping the Elders with this program.

COPS - Law Enforcement: provides training and replacement of outdated bullet proof vests for the Law Enforcement Officers.

COPS - Natural Resources Department: will receive funds to replace equipment, purchase new and needed equipment and provide funding for training. This is the first year the LTBB Natural Resources Department has received funding through the Department of Justice COPS program.

Tribal Wildlife Grant - Natural Resources Department: will further the NRD's efforts to conduct a Bald Eagle assessment in the LTBB reservation area. Once the assessment is completed the program will develop a management plan. The grant program will also conduct an assessment of Wycamp Lake and develop a management plan for this area. It is expected this program will take at least 15 months to complete.

Tribal Juvenile Justice Project - U.S. Department of Justice funding will focus on developing a juvenile code for the LTBB Tribal Court. The Project will also address diversion programs for juveniles and implement the diversion program during the last year of the three-year program.

Tribal Criminal History Record Improvement Pilot Project: the LTBB will take the lead to create a Michigan Tribes state-wide system to track the criminal history of offenders within each tribe's jurisdiction. Program activities will include the LTBB Prosecuting Attorney and Chief of Police meeting with other Michigan tribes for input and the development of a database for improving the tracking of tribal criminal history records. This is a one year project.

Land Tenure History Project: The Indian Land Tenure Foundation has approved funding for the LTBB to conduct research on the ties this Tribe has with land and the cultural connection to the Tribe's land base. In addition, several youth will be asked to participate and interview elders for additional program-related information. Once the research is completed, an informational booklet will be developed and presentations will be given. The Tribe's Archives and Records and Cultural Preservation Department will administer this program.

2004-2005 SEMA Grant: will provide tobacco education classes, smoke-free community events, and challenge current smokers to make a commitment to stop smoking. These activities will take place throughout the next year. The Tribe's Community Health/Diabetes Coordinator (Health Department) will administer this program.

I commend all of our Tribal Member Volunteers who have tirelessly assisted with Native Vote, the extensive non-partisan effort to mobilize the Native American and Alaskan vote through their continued efforts to support the Election Protection project. October 11-15, 2004 also proved to be a success for Native Vote 2004, recognizing the importance of Tribal involvement. Two of our Tribal Member volunteers, Su Lantz and Valerie Biro were among many who participated at the NCAI "get out the vote" booth during the National Congress' 61st Annual Convention. Bringing attention to NCAI and our neighbors, the importance of focusing on the "swing states" and how the Native Vote can make a difference, Su Lantz delivered a most welcome round of applause.

Many topics where on the agenda at the Annual Convention, and I will, highlight two of them: The Indian Child Welfare Act, passed by the United States in 1978 giving Tribes, rather than the state courts, the right to determine their children's future and how Tribes are working with the state to further understand the Act, was one of them. The other was attention to the Violence Against Indian Women initiative across the lands. On January 2, 2004, our Tribal Council passed through motion the Fiscal Year 2004 S*T*O*P Violence Against Indian Women Discretionary Grant Program. It was good to know that our Tribe stands behind such an important initiative. WOBTT Looks Forward to a Fourth, Record-Breaking Year in 2005

The LTBB Education Department is the recipient of a fourth year of funding for the Waganakising Odawa Business Technology Training Program (WOBTT). The US Department of Education has allocated an additional \$446,062 for 2005, which corresponds to a 38% increase from the average funding level for WOBTT's first three years. In return, LTBB has committed itself to having 52 students complete certificates in 2005-an increase of 129% from the average number of completions in years one through three.

WOBTT has two strategies to meet its aggressive goal for completions next year. First, a special effort will be made to encourage current students to finish up certificates that they have started. In fact, it is anticipated that 2005 will be the last opportunity for students to take the classes that are currently being offered.

WOBTT's second strategy will be to admit a limited number of new students who plan to complete a certificate wholly within the three semesters of next year.
