On Sunday, September 11, 2005, LTBB Tribal Judge Michael Petoskey swore in the newly elected Tribal Council along with the Chairman and Vice-Chairman. A flag song was sung by a community drum group with Anthony Davis, Richard Wemigwase and Harvey Gibson bringing in the flags to begin the days events. Previous Tribal Council Members gave closing remarks and statements to the over one hundred members on hand. The Judge then conducted the swearing in and oaths of office were administered to each Tribal Councilor elect. A pipe ceremony was conducted by Joe Mitchell, community spiritual leader from the LTBB Cultural Preservation Department. The community drum group then sang an honor song for the new Council. The women's hand drum group was also on hand to help celebrate this historic event with a song. A community feast was held with a Tribal Council meeting immediately following. This event is historic for the tribe as this is the first Tribal Council to be seated since our new tribal constitution was ratified. September 11, 2005, was a very special day that I will always remember. It was a historic day for our Tribe as we entered a new era in history. On that day, our new Tribal Council, as well as myself, took oaths of office. It marks a new beginning for us as we will now be living by a new governing document, the new constitution.

When we voted on the constitution, I was hearing comments about why we would need a new constitution. On September 10, the Tribal Chairman, the Vice-Chair elect and the Tribal Council attended a work session regarding the new constitution and what its implementation will mean to us. I gained a better understanding of the document and why it was a necessity for our tribe. To be put very simply: it is something that will protect our sovereignty as a nation and people. It actually protects us as individuals and it will protect our tribal assets. We now have three divisions of government: Executive, Legislative and Judicial. These are all needed to maintain a checks and balances system.

I was very touched by the ceremony

As I enter into this new responsibility as your Tribal Vice-Chairman, one thing will stick in my mind, and that is that our ancestors, when they were negotiating the treaties that are in existence now, used their wisdom and knowledge to provide for us and all that we have today. I, as your new Tribal Vice Chairman, will always take this in to account, as well, so as to provide for those that will come after us. It will be a learning experience for me, getting settled in and becoming acclimated with my surroundings here at the government offices, but I intend to hit the ground running!

Address to the Tribe By **Tribal Chairman, Frank Ettawageshik** At the Swearing-in **Ceremony for Newly Elected Officials On September, 11, 2005**

We celebrate a new beginning today, and we acknowledge an ending. We are truly part of the circle of life. Those of us who have worked for years to serve the people of our tribe have lived through many days and events that are woven into a history that is already being studied so that others may learn from our mistakes and our successes. It is in our hands, each and every one of us in this room today, and all those who hear these words in the future, it is in our hands to guide and build for our future. to leave a solid foundation for those coming after us to build upon.

When I stood in the Oval Office in the White House for the signing ceremony for Public Law 103-324, the bill that reaffirmed the US Government's recognition of our tribe, I realized at the time that I was not there alone, for all of our ancestors were there, our grandmothers and grandfa-

thers, our headmen and warriors, our healers and artists, our storytellers and cooks, our teachers and keepers of our knowledge. One of the provisions of the bill that was signed that day required the development of a constitution to be voted on by the membership of the tribe. Today we take another step in the process of rebuilding our tribal nation with the implementation of this newly adopt-Constitution. this Constitution that has been adopted by the people of our nation, that was developed and designed to better protect and serve our people.

The preamble of this Constitution says, "IN THE WAYS OF OUR ANCESTORS, to perpetuate our way of life for future generations, we the Little Traverse Bay Bands of Odawa Indians, called in our language own

WAGANAKISING ODAWAK, a sovereign, self-governing people who follow the Anishinaabe Traditions, Heritage, Cultural Values, set forth within this Constitution the foundation of our governance. Constitution is solemnly pledged to respect the individuality of all our members and their spiritual beliefs and practices, while recognizing the importance of preserving a strong, unified Tribal identity in accordance with Anishinaabe Heritage. We will work together in a constructive, cooperative spirit to preserve protect our resources and Treaty Rights, and the right to an education and a decent standard of living for all our people. In keeping faith with our Ancestors, we shall preserve our Heritage while adapting to the present world around us."

Here in this room today, among the gifts from our creator, with the pawaagon and the eagle staffs, in the presence of our ancestors and with the hopes and dreams for the coming generations, we move ahead once again into our

Community Invited to Conference on Traditional Peacemaking

LTBB Odawa tribal members, Tribal officials, and all employees are invited to attend an informative conference on justice and peacemaking traditions of the Anishinabek. The event is scheduled for Friday, October 14, from 2:00 - 9:00 p.m., and Saturday, October 15, from 8:00 a.m. - 3:30 p.m. It will be held at the Government Building in Harbor Springs. LTBB Tribal Court is hosting the conference, which will include a dinner on Friday, plus breakfast and lunch on Saturday.

A highlight of the event is a storytelling circle planned for Friday evening. Children as well as adults are encouraged to attend all or any part of the conference. The price of admission is an item for the Saturday afternoon giveaway. Advance registration is requested in order to plan for meals.

Peacemaking is the modern name given to traditional community justice processes which are focused on healing, accountability and restoring relationships. Across Indian Country, tribes are instituting peacemaking as an alternative to the justice systems that resemble the state and federal courts. It is often called a "new old way."

Presenters include Judge Ernest St. Germaine, an adjunct professor at the University of Wisconsin-Stevens Point, and former chief judge of the Lac du Flambeau Band of Chippewa, and Judge Alton "Sonny" Smart, a professor of social work at the University of Wisconsin-Stevens Point, and a Tribal judge for the Bad River Band of Chippewa. Both men are recognized spiritual leaders in their communities. Additionally, Michigan Indian storytellers are being invited for the storytelling circle.

The registration deadline is October 7. Further information and the registration forms are available from Linda Harper and Dave Keller at Tribal Court. They can be reached by calling (231) 242-1462.

From the Substance Abuse Department

We want to express our appreciation to the Tribal Council Resolution for supporting #082105-07 Mno-Bimaadziwin proclaiming Life September as Sobriety Month. Chii-migwetch! This resolution states that "the Tribe supports Mno-Bimaadziwin - Good Life for all its community members by encouraging individuals to lead substance abuse free lifestyles. A sober lifestyle is a positive effort that impacts the quality of life for the whole community; and those individuals who have substance abuse problems need support and assistance to access substance abuse services to enable them to live healthier lifestyles is in the best interest of the Tribe, its members, families and the community; and those individuals who are recovering from substance abuse problems would benefit from the support of the Tribal community as they walk the path of sobriety with them; and the Little Traverse Bay Bands of Odawa Indians supports our traditional Anishinaabe ways that teach us that alcohol and drugs are not a part of the circle and will continue to offer programs and resources to help families pursue healthy lifestyles. Therefore be it resolved the Little Traverse Bay Bands of Odawa Indians is honored to proclaim September as Sobriety Month as an effort to celebrate all who live alcohol and drug-free lifestyles and/or who are recovering from addictions."

Throughout the month of September our department has been sending out global emails to all the LTBB government employees that contain information about substance abuse recovery and daily affirmations as an effort to inform and support those in recovery. Also, in September we had our Sobriety Feast to honor those who live a sober lifestyle, regardless of how or why they are sober. The focus is about Mno-Bimaadziwin - the Good Life- and how that is the benefit of living substance free. We are not talking about prescription drugs and those who need drugs for medical purposes; we are talking about the

abuse of drugs, whether illegal or prescribed. Now is a good time to begin that Red Road, that path of recovery that brings naturally good feelings about being alive and being able to deal with the tragic things in life without resorting to abusing alcohol and/or drugs. There is no need to feel ashamed being on that Red Road, but there is shame, embarrassment, family chaos, legal problems, and other problems associated with the abuse of alcohol and drugs. We are happy to share this information with you and your families, so call us. Help us to help those who need support as they recover from this illness - addiction is very strong, but recovery is stronger with more people being supportive. Milgwetch to those of you who are supporting and encouraging those in recovery.

Just a reminder from the Substance Abuse Department about our Community Readiness

In last month's Odawa Trails we told the membership about a survey our department will conduct. We are going to ask several adult community members to fill out the survey. LTBB Dedicates Natural Areato Taimi Lynn Hoag

On August 4th, 2005, the Little Traverse Bay Bands of Odawa Indians dedicated a new natural area just outside of Charlevoix on Susan Creek, named after the late Taimi Lynn Hoag. Taimi's persistence and dedication to all aspects of the environment made her a leading force in environmental protection in Indian Country. She worked for several years as the LTBB **Environmental Services Director** until her death in December 2002.

The Susan Creek property project was her vision for her people. This 55 acre parcel that runs parallel to US 31, was purchased by Little Traverse Bay Bands (LTBB) with the collaborative efforts of Little Traverse Conservancy (LTC) and Tip of the Mitt Watershed Council.

This project began on

January 14, 2002, with Taimi's idea of partnering with LTC and Tip of the Mitt Watershed Council to obtain funding for land protection through a grant. Together with the LTBB, these organizations are committed to preserving Lake Michigan wetlands and tributary streams for tribal and non-tribal communities with funding through the Michigan Coastal Management Program through Michigan Department of

Environmental Quality and the National Oceanic Atmospheric Administration. The property was finally purchased in September, 2004. The natural area has a planned trail system including boardwalks throughout that will connect with adjacent Little Traverse Conservancy land encompassing over 200 acres of contiguous preserve.

The United States **Environmental Protection Agency** (EPA) also recognizes Taimi's accomplishments each year with an environmental stewardship award in her honor; which was established after her death in March of 2003. The criteria for this award follow the foot prints of Taimi's path. The recipient of this award must demonstrate a high degree of initiative and leadership for the advancement of environmental protection in Indian country; provide excep-



tional commitment, direction, and representation of significant environmental issues related to the assessment and protection of the air, water, land or other natural resources; develop public forums to address environmental issues that affect Indian Country; and make positive and noteworthy contributions to a Tribe's environmental and natural resources protection.

The Environmental Services Department staff is proud and grateful to be able to continue with Taimi's vision for environmental protection in Indian Country. We will miss her as a mentor and a friend.

The staff here at LTBB Governmental Operations is busy adjusting to the requirements of the new Constitution. The approved document defines the separation of powers and distinct branches of our government, Judicial Branch, Executive Branch and Legislative Branch.

Congratulations to the new Tribal Council and newly elected Legislative Leader, Bea Law; Treasurer Shirley Oldman and Secretary Mel Kiogima. It is an exciting time for the Tribe with new leadership and plenty of work on the table to complete.

As a part of the Executive Branch, we will provide our Tribal Council with the proper information and support required to make the right decisions on future direction.

Tribal Administration has started the process for updating strategic plans for all the departments. These plans will be finalized through meetings with the directors and with the assistance of staff within each respective department. 



As of August 22, 2005 our Tribal Health facilities have taken a new home. The new location is housed at the former Bear River Health Park Professional Building at 1080 Hager Drive, Petoskey, Michigan. The property is located behind Victories Casino. The new facility has 21,000 sq ft of room to house all current health programs as well as room for future expansion of services. There are now eleven patient care rooms for LTBB patients.

In making the decision to purchase this facility, the Health Director, Medical Director, Planning Department and Tribal Council, were looking at the future of LTBB Health needs for the next ten years. Future plans for the facility are to include dental clinic, pharmacy and a radiology department. Doctor Terry Samuels, M.D., Medical Director said; "We are very thankful to have the support of Tribal Council as well as Tribal Administration, as we expand our services in the new health park, these services become direct care and will be available to ALL Tribal Members regardless of their county of residence." What an exciting endeavor for the tribe to be taking in the area of health care and providing for our memberships needs.

This building is Min-A- Mskiki Gumik, all health programs. A list of programs that have relocated to the new building are: the Health Clinic, Community Health Outreach, Contract Health, Diabetes Program, Foot Care Clinic, Traditional Medicine, Maternal Child Health and Health Administrative offices.

Although the location has changed for all Health Programs, the telephone numbers have remained the same. The main Tribal Government Address is still: 7500 Odawa Circle, Harbor Springs, Michigan 49740. A Complete list of contact numbers will follow. The Doctor Samuels also informed me that there would be a Grand Opening held at the facility once all programs are unpacked and moved in completely. Look for announcements in next month's edition of the Odawa Trails.


