Come visit Quill Box Ehibit

The Little Traverse
Bay Bands
Archives/Records
and Cultural
Preservation has
developed and
placed a small
exhibit in the lobby
of the Victories
Hotel. This exhibit
serves to educate
hotel visitors,
guests, and community members about
our unique tradition
of quill box making.



The exhibit is made possible by a generous temporary loan by a private collector who managed to save thirty-nine quill boxes from being sold on an internet auction site. The loan is currently temporary with the Archives/Records and Cultural Preservation Department acting as agent for the collection. However, the collector plans to fully donate the boxes once the Tribe constructs an appropriate museum/cultural center. The current display was created to fulfill the wishes of the collector to have the boxes displayed until they find a permanent home.

To thank the collector and to properly open the exhibit, a small reception took place on August 9, 2005. There were approximately fifty guests in attendance to view the boxes, enjoy refreshments, generously prepared and donated by the Victories Hotel, and to take part in an honor song and pipe ceremony. The exhibit will remain in the lobby indefinitely. However, the Archives/Records and Cultural Preservation staff will provide changing exhibits in the future for the Hotel. We invite all tribal members to view the exhibit, even if they are not planning a stay at the hotel.



The case is placed prominently in the main lobby. It contains forty-one examples of exquisite quill work done by Odawa people with text to explain our history with the art form. So...please visit the exhibit!

Dear President Ettawageshik:

We received the results of the election held on February 1, 2005, where the eligible voters voted to adopt the proposed constitution of the Little Traverse Bay Bands of Odawa Indians. The election was called in accordance with the order issued August 25, 2004, by the Assistant Secretary – Indian Affairs, which permitted the qualified voters of the Little Traverse Bay Bands of Odawa Indians to vote on the adoption or rejection of the proposed constitution.

As evidenced by the completed Certificates of Results of Election, the proposed constitution was duly adopted in an election in which 65% of the 990 members registered and entitled to vote cast their ballots.

The constitution adopted by the voters of the Little Traverse Bay Bands of Odawa Indians is hereby approved pursuant to Public Law 103-324, 25 U.S.C. §1300 k-6(a)(1), and the Act of June 18, 1934, (48 Stat. 984), 25 U.S.C. 476, as amended, and by the authority delegated to me under 130 DM 3 (April 23, 2003). Nothing in this approval shall be construed as authorizing any action that would be contrary to Federal law.

APPROVAL OF CONSTITUTION
LITTLE TRAVERSE BAY BANDS OF ODAWA INDIANS

I, <u>Michael D. Olsen</u>, Acting, Principal Deputy Assistant Secretary – Indian Affairs, by virtue of the authority granted me by the Act of June 18, 1934 (48 Stat. 984), as amended, Public Law 103-324, 25 U.S.C. §1300 k-6(a)(1), and delegated to me by 130 D.M. 3, do hereby approve the constitution of the Little Traverse Bay Bands of Odawa Indians which received majority support of the eligible voters who voted in the constitutional election held February 1, 2005. This constitution is effective as of this date; PROVIDED, that nothing in this approval shall be construed as authorizing any action that is contrary to federal law.



After several months, we have finally received the official notice of approval from the Secretary of the Interior of our election for our new Tribal Constitution. That notice is reproduced to the left. The September 11th Tribal Council meeting will be the swearing in of newly elected officials under this new constitution. I've had the privilege of serving the Tribe since April of 1989. believe that it is important to recognize the milestones of history to reflect on our accomplishments and to think about what comes next. As we start working with the new constitution it will be an exciting and interesting

Repetitive Stress Injuries

What Are Repetitive Stress Injuries? (RSI)

Whether it's typing a school report or surfing the internet, your child may be spending lots of hours at the computer. By learning about the causes and prevention of repetitive stress injuries now, you can protect your child from future injury.

Repetitive stress injuries (RSI) are a group of conditions generally caused by placing too much stress on a joint, and they vary in type and severity. Most repetitive stress injuries are linked to the stress of repetitive motions at the computer or overuse injuries in sports. RSI in kids may occur from heavy computer or video game use, playing musical instruments, or the repetitive motion of sports such as tennis. RSI occurs when stress is placed on a joint, pulling on the tendons and muscles around the joint. When the stress occurs repeatedly, the body does not have time to recover and becomes irritated. The body reacts to the irritation by increasing the amount of fluid in that area to reduce the stress placed on the tendon or muscle. Conditions that occur as the

include the following. **Carpal tunnel syndrome:**

result of repetitive stress injuries

swelling inside a narrow

"tunnel" formed by bone and ligament in the wrist; the tunnel surrounds nerves that conduct sensory and motor impulses to and from the hand, leading to pain, tingling, and numbness

- **Cervical radiculopathy:** disk compression in the neck, often caused repetitive cradling of a phone on the shoulder
- **Epicondylitis:** elbow soreness often known as "tennis elbow"
- Ganglion cyst: swelling or lump in the wrist resulting from jelly-like substance that has leaked from a joint or tendon sheath
- Reflex sympathetic **dystrophy:** a condition characterized by dry, swollen hands and loss of muscle control; consistently painful
- Tendonitis: tearing and inflammation of tendons bones connecting muscles

Fortunately, only a small percentage of kids have RSI. You can help prevent RSI by taking preventive measures redesigning your home computer environment so that it fits your

Preventing Repetitive Stress Injuries

By taking some easy preventive measures, you can help your child avoid repetitive stress injuries altogether. One important step you can take to prevent RSI is to remind your child to sit straight in the chair. Slouching or crouching over the keyboard can place undue stress upon your child's neck, back, or spine and this can lead to a repetitive stress injury. In addition, help your child avoid tensing her shoulders. Legs should be positioned comfortably and feet should be flat on the floor or on a footrest with the legs and hips perpendicular (between 90 and 100 degrees) relative to the

Remind your child that pounding on the keyboard is unnecessary and can hurt both her and the keyboard! Using a light touch to type is best. Also, be sure that your child isn't reaching for the keys; if so, the keyboard should be moved closer to her. In addition, your child should maintain a 90-degree angle between the wrists and elbows and the upper part of her arms. Fingers and wrists should remain level while typing.

Taking frequent breaks is also an important step in preventing repetitive stress injuries. Your child may lose track of time and forget to take breaks, so it's your job to make sure she rests her eyes, back, wrists, and neck every half hour or so. Stretching, getting a snack or a drink, or a fun physical activity, walking or taking a bike ride can help your child avoid future pain. Eye twitching; sore, tired, burning, itching, or dry eyes; blurred or double vision; and increased sensitivity to light are all symptoms of eyestrain, so tell your child to look away from the computer and focus on something far away every once in a while. Proper lighting of the workspace will also help to prevent eyestrain.

Finally, you can help your child avoid RSI by setting a good example. If you stare at a computer screen in dim lighting for hours without taking a break, your child will get the message that it's OK to abuse your body. Set a good example, and your child will follow your ergonomically correct lead. By informing your child of the dangers of incorrect posture and positioning, you can keep her aware of avoiding RSI.

Many times, repetitive stress injury is caused by using the wrong tool for the job. Because most computer systems are designed for the body of a 25year-old man, you can help your child avoid repetitive stress injuries by fitting the tools, such as chairs, monitors, input devices, and keyboards, to your child's size.

Getting Ergonomic

Proper computer placement, correct typing and sitting positions, and well-designed furniture will make your child's computer environment ergonomic (which means to make equipment use less fatiguing and uncomfortable) and prevent future injuries.

"In computer usage - as with other equipment - the goal is to decrease both force and repetition, to ensure adequate rest breaks, and to achieve good positioning and good support.

Computer furniture can prove to be an ergonomic hazard if it does not adjust to promote good posture and hand positions. Don't put your new computer on a discarded desk with an old kitchen chair pulled up to it because these products don't give proper support to you or your child. You want the maximum adjustability in the set-up from the desk and chair height to the position of the keyboard relative to the elbows and trunk to the height of the monitor. This is necessary because kids come in all different heights and sizes.


I hope this finds you enduring the heat. I think it will make the Fall season even more welcome.

We do not have a date yet for the Michigan Indian Elder's Association Conference at Mt. Pleasant. We will get that information in the newsletter as soon as it is available.







Michigan Tribes showed up in great numbers, all with one hope...to bring home the first place team trophy. I am proud to announce, for the third consecutive year, Little Traverse Bay Bands of Odawa Indians brought home the Gold! There were 620 registered participants with several spectators that came out for the day's events. LTBB had 151 registered participants and a few "cheer leaders" that attended the event filled day. Grand Traverse Band of Ottawa and Chippewa had 160 registered participants but the LTBB Athletes still managed to come out on top. In the point standing the judges recorded LTBB having 355 points for

medals earned. The next highest finishing team was GTB with 248 points.
Elders as well as infants attended to represent LTBB and there was a real sense of Community Pride displayed at the games. This is an event that attracted members from Southeastern, Southwestern, Mid-Michigan and people from right here in the Harbor Springs/Petoskey

Substance Abuse & Mental Health Department

The Substance Abuse and Mental Health Department will be conducting a survey at some upcoming community events.

We know from our last survey that some

We know from our last survey that some people are surveyed out so we thought it would be best to do this one in person.

This survey will be important in creating a prevention program for our youth and families. In our last survey it was found that 65% of the respondents were asking for a prevention program for our youth and families. The survey that we have chosen has been used at several other Tribal Nations in Wisconsin and Minnesota to help them create programming for their families and youth to prevent substance use and abuse. Those communities reported that it was a very good tool in helping them provide programming and events that the people would invest their time and energy in.

Many respondents to the last survey felt that a lot of resources were being spent on surveys such as this one. After careful consideration the program staff decided to complete the survey in person. Doing the survey in person saves a lot of mailing cost and allows the program to give responses to questions on the spot.

We will only need 150 surveys filled out and we decided to reward people with a cool T-shirt for taking the time to fill out the survey. The T-shirts will have a turtle on the front with the words "MNO-BMAADZIWIN" (Good Life).

The survey will ask questions about your opinion of our community and your thoughts about alcohol, drugs and gambling as well as how you see those things can affect people. Also some other non identifiable demographics will be asked, such as age and gender. At no time will you be asked to identify yourself.

We are taking the time for this survey because it is an important step in creating a program to fit our community and its people. If the program is created without the input of the people it has a small chance of helping or reaching anyone.

As before we will make sure we let the community know what we find out when the survey is complete and what the recommendations are for events and programming.

Diabetes Prevention and Control

Food is mshiki (medicine). In our language it translates as strength from the earth. All that we need to live a good life has been given to us by the Creator. It is all held here in the bosom of Ishkakamikwe (Mother Earth). She holds the water for all life here on Turtle Island, she is home to the plants and animals that we use for food and medicine. She also provides us with shelter and warmth. In return, we honor and respect her by caring for the Earth, making an offering for what we take and taking only what we need, and most of all being grateful. The Creator has provided us with everything that we need to have a good life.

We know that the reason that our people have a high incidence of diabetes, pre-diabetes, metabolic syndrome and cardiovascular disease is directly related to the types of foods that we eat and lack of physical activity. Another equally important factor is that we have not been involved in the growing, gathering, hunting, fishing, harvesting and preservation of the foods that we eat.

Some of the mshiki that goes into the foods we eat comes from those who have taken part in the preparation of that food. My Mom always told me to do everything that I do with love. (I am convinced that that is why Mom's cooking is always the best.)We do not know what kind of energy was added to our food when we buy it from the stores. We do know that chemicals that are added to prolong the shelf life of products, foods are 'processed'-what does that mean exactly? It is one of those words that cover just about any changes that are made to the original product before it is consumed. It means that every step of this 'process' takes us farther away from the Earth-from the natural state that the Creator intended us to use these gifts.

Have you ever read the label on a hotdog package? The list of ingredients includes: "chicken parts". That's scary! Take a look at the meat counter the next time you go to the store. You will find chicken breast, wings, thighs legs, livers, and necks. So what part of the chicken is

left to go into the hotdog? Chicken lips?!

Lastly, who is making an offering or

Lastly, who is making an offering or praying to these plants and animals that have given their life so that we can live. The circle of life is incomplete. We do not have to expend as much energy to obtain the things that we need. The Home Grown Project is a collaborative community effort to enhance towards the development of sustainable food systems for our people. This program is really in the planning stages. We are looking for community input and also for 2 community members to be a part of the commission (or whatever we call ourselves) that we help to provide some direction for this project. We are limited only by our imaginations or lack thereof. As a community we work together with a common goalunity, strengthening the connection between ourselves, the food that we eat and our Mother-Ishkakamikwe, honoring the circle of life.

It is a lot of work but the benefits are life giving and life sustaining. If we change the way we eat, (eating natural foods-foods that we grow, gather, or harvest), increase the energy we expend providing for our families (increasing physical activity), we will defeat diabetes and cardiovascular disease and leave a legacy of a healthy, traditional lifestyle to our children.

Towards this end, we have four small gardens growing, many seed packages were given away (have not gotten any feedback on how those gardeners are doing), and we have contracted with Danny Berg, a local farmer, to deliver fresh vegetables twice a week throughout the growing season. This has been a huge success. We have received a lot of very positive feedback regarding this program. The best part is that we are eating more vegetables!

We also have cooking and food preservation classes scheduled. We have been drying and canning foods as they are harvested. We will be using some of this food for our feast. It has been a lot of fun so far. Work that is shared does not seem like work at all. Please join us.

Food is mshiki. With it we can prevent diabetes and cardiovascular disease. It can help us to heal our bodies, mind and spirit.








Tribal Member Gertrude Chingwa Places a LTBB Tribal Flag on the fence in memorial where Flight 93 crashed on September 11, 2001


