ter McNamara as Vice Chairman. Together, we made a good team with Dexter's eight years Tribal Council experience; he was an encyclopedia of knowledge when questions or crucial situations arose. Accompanied with my 25 years

of business and development experience, we addressed tribal government programs, capital improvements, issues and concerns diligently and professionally. At our level, there are many hard decisions to be made and then administered. We consulted and made many decisions together, supported each other and have many accomplishments in less than two years. We can be proud of the money saved, developments and the improved services while under tight budget constraints.

The results of the latest recall election held on August 8, 2011 have removed me from office and retained Dexter. This meant Dexter became Tribal Chairman and will appoint a new Vice Chairman who will need Tribal Council approval by majority vote of a full Council. A swearing in process for Dexter was held on August 23, 2011 following the validation of the recall election results on August 22, 2011. I did have a right to challenge, and I considered all options at that time. After the certification of the recall election results, I then stepped down from office. A Vice Chairman is in place for situations such as this, and Dexter has what it takes to carry on as your Chairman. We are urging your support for Dexter to finish this term in a

On our first day in office, August 24, 2009,

we had a meeting in the Chairman's office about the Murray Road Housing Project, and the schedule for construction of the 10-unit subsidized housing development in Hayes Township, MI. The project schedule moved up nine months and is now complete. The 10-unit development is Gold LEED certified. What does LEED mean? Leadership in Energy Efficient Development, and LTBB is now a leader in LEED across the nation. We have the only multiple unit Gold LEED certified project in a 26state region. We simultaneously developed a single family home in Wah-Wahs-Noo Da Ke, our Harbor Springs, MI, housing development. Both projects were grant funded through the American Recovery and Reinvestment Act.

Within the first week, we addressed all loans and leases our tribal government had at that time. We restructured to cut costs and dissolved some storage leases, moved Mental Health/Substance Abuse from a rented building to our LTBB Health Park in Petoskey, MI, and have renovated our own buildings for storage. There was a \$2 million loan remaining on our LTBB Governmental Center in Harbor Springs, and this is now paid off. Tribal Council renegotiated our \$122 million casino loan we defaulted on, and we are one of the first tribes ever to accomplish this painful task. The debt

is now \$40 million with a better interest rate. During the forbearance process, the Chairman vetoed a resolution that was not overridden that saved our tribe a \$500,000 contract in the eleventh hour of our bond renegotiations.

# Postcard of Her Grandmother, Virginia Janet Kishigo-Laughlin, As an Indian Princess Inspires Miss Odawa Nation 2011-2012 Josephine Laughlin

As a young child, Josephine Laughlin saw a postcard from the 1940s of her grandmother, Virginia Janet Kishigo-Laughlin, as an Indian princess. Ever since that moment, the 14-year-old LTBB Tribal Citizen has wanted to follow in the footsteps of her grandmother and be Miss Odawa Nation.

In her first year eligible to compete for Miss Odawa Nation (contestants must be between 13 and 19 years old), Laughlin finished as the runner-up by one point in 2010. Undeterred, she competed again this year, and her lifelong dream became a reality when the Harbor Springs, MI, resident was crowned Miss Odawa Nation 2011-2012 at the 20th Annual Odawa Homecoming Pow Wow on August 14, 2011. She is the first LTBB Tribal Citizen crowned Miss Odawa Nation in several years although Miss Odawa Nation 2007-2008 Alicya Wix is a LTBB descendent.

"It's one of my life goals achieved as I have wanted to be Miss Odawa since I was a small child and saw the postcard," she said. "By setting a positive example, I hope to properly represent my tribe while fulfilling all of my duties. I will serve my people with

pride and honor, always remembering the only encounter the person may have with Native people is through me."

Laughlin, whose Indian name is Little Bee Woman, has attended pow wows all of her life with her family and has been a traditional dancer for nine years. Her older sister, Nicole, 16, has been a fancy shawl dancer for 10 years.

"Traveling along the pow wow trail has always been a priority of mine and my family's," Laughlin said. "Whether traditional or contest, it is always fun for me to go out and do what I enjoy. Being a traditional dancer is a custom and tradition that I plan to pass on to my own children. Our traditions are important to identify us as a nation and must be preserved. My family and I try our best to keep us identifiable as Odawa people. Our culture and teachings help me to be the best person I can be."

Laughlin is the daughter of Melissa (Naganashe) Laughlin and the late Richard Laughlin and the granddaughter of the late Virginia Janet Kishigo-Laughlin and the late Thomas Laughlin and Thomas and Dianna Naganashe.

"From infancy, my mother and father have taught me the meaning and value of family and the background of where I come from as an Odawa," Laughlin said. "We practice Native spirituality and venture away from our home in Harbor Springs to gather and interact with other Native families from all over. I always keep in mind, I represent my family and sometimes, even my tribe already as I may be the only LTBB person these others encounter."

Laughlin and her family are active in the LTBB tribal community, participating in many tribal events and gatherings, and she strongly encourages other Native youth to participate in

### TAX AGREEMENT INFORMATION

The Department of Commerce (DOC) would like to remind the tribal membership about a few items pertaining to the Tax Agreement.

First of all, I cannot express enough how important it is to keep your address updated.

The first step in becoming a Resident Tribal Member (RTM) is to officially change your address with the Enrollment Department. This must be done in writing and as soon as possi-

The DOC cannot and will not change the estimated beginning date (EBD) (which is always the first in any given month) of a member's tax exempt status (see example below).

It is YOUR responsibility to update your address on file with the Enrollment Department. This date will affect how many months you will be able to file the Annual Resident Tribal

Member Sales Tax Credit (Tribal Form 4013). It is to your benefit to be able to file for the maximum number of months for this credit.

In addition, being an RTM will allow you to purchase large items such as vehicles, boats, motorcycles and off the road vehicles tax exempt.

There is a form that needs to be filled out called a "Request for TCE" (Tribal Certificate of Exemption), which is available in my office. Once this form is completely filled out, I will then issue the RTM the actual Tribal Certificate of Exemption (Tribal Form

If you plan on purchasing any of these items, please contact me FIRST, and I will be happy to get you the form via e-mail or fax. I am also able to fax the TCEs to the dealership you are doing business with.

Being an RTM will also allow you to be tax exempt on utility bills such as phone, cable, gas, propane, electricity, satellite and cellular service. If you

have not filled out a Utility Provider Survey, please contact the DOC, and I will be happy to get one to you.

Also, another important thing to remember is if you do move into the Tax Agreement Area (TAA), your RTM status does NOT take effect until the first day of the following

Example: I move to Petoskey, MI, (inside the TAA) on September 5, 2010. My RTM (EBD) status begins October 1, 2010. All updates are sent to the State of Michigan as close to the end of the month as possible.

## Address Verification Forms Due November 30, 2011

All minors need to have a notarized MI-NOR ADDRESS VERIFICATION FORM completed annually before November 30, 2011. No faxed or electronic versions are accepted because all forms require original signatures. Forms must be mailed to the Enrollment Department at 7500 Odawa Circle, Harbor Springs, MI 49740 or dropped off at the aforementioned address. The Enrollment Department is located on the first floor of the LTBB Governmental Center in Harbor Springs, MI. If you have any questions concerning guardianship or custodial issues, please contact the Enrollment Department at 231-242-1520 or 231-242-1521.

Minors who turn 18 by November 30, 2011 must complete an ADULT ADDRESS VERIFICATION FORM. This form must be returned by November 30, 2011.


Currently, we have 4,494 enrolled LTBB Tribal Citizens. Normally in late October, we start preparing for the annual per capita payment. We begin by mailing the Minor Child Ward of the Court Address Verification forms to our minors. We then notify our minors turning 18 that an Adult Address Verification form must be complete because they are considered an adult. Due to the amount of unclaimed forms, we will not be mailing the forms.

  4. Michigan Business Tax (currently 4.95%)
  5. \*Motor Fuel Tax (currently, 36.5 cents per gallon unleaded and 32.6 cents per gallon on diesel)
  6. \*Tobacco Product Tax (currently \$2 per pack of cigarettes)
- \* All LTBB Tribal Members are entitled to the exemption on fuel and tobacco.
- \*The Motor Fuel and Tobacco Product Tax exemption is available at Biindigen (tribal convenience store) located at 2169 U.S. 31 North in Petoskey, MI.
- \*The Motor Fuel Tax exemption is also available at the BP station on the south side of Petoskey, MI, near the Big Boy restaurant.

Please note: Exemption for tobacco and fuel is for LTBB Tribal Members' sole consumption ONLY!

IMPORTANT REMINDER: TRIBAL MEMBERS ARE NOT ALLOWED TO USE THEIR TRIBAL ID SWIPE CARDS FOR PURCHASES OF NON-MEMBERS NOR ARE THEY ALLOWED TO LEND THEIR CARDS OUT TO ANYONE.

The current limit on tobacco purchases is four cartons per week per tribal citizen age 18 and over. The same applies to all other tobacco products (OTP) packaged in similar fashion.

Your RTM status will take effect on the first day of following month in which you moved.

ATTENTION ALL RESIDENT Tribal Members (RTMs) If you are planning to purchase a vehicle, ORV or plan on doing any home improvements to your principal place of residence, YOU NEED TO CONTACT ME FIRST before making the actual purchase(s). You must fill out the "Request for TCE" form located on the LTBB website or by contacting my office. I will then issue you a "Tribal Certificate of Exemption" for such purchases. We would like to take this opportunity to introduce Mno Ode (Healthy/ Good Heart) Program. This is a new grant called the Special Diabetes Program for Indians Healthy Heart Initiative, and its purpose is to determine if a program in our community to prevent cardiovascular disease in people with diabetes is helpful.

In 2004, Congress funded the Indian Health Service to give funding to selected Indian Health programs to demonstrate implementation of activities in Indian communities to reduce the risk of cardiovascular disease in our people. We are now in the enrollment phase and are looking for people with diabetes who are interested in decreasing their risk of heart

You may already be aware diabetes and heart disease are very serious health problems for Native peoples, and diabetes is a major risk factor for heart disease. This includes heart attacks and strokes. Studies have shown yourrisk of developing heart disease can be reduced by controlling your blood pressure, weight, cholesterol levels and by not smoking. These are risk factors you can control.

Mno Ode offers intensive case management of your diabetes, including education on heart health, weight loss, healthy eating and a physical activity program geared to your personal needs as well as the needs of your family. It also means we will do whatever we can or need to do to help you decrease your risk factors. We will support each other on this journey to wellness. This includes a physical exam, lab test, baseline ECG - checks out your heart to learn as much about your health as we can. You will also receive health education, in a group or as an individual, and participate in program activities. We will work together to develop a wellness plan specific for you (and your family). We will get there one step at a time, together! By joining the Mno Ode, the SDPI Healthy Heart Initiative, you can:

- Reduce your chances of getting heart disease
- Help your family learn new ways to live in balance - healthy eating, active living
- Receive professional medical and nutritional advice from people who truly care about you and your

#### LTBB Contract Health Services Vision Care Guidelines

In order to be eligible for payment for vision services, these criteria must be met:

- 1. Patient must be registered and in compliance with LTBB Contract Health Services guidelines.
- 2. Patient must receive services at preferred provider, which is Vision Max in Petoskey, MI.
- 3. Patient must contact LTBB Contract Health to receive a reference number BEFORE the appointment occurs.

\* LTBB CHS is the payer of last resort and will only pay for copays for these services for insured patients, and patients must schedule services in sync with their vision insurance coverage. (Example: Patient cannot use LTBB CHS to pay for exam one year and their vision insurance to pay for exam the next year; must coordinate visits, so LTBB CHS and insurance pay for the visit on the same year)

#### Medically Necessary (non-routine) services:

- Annual dilated diabetic eye exams will be covered for diabetic patients as well as glasses that result from a prescription change.
- Referrals as a result of school screenings will be covered.
- Other medically necessary eye care services will be considered for payment through the CHS Managed

#### LTBB CHS will not pay for:

- Non-medically necessary services such as progressive, transitions or anti- reflective lenses.
- Replacement of broken or lost glasses.





## WOCTEP LEADS ELDERS EXERCISE CLASS

WOCTEP Health Curriculum Coordinator and Exercise Specialist Tina Dominic led the June 28th Elders Ex-

ercise class. Her focus for creating the lesson plan, for this class, was to focus on 1. Posture, 2. Leg strength and 3. Flexibility. "It's very important to be aware of posture ..." Dominic stated, "... just being aware of how we stand or sit can help correct our positioning and work towards a healthier posture." Simply keeping our feet flat on the ground, without crossing our legs, can help promote better posture. Bringing the chin down and "putting our

shoulders in their back pockets" can also help correct poor posture. "A few times a day, I like to pretend that I have a string attached to the top of my head, pulling me straight up in my seat." It may take some time to see results, but by practicing these tips daily, you should notice a difference over

Dominic said having a healthy spine can prevent a lot of backache later in life, so be sure to practice "posture awareness" as often as possible!!! A few of the leg strengthening exercises were the "chair stand" and "plié squats" (both can be performed while holding a chair). These are great ex-

> ercises you can also do at home, stated Dominic. It's a great way to jumpstart your circulation by doing these exercises in the morning!!! Dominic always recommends warming up before stretching. Not stretching cold muscles could potentially lead to injury. A five or 10minute walk or spin on a stationary bike to get the muscles warmed up is better than no warm up! Although she did not ask the elders to walk or ride a bike to warm up for

the elders class, they did the leg exercises before stretching, which allowed for the muscles to warm up first. Dominic had the elders do stretches which can be done while being seated. Chair exercises are wonderful for people of all ages, and can benefit those working at a desk as well. Note these verbs may be said in different ways and may mean something else in another context. These verbs are given in present tense for third person (She or He, Wiin) and for first person (I, me, Niin).

When changing from third person to first person, drop the last vowel sound if it is at the end of the word and if it is a short "I" or short "alo" sound. Usually, use "N" at the beginning to signify Niin, I am doing the action. The N can be with a present tense indicated such as da, di, do, daa or can be used alone depending on what sounds flow well or the speaker's preference.



## MEET WOCTEP CURRICULUM COORDINATOR - Business Tech Sean Kutzler

## Prepare Kids for

"Will my teacher be nice? Where will I sit? Will the other kids like me?" Many kids get nervous about heading back to school. "A big part of a successful first week is establishing a routine and explaining where the bathroom is, what happens when you go to gym class and when to expect recess," explains Cathy Dunne, a seventh grade teacher in the Toronto area. With a little preparation, parents can help. Here's how to make your child's transition a smooth

Remember Routines. Family routines tend to slide in the summer — after all, what's summer without crazy bedtimes, a popsicle habit and wearing swimsuits for days on end? — and it can be hard to readjust come fall, notes Patricia Tanner Nelson, Family and Human Development Specialist at the University of Delaware. "Well before school starts, focus on choosing sleep, exercise, healthy foods and time together," she says. Rosanna Scott, a mom of two

from Ohio, agrees. "Practice school bedtimes a week before school starts, so that the new routine is established," she says.

Get Ready! Don't underestimate the fun and importance of new stuff for the big day. With younger kids, a bag full of school supplies, a new backpack and a few new items of clothing tend to gear them up without any further encouragement, says Amanda Formaro, mother of four in Nevada. For an older child, this may be the time to give the thumbs-up to that must-have trend item, especially if he's earned some money over the summer to pay for it. For ideas, find out what's hot this year and get a printable supply list.

Show Them the Way. If she's new to the school, show your child her classroom, what entrance and exit to use and where the bathroom is located. If she's taking the bus, visit the bus stop location and explain how to get on and off, especially if it's the first time. Show her the drop off and pick up spot at school, too — if you're not sure where it will be, call the school ahead of time to find out.

Some schools will allow you to take a tour during the summer and arrange to meet the teacher. Third grade Alberta teacher Fay Chomik suggests encouraging a sense of ownership on the tour: "This is your school, your gymnasium, your lunch

Prepare the Teacher. Let your child's teacher know about any specifics about behavior or health.

Talk, Talk, "I try to think of all the positive things that they like about school, and I talk about them as much as possible," says Formaro. "I ask about friends they haven't seen over the summer. I also look at my kids and note anything different that their friends will notice, such as a new hairstyle or if they've grown over the

Be Organized. Ease back-toschool anxiety by being prepared. Help your child to lay out her clothes and pack her backpack the night before. Be sure to include a healthy lunch and a snack that your child can open and eat on his own.

Take It Easy. Preparation is great · but don't go overboard. "You can



make back-to-school too big a deal!" laughs Tanner Nelson. If September was a hard month for you as a kid, it might not necessarily be the same for your child, and vice versa. You're the best judge of when your child needs reassurance, and how to go about giving it. "In the end, remember that it's normal to feel a little nervous or fluttery about that first week back. Everyone, including the teachers, feels like that," she says.

I advised him of some ideas of what I thought should go into a mural which would be titled, Waganakising: Land of the Crooked Tree, Pre-European Contact. Burkhart took notes and incorporated into the mural everything I suggested. I viewed his progress while worked. The library staff

worked closely with us, and we were able to contact people to retell stories from the Odawa's past at the opening.

Earlier this summer, the library staff reconnected with LTBB Staff to assist in producing a book of the stories, Waganakising: Stories from the Mural, A Collection of Odawa Tales. The book is dedicated to "the storytellers who have kept these stories alive and to those -present and future - who continue the tradition."

The collaboration of dedicated effort by the library staff, LTBB Departments and LTBB Community Members resulted in the book for the

"Students must submit grade reports for the previously awarded semesters. If necessary, adjustments will be made for any credits, withdrawn or deemed ineligible, according to GPA guidelines." Please be advised adjustments will be made for any class a student withdraws from or earns an incomplete or when a student receives a failing grade and is not awarded credit by the institution.

Merit applications for the 2010-2011 academic year are now available. Students currently enrolled for summer semester may apply when their semester is finished, all other students may apply now. Students will need to submit a Merit application as well as grade reports from any semester attended for the 2010-2011 academic year. Faxed copies will not be accepted. Please be aware the award has changed and will be issued once per academic year taking into consideration the GPA average for the entire academic year. > Some of the trainings are mandatory and are required to maintain an officer's effectiveness; however, some of the additional trainings attended contribute to the overall capabilities of an officer.

> One of the training subjects the Conservation Enforcement Program (CEP) has embraced is the Joel Hardin Professional Tracking Services (JHPTS) program. All three of the LTBB Conservation Officers are actively in the program with two having completed approximately 150 hours of training instruction. This program provides students with specific training procedures, practices, techniques and tactics to equip law enforcement, military, special operations forces, search & rescue and emergency response personnel to ob

serve and interpret physical evidence left by human passage otherwise unseen. JHPTS utilizes a proven technique that is the result of 30-plus years of tracking mission and training experience. Students are evaluated after the conclusion of each training course. The mixing of other tracking programs could lead to confusion or lack of coordination during a mission and may lead to an unsuccessful and unprofessional conclusion, so the CEP is committed to JHPTS and has progressed through the program.

As a result, we are pleased to announce Roger has received his "Basic Tracker" certification from JHPTS and continues to participate in training session missions to move to the next certification level. Congratulations to Roger!

On June 26, 2011, Tribal Council passed a statute that provides an award for high school Tribal Citizens who obtain a high school diploma, a General Equivalence Diploma (GED) or a certificate of completion for students in Special Education programs. The law is called the Shirley Naganashe Oldman Secondary Education Completion Award in honor of Shirley and her dedication in assisting Tribal Citizens to obtain their highest level of educational goals. Tribal Chairman Ken Harrington signed it into law on July 28, 2011. This law will take affect for the Graduation Class of

According to Diplomas Count 2010, nationally, 1.3 million members of the public high school class of 2010 will fail to graduate with a diploma; that amounts to a loss of 7,200 students from the U.S. graduation pipeline every school day or one student every 25 seconds.

Michigan high schools are following the national trend. According to Alliance for Excellent Education, the national rate for high school American Indian graduates is at 50%, and in Michigan, it is at 48%. Michigan is faring worse than the national average. Overall, the dropout rate for

students in Michigan is more than 32,400 students. The lifetime earnings lost for these 32,400 students total more than \$8.4 billion that could have been earned if they stayed

Education Week reported in 2010 the nation's graduation rate has dropped for the second consecutive year, following a decade of mostly solid improvements. "These new findings raise cause for concern, as those who fail to finish high school will face far greater hardships than their graduating peers, particularly during a period of economic instability."

Based on these latest reports, Tribal Council agreed our students need to know graduating from high school is important, and a great accomplishment for our youth and future generations. We need to acknowledge this achievement and provide encouragement for those students who are struggling to stay in school. As a result, the new statute will provide an award in the amount of approximately \$150-\$200, based on the amount of applicants, for all students who graduate from high school, receive their GED or a certificate of completion for students with disabilities. This hopefully will

be a stepping stone toward continued

education and utilization of the Michelle Chingwa Scholarship.

## Housing Department Programs

Services are available to citizens residing within the 27 county service area. An application packet must be completed and returned to the Housing Dept. for processing to determine qualification. To obtain an application, please contact the Housing Dept. at 231-242-1540.

Short Term Rental Assistance: This program offers up to \$1,500 for new tenants who need assistance with the first month's rent and/or security deposit. This can be used ONE TIME ONLY and the rent requested must be affordable and can NOT exceed 35% of the household gross monthly income. Please note the application packet must be received and approved in advance of your moving into the rental in order to qualify for this program.

Home Improvement Program: This program offers up to \$2,500 for non-cosmetic home repairs and may be utilized once every five years.

**Down Payment Assistance:** This program offers up to \$2,500 or 10% of your mortgage (whichever is less) and can be used to purchase or refinance a home. In order for you to receive any grant dollars, you must be able to match the grant amount with your own guaranteed funds.

Foreclosure Prevention Program: This program offers up to \$3,000 to assist in foreclosure prevention.

Well & Septic Assistance Program: Funded by the Indian Health Services located in Sault Ste. Marie, MI this program provides the resources and technical assistance associated with the installation of a new well and sanitation service or replacement of deficient existing well/septic.

**Credit Counseling:** We provide confidential advice and referrals to assist tribal citizens in regaining their financial stability and credibility.

**Tribal Rental Housing Program:** The LTBB Housing Department offers 29 rental units in the Northern Michigan area. These units are available to rent to Tribal Citizens and most rents are based on a family's monthly income. Any Tribal Citizen interested in renting a unit from the LTBB Housing Department should contact our offices for an application. Currently, there is a waiting list for available units.



Odawa Casino Resort and Odawa Hotel administration and organizers with special gratitude to Chef Eric, Russ Worthington, Amanda and the rest of their dynamic dining room experts.

Bob Dominic served as our keynote speaker. He humbly asked why he was speaking because so many others qualified on history. A history teacher, Bob offered the opportunity to travel the path of our ancestors. Even though he was asked to present Odawa history, we as a Native people, are all Anishnaabe and could not be clearly separated. Bob reminded all of us of the path our ancestors walked as a people, including a glimpse of their challenges, sacrifice, vision and success.

Archival Tech Yvonne Walker- Keshick's presentation followed, and she spoke on global warming and the im-



pact our misuse of Mother Earth is having. Yvonne spoke of our sacred trees giving us clear definitions of how their strong medicine could help us to heal Mother Earth. Taking the first step in initiating a campaign for planting these trees, Yvonne questioned if one person could evoke change and if her thinking was perhaps naive. For one event, MIEA purchased and encouraged the planting of 300 blue spruce seedlings and 400 blue spruce saplings! The first steps in an ongoing campaign!

Anishinaabe youth and elders shared verbally and in writing, the commitments in support of one another and tradition before uniting in a round dance accompanied by the Spirit Lake drum: PLANTING THE SEED, CUL-TIVATING OUR FUTURE THROUGH FORGING RELATIONSHIPS BETWEEN OUR YOUTH AND ELDERS.

Among the MIEA scholarship recipients were LTBB Tribal Citizens Jory Purvis and Regina Gasco. Purvis was the only unanimous choice of the judges and therefore, received the \$1,000 scholarship. He is attending the University of Michigan and studying Computer Science with a projected graduation date of 2015. Gasco received three votes from the judges and received a \$500 scholarship. Gasco is an all A student of Nursing at North Central Michigan College (NCMC) in Petoskey, MI. She is the granddaughter of Alice and Bob Yellowbank and the daughter of Regina and Archie Kiogima, Jr.

MIEA elections were held, and two vacant seats on the Election Committee were filled by Ruth Suldivor and Susan Larson. LTBB Tribal Citizen Bill Demeny, Sr. was elected as the new Vice Chair! Mike Duschene was reelected as Treasurer, and Anna Harwood was elected as the new Officer at Large.

The silent auction raised \$1,700, and the 50/50 ticket sales raised \$550 with \$275.50 paid to the winner. MIEA was presented with a check from Independence Village of Petoskey, MI, along with a big thank you to LTBB for paving and beautifying Lears Road past the village. We look forward to a positive, ongoing relationship with the Independence Village VP and its affiliates as it supports senior programs and living throughout the state. All funds will be applied directly to the MIEA scholarship fund.

The next MIEA Conference is scheduled for October 12, 13 and 14, 2011 and will be hosted by the Little River Band of Ottawa Indians.

accepted a \$250,000 donation from CMS for the construction of our tribe's fish hatchery. Tribal Council approved the donation. An additional donation for \$250,000 may be contributed by CMS for the hatchery. Our savings and restructures have ultimately paid for our salaries for the full four-year term. Future plans for profitable businesses submitted by the Chairman to Tribal Council remain on

Other developments include the Firekeepers Lodge, the Natural Resource Department fish hatchery slated for construction in Spring 2012, the veteran's memorial was initiated and approved as a site plan for construction in our administration, site plan approval for a new Archives and Records building at the LTBB Government Center, development of a small biodiesel, wind studies for future wind development, Aldridge property repairs and maintenance to revive three cabins and to make them available for rental units, restructure of our Dental Clinic and three playgrounds for our youth, one at Murray Road, one at Wah-Wahs-Noo Da Ke and a third playground at the LTBB Governmental Center with an outside basketball court

were approved. The play areas are in conjunction with the "Let's Move Initiative" to get kids moving and outside.

In other news, our tribe took the first place trophy for the Michigan Indian Family Olympics. The Huron Potawatomi tribe came in second (although the Huron Potawatomi later contested the results and was declared the winner), and the Grand Traverse Band of Ottawa and Chippewa Indians in third. The Huron Potawatomi and LTBB have swapped first place the last four years; they will be gunning for us next year. We will be back to compete and have fun next year; hope to see you there. The Chairman carried our flag in the opening ceremonies and helped the team with four medals. This is a fun, family event, and it was enjoyable to see all the smiling faces.

In closing, I want to say Dexter and I have always put our tribe first when a decision was made. We can be proud of the work accomplished and hold our heads high. When the time came, I passed the torch I had been carrying for our tribe and turned the reigns over to Dexter McNamara, our Tribal Chairman. I urge all to support Dexter for the remainder of his term, and let's work together.

## Michigan Indian Land Claims Settlement Certificate Redemption Update

Submitted by the Trust Fund ing the age of 18. **Board** 

It has been more than a decade since the original Michigan Indian Land Claims Settlement certificates were issued.

All adults have been paid or they have deferred payment to a later date, however, tribal children who were enrolled before December 16, 1997 but had not yet turned 18 are still in the process of redeeming their certifi-

The following steps are intended to aid in this process. Redeeming certificates from the Michigan Indian Land Claims Settlement Act, Public Law 105-143, are as follows:

1. Determine your eligibility: Tribal citizens who were enrolled, but had not reached the age of 18 on December 16, 1997 are eligible to redeem their certificates upon reach-

- 2. Sign your certificates with a notary: The tribal citizen redeeming his or her certificates must have a notarized signature.
- 3. Copy two pieces of identification: One piece of identification (e.g. Driver's license) must have a picture, and the second piece needs at least your signature.
- 4. Mail your signed certificates, the mailing address you would like your check sent to and two pieces of identification to the following ad-


with me," Willis wrote. "You couldn't ask for better representation for your nation. I am proud to have her call me
