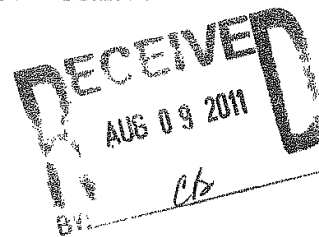

**STIPULATION AND ORDER REGARDING CUSTODY, SUPPORT,
PARENTING TIME, AND BREACH OF CONTRACT ACTION**

NOW COMES, the parties, Roan Exelby, by his attorney Jodi J. Doak, PC by Jodi J. Doak, and Kristina Lynn Dominic, by her attorneys Law Offices of Daniel J. Harris, P.C by Travis J. Groat, and hereby stipulate and agree that the following agreement will resolve all claims between the parties and is in the best interests of their minor child. The parties agree as follows:

1. The mother, Kristina Lynn Dominic shall have full physical and full legal custody of the minor child Karlee Exelby, until further order of the court. However, the mother shall inform Roan Exelby, the father, of all major decisions that will be made in a timely manner and will, where practical, seek his advice and opinion before making a decision. Mr. Exelby will also be informed of where Karlee is attending school and of school events.
2. The parties will work together to make every effort to schedule Mr. Exelby's parenting time by January 31 of each year. A minimum of thirty days notice shall be provided to the Plaintiff mother of the visits, unless otherwise agreed by the parties. Mr. Exelby agrees to forward his travel itinerary to Plaintiff Mother prior to his parenting time. The visits shall not interfere with school. However, if his parenting time is during school, he may exercise that parenting time provided he makes arrangements for her to attend school during that time at her school. Parenting time shall be a gradual schedule, as follows:

- a. From now until January of 2013, Mr. Exelby shall have one visit for a maximum of two weeks and three visits for a maximum of one week each, and also as the parties may otherwise agree.
 - b. For the year 2013, Mr. Exelby shall have three visits consisting of a maximum of two weeks each, and also as the parties may otherwise agree.
 - c. Beginning in 2014, Mr. Exelby shall have three visits per year consisting of three weeks each, and also as the parties may otherwise agree.
3. Parenting time of Mr. Exelby shall be his time, and the child shall be with him during that time without interference from the Plaintiff mother. However, the child shall be permitted phone or Skype contact with her mother but Plaintiff mother agrees to limit the duration of the contact so as to not take away from Defendant's time with Karlee. If the visit is more than one week, the father agrees that the child shall return for one overnight with her mother during the visit.
 4. Unless otherwise agreed by the parties in writing, parenting time shall occur in Northern Michigan, that is Karlee shall not be taken more than 100 miles from Petoskey, Michigan. Mr. Exelby further agrees to provide Plaintiff Mother with the address of where he is staying and his contact information.
 5. This agreement does not exclude other family members of the father's from requesting time with Karlee should they be in the area. The mother Kristina Dominic will work together with Roan Exelby to encourage a good relationship amongst all of Karlee's extended family.
 6. The parties agree that the Plaintiff mother shall retain the child's passport and that during Mr. Exelby's parenting time, he shall not remove the child from the United States and shall inform the mother of where the parenting time will occur and any travel plans.
 7. The defendant father shall be entitled to 60 minutes of Skype time per week with the minor child. This may be separated into two thirty minute conversations.
 8. The parties agree to utilize the Michigan Child Support Formula for purposes of calculating child support. The parties further agree to cooperate and immediately provide counsel of record with income information for purposes of calculating child support. Child Support shall be retroactive to January 2011.
 9. Mr. Exelby shall have a visit with Karlee starting August 7, 2011 and proceeding until August 16, 2011, but he agrees to allow Karlee to attend and perform in the Odawa Pow-Wow on Saturday and Sunday, the 13th and 14th. (He will attend with Karlee)


10. This agreement resolves all causes of action between the parties for breach of contract separate maintenance of any kind, custody and parenting time. An additional order regarding child support will be submitted once calculated.


