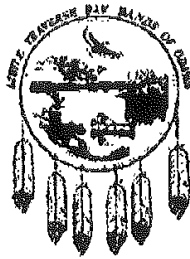

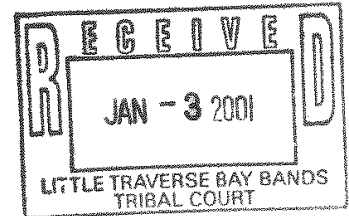

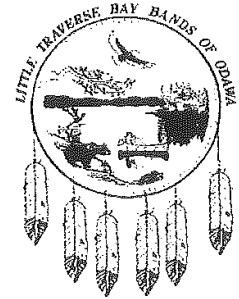

**ORDER FOLLOWING CONSERVATION HEARING**

Held on September 27, 2000

The Respondent admitted that he was engaged in inland fishing without a tribal license as required by tribal law. The Court determined that the admission was voluntary and that Respondent knowingly waived his right to have a hearing and all other corresponding rights were waived.

**IT IS ORDERED THAT Respondent pay a twenty-five dollar (\$ 25.00) fine within thirty (30) days.**

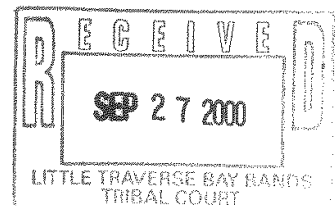
