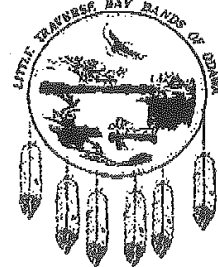

ORDER FOLLOWING CONSERVATION HEARING
Held on December 13, 2000

The Respondent admitted that he was engaged in discharging a firearm from a motorized vehicle in the act of killing a deer in violation of tribal law. The Court determined that the admission was voluntary and that Respondent knowingly waived his right to have a hearing and all other corresponding rights were waived.

IT IS ORDERED THAT Respondent pay a Two-Hundred Fifty Dollar (\$ 250.00) fine, all Tribal Inland Hunting and Fishing privileges are suspended for three years and Tribal Law Enforcement shall retain the firearm for three year suspension period.
