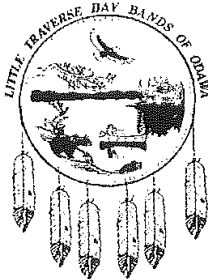

THE COURT FINDS:

1. Ms. Booth did not appear for the Show Cause Hearing on November 14, 2007.

2. Respondent, Patricia Booth, did not attend the show cause hearing and has not satisfy the Default Judgment.

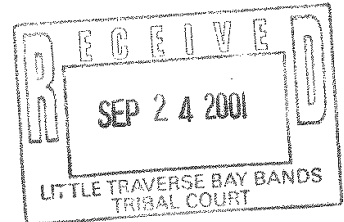
IT IS SO ORDERED THAT:
