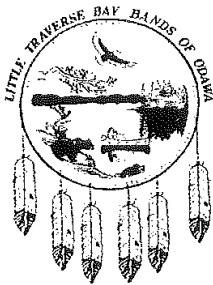

ORDER

On October 31, 2001, Mr. Keshick was issued NRD Civil infraction #4594 for failure to file a catch report. Mr. Keshick returned his plea by mail form to the Court where he pled responsible for the infraction. On December 13, 2001, the Court ordered Mr. Keshick to pay the fine of \$50.00 and court costs of \$50.00 within thirty (30) days. On January 30, 2002, the Court revoked Mr. Keshick's treaty rights for non-payment of the fine and costs.

A hearing was held in this matter on November 14, 2007, where Mr. Keshick was requested to show cause of why he should not be held in contempt of Court for failure to pay the fine and costs. Mr. Keshick did not appear at the hearing, but his sister, Yvonne Fuerte, appeared and informed the Court that her brother is currently incarcerated until March of next year. Ms. Fuerte offered to pay the fine and costs on her brother's behalf.

The Court informed Ms. Fuerte that she was under no obligation to pay the fine and costs on her brother's behalf.

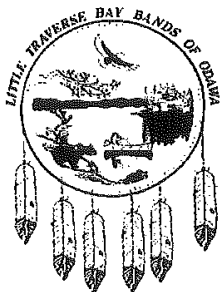

Defendant did not pay the outstanding fine and court costs in this matter within thirty (30) days as ordered by this Court on December 13, 2001.

WHEREFORE, IT IS ORDERD THAT:

1. Defendant's LTBB Natural Resources privileges and licenses be revoked.
2. Defendant is not eligible for reinstatement of privileges or licenses until eligibility is established by this Court.
3. Defendant must petition the Court for reinstatement of LTBB Natural Resources privileges.
4. Privileges will not be reinstated until the fine and costs due in this matter are paid in full.
5. Defendant must pay a filing fee of \$ 50.00 to petition the Court for reinstatement of privileges and licenses.

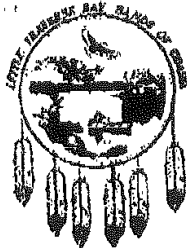

The Defendant admitted responsibility by *Plea by Mail* and did not pay the fine and court costs of \$100.00.

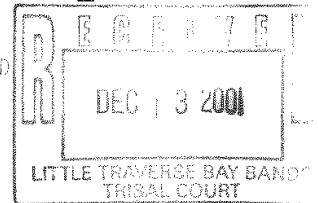
WHEREFORE, IT IS ORDERD THAT Defendant pay the fine and court costs within 30 days.

You will also have to pay a filing fee of \$ 50.00 when you file the petition.
