### ORDER FOLLOWING HEARING

A hearing in this matter was held on October 24, 2007, the Honorable Jenny Lee Kronk, Little Traverse Bay Bands (LTBB) of Odawa Indians Associate Tribal Judge presiding. Present at the hearing were the respondent, Justin Henry Pagel, and LTBB Conservation Officers Roger Willis and Kevin Willis.

### Findings of Fact

Officer Roger Willis issued two citations to Mr. Pagel: (1) on August 22, 2007, for violation of Section IX (c) (1) of the Chippewa, Ottawa Resource Authority (CORA) Commercial Subsistence and Recreational Fishing Regulations for failing to have the required four (4) foot minimum of his staff buoy above the water surface; and (2) on August 23, 2007, for a Section IX (L) violation of CORA Regulations for failing to attend to his gill net for seven (7) straight days.

Officer Willis indicated that Mr. Pagel had been very cooperative during the course of the investigation and admitted not attending to his nets for ten days. Mr. Pagel tried to pull the net but ran out of gas. He later turned in his Commercial Captain license and LTBB conservation officers assisted Mr. Pagel in returning the LTBB boat he had leased from the Tribe.

Mr. Pagel pled responsible to the charges as stated in the citations.

#### Conclusions of Law

The Court finds that Mr. Pagel violated Sections IX (c) (1) and (L) of the CORA Regulations and imposes a fine of \$100.00 for each violation and court costs of \$50.00 for a total of \$250.00. Mr. Pagel said he was a college student with no funds to pay, but agreed to pay the fine and court costs by December 20, 2007, with his per capita funds,

Therefore, it is **ORDERED** that Mr. Justin Henry Pagel pay to the Court \$250.00 in fines and court costs by December 20, 2007.
