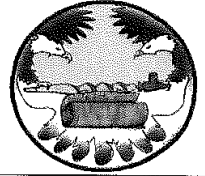

Satisfaction of Judgment

The Respondent submitted the Plea by Mail form accepting responsibility for violating The Little Traverse Bay Bands of Odawa Indians Natural Resources 1836 Ceded Territory Rules and Regulations Section VI, Subsection (E), Pursuit with a Vehicle and Section I, Subsection (1), Transportation of firearms, Bows, Cross-bows, and Muzzle-loaders. A fine of \$425 was imposed by this Court. On the Judgment and Order dated January 14, 2014, the Respondent had until April 14, 2014 to complete 40 hours of community service in lieu of paying his fine. This Court has received proof of 40 community service hours being completed by the Respondent.

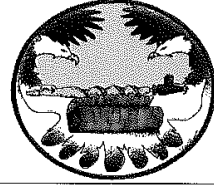
