REQUEST FOR TRUST ACQUISITION

WHEREAS the Secretary of the Interior is generally authorized to accept land into trust for the Little Traverse Bay Bands of Odawa Indians under the Indian Reorganization Act, 25 U.S.C. § 465, and is explicitly required to accept land into trust for the Little Traverse Bay Bands of Odawa Indians in Emmet and Charlevoix Counties, Michigan, by the Little Traverse Bay Bands of Odawa Indians and the Little River Band of Ottawa Indians Act, 25 U.S.C § 1300k-4 (a).

WHEREAS the Tribe has an interest in the following described parcel in Bear Creek Township, Emmet County, Michigan, street address 1345 U.S. 31 N, Petoskey, Michigan 49770 which it desires to be held in trust for the Tribe by the Secretary of the Interior:

Sec 34 T35N R5W Com 64 ft S & 181, 5 ft W of NE cor of SW 1/4 of NE 1/4, th W 148.5 ft, S 151.7 ft, w'ly 50 ft, N 370.81 ft, E 150.05 ft, to a pt 9 rd N of POB, S 9 rd m/1 to POB.

WHEREAS the Tribe is currently using, and intends continue to use this parcel to house tribal health administration and services. Once the Tribe constructs its main administration building, it will continue to use this parcel as a satellite office for Tribal administration and services.

THEREFORE BE IT RESOLVED THAT the Little Traverse Bay Bands of Odawa

Indians requests that the Secretary of the Interior accept this parcel in trust for the Tribe.
