TRIBAL RESOLUTION #050210-01

Authorization for Payoff of Loan on 7500 Odawa Circle

WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians (LTBB), and its citizens are vested with inherent sovereignty and right to self-governance;

WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

WHEREAS National City Bank (now PNC) made a construction loan to LTBB for 7500 Odawa Circle;

WHEREAS the balance on that loan is approximately \$2,268,166.63.

THEREFORE, BE IT RESOLVED that the Tribal Council authorizes and approves for the existing loan against 7500 Odawa Circle, Harbor Springs, Michigan in the amount of approximately \$2,268,166.63 to be paid in full with National City Bank (now PNC) that allows for early repayment without penalty.

FURTHER BE IT RESOLVED that Tribal Council authorizes and requests the Chairman, or in his absence Vice Chair administer oversight authority to the extent necessary to ensure that such funds are applied in accordance with this Tribal Resolution.

CERTIFICATION
