**RESOLUTION # 051902-03**  
**ITC Application for Community Service Block Grant**

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe as reaffirmed and restored under Public Law 103-324;

**WHEREAS** the Tribal Council as the governing body of the Little Traverse Bay Bands of Odawa Indians has determined that the American Indian population within the State of Michigan would be best served with the Community Service Block Grant funding applied for and distributed through the Inter-Tribal Council of Michigan;

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians is a member of the Inter-Tribal Council of Michigan and recognizes the importance of the Community Services Block Grant funds to Indian communities and vital programs;

**THEREFORE BE IT RESOLVED** that the Tribal Council authorizes the Inter-Tribal Council of Michigan, Inc. to apply for the Community Services Block Grant Fund from the Office of Community Services, United State Department of Health and Human Services for fiscal year 2002-2003.

**FURTHER RESOLVED** that the Tribal Council authorizes Sharon L. Teeple, Executive Director of Inter-Tribal Council of Michigan to negotiate and implement the financial award on behalf of the member Tribes of the Inter-Tribal Council of Michigan.
