Funding for the Michigan Indian Family Olympics in the Amount of \$4,700 from Prior Year Funds

- WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians ("Tribe"), and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- **WHEREAS** the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected legislative body of the Tribe;
- **WHEREAS** participation in the Michigan Indian Family Olympics is an activity supported by the Little Traverse Bay Bands of Odawa Indians.

THEREFORE, BE IT RESOLVED that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians approves and authorizes funding for participation in the Michigan Indian Family Olympics in the amount of \$4,700.00.

FURTHER, BE IT RESOLVED that the Tribal Council appropriate \$4,700.00 from prior year funds to be placed within the Executive Budget to fund participation for this event.
