**RESOLUTION 06149801
HELPING HANDS TREATMENT MODEL**

WHEREAS the Little Traverse Bay Bands of Odawa Indians, a Federally recognized Indian tribe, is a member of the Inter-Tribal Council of Michigan, Inc., an inter-tribal entity that promotes coordination of services, funding and programs for the ten Federally recognized member tribes in Michigan;

WHEREAS the physical and mental well-being of its children and adolescents are of great importance to the Little Traverse Bay Bands of Odawa Indians;

WHEREAS there currently exist gaps in treatment for Native American adolescents in Michigan which can be addressed through collaborative efforts between the Little Traverse Bay Bands of Odawa Indians and the Inter-Tribal Council of Michigan, Inc. in implementing the Helping Hands Adolescent Intensive Outpatient Substance Abuse Treatment Model;

THEREFORE BE IT RESOLVED THAT the Tribal Council of the Little Traverse Bay Bands of Odawa Indians agrees to subcontract with the Inter-Tribal Council of Michigan, Inc. as a site for the Center for Substance Abuse Treatment, Targeted Capacity Expansion Program: Helping Hands Treatment Model for a contract period from October 1, 1998 through September 30, 2001;

FURTHER RESOLVED THAT the Little Traverse Bay Bands of Odawa Indians supports the efforts of the Inter-Tribal Council of Michigan to obtain funding for this purpose through the Center for Substance Abuse Treatment;

FURTHER RESOLVED THAT the LTBB Tribal Chairman or his designee is authorized to negotiate and sign the contract, and any amendments, and is also authorized to serve as the tribal senior official representative for purposes of the contract and to sign all documents necessary to receive and administer funds under the contract.
