SUPPORT AND AUTHORIZATION FOR SECTION 104
CLEAN WATER ACT PROGRAM APPLICATION TO EPA**

WHEREAS the Little Traverse Bay Bands of Odawa Indians of Michigan is a federally recognized Indian tribe, as reaffirmed under Public Law 103-324 of September 21, 1994;

WHEREAS the Tribe wishes to ensure the current and future well being of the environment for its Tribal members and their future generations;

WHEREAS the United States Environmental Protection Agency has provided the Tribe with an invitation to apply for funding under the Section 104 Program of the Clean Water Act;

THEREFORE IT IS RESOLVED THAT the Little Traverse Bay Bands of Odawa Indians Tribal Council approves the application for funding under the Section 104 Program;

FURTHER RESOLVED THAT the Tribal Chairman or his designee is authorized on behalf of the Tribe to sign all documents necessary to apply for, receive and administer such funds and implement the program.
