Supplemental Funding for Funding Elder Dental Program in the amount of \$20,000 to come from Prior Year Funds

- WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- **WHEREAS** the Little Traverse Bay Bands of Odawa Indians is the elected legislative body of the tribe;
- WHEREAS Tribal Council passed TR 022110-01 Supplemental funding for Elders Program Establishing an Elders Dental Program Fund;
- **WHEREAS** TR 022110-01 requires the Tribal Chairperson to make Tribal Council aware on any shortages of funding;
- **WHEREAS** To adequately fund the program, an estimated additional \$20,000 is needed.

THEREFORE, BE IT RESOLVED that the Tribal Council appropriates the sum of \$20,000.00 from prior year funds to assist Tribal Elders with specialized dental costs not covered by the Tribal Health Clinic and approves the funding to the Elders Department budget.
