**RESOLUTION 082000-07**

**REQUEST FOR TRUST ACQUISITION**

**WHEREAS** the Secretary of the Interior is generally authorized to accept land into trust for the Little Traverse Bay Bands of Odawa Indians under the Indian Reorganization Act, 25 U.S.C. § 465, and specifically mandated to accept transfer of lands within Emmet and Charlevoix Counties, Michigan for the Tribe under 25 U.S.C. § 1300k-4(a);

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians possesses clear title in fee the following described parcel which it intends to transfer to the United States in trust for the Tribe:

Land situated in the Township of Hayes, Charlevoix County, Michigan:  
Part of Government Lot 3, Section 2, Township 34 North, Range 7 West, more fully described as: Commencing at the Southwest corner of said Section 2; thence North 01°17'40" West 1577.87 feet along the West 1/8 line of said Section 2 to the Northerly right-of-way line of Highway U.S. 31, for the Point of Beginning; thence North 01°17'40" West 198.90 feet; thence South 59°02'54" East 139.08 feet along a traverse line near the shore of Lake Michigan; thence South 68°56'00" East 341.11 feet along said traverse line to the Northerly right-of-way line of Highway U.S. 31; thence Northwesterly 422.00 feet along the arc of a 01°30' curve to the left along the Northerly right-of-way line of Highway U.S. 31, the long chord of which bears North 86°55'57" West 421.79 feet to the Point of Beginning. (This parcel is known hereafter as Parcel 1)

TOGETHER WITH a Drainfield and Septic Easement described running over a across the parcels described in Exhibits A-D of the Grant of Exclusive Permanent

Septic Tank/Drainfield Easement recorded April 1, 1991 in Liber 330, Page 7, Charlevoix County Records, EXCEPTING that portion of said easement which runs over and across the railroad right-of-way. (This parcel is also know hereafter as Parcel 2).

**WHEREAS** the Tribe intends to use this parcel to access its Treaty fishing waters of Lake Michigan thereby aiding in the economic development of the Tribe and its members;

**THEREFORE BE IT RESOLVED THAT** the Little Traverse Bay Bands of Odawa Indians requests that the Secretary of the Interior accept the above described parcel in trust for the Little Traverse Bay Bands of Odawa Indians.

#### **Certification**

As Tribal Chairman and Tribal Secretary, we certify that this Resolution was duly adopted by the Tribal Council of the Little Traverse Bay Bands of Odawa Indians at a regular meeting of the Tribal Council held on August 20, 2000 at which a quorum was present, by a vote of seven (7) in favor, zero (0) opposed and zero (0) abstentions as recorded by this roll call.
