Request for Funding from Northrop Grumman Health Solutions,
Little Traverse Bay Bands of Odawa Indians
Fetal Alcohol Spectrum Disorders Response Initiative Planning Project

WHEREAS: the Little Traverse Bay Bands of Odawa Indians (“LTBB” or “Tribe”) is a Federally recognized Indian Tribe reaffirmed by the United States Congress on September 21, 1994 in Public Law 103-324, as amended, which exercises sovereign governmental authority over the people, land, and water within its jurisdiction and administers a wide range of governmental programs;

WHEREAS: the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected governing body of the Tribe:

WHEREAS: the Tribe recognizes the impact of alcohol and substance abuse within the LTBB Community;

WHEREAS: Northrop Grumman Health Solutions is requesting proposals from local community organizations and tribal governments to improve their existing service delivery systems to prevent Fetal Alcohol Spectrum Disorders (FASD) and/or treat children or adults with FASD;

WHEREAS: Northrop Grumman Health Solutions is the prime contractor for the Substance Abuse and Mental Health Services Administration Fetal Alcohol Spectrum Disorders Center for Excellence.

THEREFORE BE IT RESOLVED that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians authorizes and supports the grant application to Northrop Grumman Health Solutions for funding for a “LTBB Tribal Fetal Alcohol Spectrum Disorders Response Initiative Planning Project.”

BE IT FURTHER RESOLVED that Tribal Chairman Frank Ettawageshik or his designee is authorized to execute any documents necessary to apply for, receive, and administer funds under the grant.
