Authorization for Payoff of Loan on 911 Spring Street, Petoskey, Michigan in the amount of approximately \$87,000.00

- WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians (LTBB), and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- WHEREAS the Little Traverse Bay Bands of Odawa Indians has a secured loan on the 911 Spring Street, Petoskey, Michigan with Northern Michigan Bank in the amount of approximately \$87,000.00;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians has approximately \$90,000.00 in a restricted secured collateral account with Northern Michigan Bank;

THEREFORE, BE IT RESOLVED that the Tribal Council authorizes and approves for the existing loan against 911 Spring Street, Petoskey, Michigan in the amount of approximately \$87,000.00 to be paid in full with the Northern Michigan Bank secured collateral account and any remaining funds be transferred to the Tribe's General fund account.

FURTHER BE IT RESOLVED that Tribal Council authorizes and requests the Chairman, or in his absence Vice Chair administer oversight authority to the extent necessary to ensure that such funds are applied in accordance with this Tribal Resolution.
