**National City Bank Account Signer Resolution**

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians (LTBB or Tribe) holds the following accounts with National City Bank of Michigan/Illinois: Long Term Account # M17650009, Liquid Account # M17650017, Balanced Account # M17650025;

**WHEREAS** the Tribe and National City Bank have previously entered into a Custody Agreement with regard to said accounts;

**THEREFORE BE IT RESOLVED** that Tribal Chairman Gerald V. Chingwa, Tribal Administrator Albert Colby Jr., and Tribal Council Treasurer Alice Yellowbank may take or direct any action on behalf of the Tribe authorized under said Agreement including, without limitation, the right to endorse for transfer any and all securities in the name of the Tribe to National City Bank, or its nominee, the right to add assets to and withdraw assets from the accounts held under said Agreement, and the right to direct the investment of assets held under said Agreement;

**FURTHER RESOLVED** that National City Bank is authorized to rely on this Resolution and that the named persons continue to have the authority stated above until National City Bank receives written notice of any change.
