- Supplemental Funding in the Amount of \$70,220 for the Legislative Branch FY14 Budget for purchase of parcel 54, 312.5 acres of land known as 'Tuthill Farm' property
- WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- **WHEREAS** the Little Traverse Bay Bands of Odawa Indians approved the purchase and financing of the parcel 54, consisting of 312.5 acres of land known as "Tuthill Farm" property;
- **WHEREAS** the annual payment for the property purchase is approximately \$70,200 for a term of five years;
- **WHEREAS** the Tribal Council budget for FY14 has already been approved without funding for the land purchase.

THEREFORE, BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and supplements funding to the Legislative Branch in the amount of \$70,220 for the annual payment for the financing of parcel 54, consisting of 312.5 acres of land known as "Tuthill Farm" property, with funding to come from prior period funds.

FURTHER BE IT RESOLVED that in accordance with the Constitution the Executive Branch shall administer such funds as appropriated by Tribal Council.
