RESCISSION OF TRIBAL RESOLUTION #031603-02, ELDERS ADVISORY BOARD

- WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay
 Bands of Odawa Indians (LTBB), and its citizens are vested with inherent
 sovereignty and right to self-governance;
- WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- WHEREAS In accordance with the Tribal Constitution adopted February 1, 2005, the Tribal Chair represents the Tribe in an ambassadorial capacity;
- WHEREAS Tribal Resolution #031603-02, Elders Advisory Board was approved prior to the enactment of the current Tribal Constitution;

THEREFORE, BE IT RESOLVED that the Tribal Council rescinds Tribal Resolution #031603-02, Elders Advisory Board.
