WHEREAS the Little Traverse Bay Bands Tribal Council has passed an enrollment ordinance on January 22, 1995; and

WHEREAS the Enrollment Committee and Tribal Council have agreed that an amendment is necessary to better facilitate the workings of the committee;

NOW THEREFORE BE IT RESOLVED that Section 5 (a & d) of the Little Traverse Bay Bands Enrollment Ordinance be amended to read:

SECTION 5.

Eligibility Criteria for Membership.

The membership of the Little Traverse Bay Bands of Odawa Indians shall consist of all persons born prior to May 2, 1996, who are one-fourth (1/4) or more Indian blood quantum, of which at least (1/8) of the total blood quantum is traceable to persons identified in Section 5(a-d), and have submitted application on or before May 2, 1996, provided such persons are not currently enrolled in any other Federally recognized Indian Tribe or Band:


- a. All persons whose name appears on the Durant Roll of 1908 as approved by the Secretary of the Interior on February 18, 1910; and
- b. All direct lineal descendants of persons listed on the 1836 to the 1870 Annuity payrolls of Ottawa & Chippewa Indians of Michigan and referenced in the in the 1850 through the 1910 Federal Population Enumeration (i.e. Census Records); and
- c. All direct lineal descendants of persons listed under the following chiefs and areas of residency:
  - Nawwemaishcotay - Cross Village
  - Shawwawdayse - Charlevoix,
  - Shawwawnegwawnaybe - Bay Shore,
  - Louis Micksawbay - Charlevoix,
  - Awnegwawbay - Petoskey,
  - Nawogemaw - Good Hart/Middle Village,
  - Simon Keywawkezhick - Harbor Springs,
  - Joseph Waywaydum - Burt Lake,
  - Daniel Nesawwawquot - Harbor Springs,
  - Payzhickwaywedung - Beaver Island,
  - Nawoquaygawbowe - Manistique,
  - Kawgegaypenayse - North Shore; or
- d. All persons of Michigan Ottawa & Chippewa descent who resided in the


service area of the tribe as defined in Public Law 103-324, at the time of the 1908 Durant Roll as approved by the Secretary of the Interior on February 18, 1910. This will be determined by Durant's Census Roll and corresponding fieldnote's which indicate residency and can also be referenced in the 1860-1920 Federal Populations Enumerations (i.e. Census Records).

#### CERTIFICATE OF ADOPTION

This resolution was considered and adopted by the Tribal Council of the Little Traverse Bay Bands of Odawa Indians at a meeting held on June 4, 1995 by a vote of 3 in favor, 0 opposed and 0 abstentions.
