

WAGANAKISING ODAWAK STATUTE 1997020

TECHNICAL AMENDMENT TO GAMING ADMINISTRATION ORDINANCE

The Gaming Administration Ordinance, (Waganakising Odawak Statute 1995015) is amended as follows:

Replace Section III(B) with:

B. Eligibility

A person must be a duly enrolled member of the Tribe at least twenty one (21) years of age and must be a person who would qualify for licensing under the Tribe's Gaming Regulatory Ordinance to be eligible to serve on the Gaming Administration. No person can be appointed to the Gaming Administration who is employed in Gaming operations by another federally-recognized Indian tribe or any other facility or enterprise conducting Gaming. No person can be appointed to the Gaming Administration who had been convicted of a felony in tribal, state, or federal court within 7 years prior to the date of appointment.

Replace Section III (C)(2) with:

2. Term and Compensation. Members of the Gaming Administration shall be appointed to serve for three (3) year terms. Members may be reappointed for additional terms without limitation. Provided, to stagger terms, when the Tribal Council makes initial appointments, one person shall be appointed to a one (1) year term, one person shall be appointed to a two (2) year term, and one person shall be appointed to a three (3) year term. All appointments thereafter shall be for three (3) year terms. The Tribal Council shall determine and authorize the compensation to be paid to members of the Gaming Administration based upon the Tribal Council's determination of the time required to be expended upon Administration duties and the qualifications of the appointed Administrators.

Delete section IV (A) (9), "surveillance."

Add the following section IV(E):

E. Bank Accounts


The Gaming Administration shall have the authority to establish and maintain such bank accounts as may be necessary or convenient for the operation of the Enterprise.


Certification
