WAGANAKISING ODAWAK STATUTE # 2012-019 AMENDMENT TO WOS 2005-014 TRIBAL TREASURER RESPONSIBILITIES

SECTION IV. OTHER DUTIES REQUIRED BY THE TRIBAL COUNCIL

B. The Treasurer shall:

- 4. Assume responsibilities of the Legislative Leader if there is a vacancy in both the Legislative Leader position and in the Secretary position and not to exceed thirty (30) days.
- 5. Assume responsibilities of the Secretary if there is a vacancy in the Secretary position and that vacancy cannot exceed thirty (30) days.
- **6.** Under this Statute a vacancy occurs under the following conditions:
 - a. An emergency vacancy occurs when the Legislative Leader is unavailable or unresponsive by phone, electronic communications, or other means for a period of not less than twenty-four (24) hours and the matter needs to be addressed within forty-eight (48) hours or the matter needs immediate attention within a twenty-four (24) hour period to prevent the Tribe from suffering detrimental harm.
 - b. A temporary vacancy occurs when the Legislative Leader is unavailable or unresponsive by phone, electronic communications, or other means for a period of less than thirty (30) days.
- 7. If a permanent vacancy occurs there shall be a motion by Tribal Council to declare an Officer position vacant and shall not be considered a temporary vacancy. "Permanent Vacancy" means a vacancy by reason of death, resignation, removal from office, or an inability or incapacity that is for more than thirty (30) days.
