**D.** "Chief Financial Officer" or "CFO" means the person employed by the Gaming Enterprises who oversee the issuance of financial information related to the Gaming Enterprises.

Any questions regarding the report shall be directed to the Gaming Enterprise Board.

## SECTION II. EFFECTIVE DATE

Effective upon signature of the Executive or thirty (30) days from Tribal Council approval whichever comes first or if the Executive vetoes the legislation, then upon Tribal Council override of the veto.
