TRIBAL RESOLUTION # 080521-0

To Authorize Funding in the Amount up to \$45,000 for Purchase of Parcel #139 to come from the General Fund-Fund Balance

- WHEREAS the Waganakising Odawak, known as the Little Traverse Bay Bands of Odawa Indians, is a nation of citizens with inherent sovereignty and right to self-governance;
- where the Little Traverse Bay Bands of Odawa Indians (LTBB or Tribe) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- WHEREAS Article VII (B)(9) of the LTBB Constitution delegates to the Tribal Council the authority to "Purchase, receive by gift, or otherwise acquire land, interests in land, personal property or other intangible assets which the Tribal Council may deem beneficial to the Little Traverse Bay Bands of Odawa Indians;"

WHEREAS Tribal Council passed a motion on July 8, 2021 to pursue Land parcel #139;

THEREFORE BE IT RESOLVED that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians authorizes the Tribal Treasurer or Tribal Chairperson to execute any documents needed to close on the purchase of land parcel #139 and appropriates up to \$45,000.00 to cover the purchase price, survey, and closing costs to come from the General Fund-Fund Balance.
