TRIBAL RESOLUTION #102121-04

To Authorize and Approve any funds received from the Housing Department's Market Rate Rental Program Carryover each Fiscal Year

- WHEREAS, the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and rights of self-governance; and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which are the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and
- **WHEREAS**, the Little Traverse Bay Bands has a Housing department that currently manages Market rate rentals; and
- WHEREAS, in accordance with the WOS 2020-006 Tribal Government Budget Formulation and Modification Statute the Executive Branch supports and recommends the Establishment of a Market Rate Rental program; and

THEREFORE, BE IT RESOLVED, the Little Traverse Bay Bands of Odawa Indians Tribal Council establishes a Market Rate Rental program restricted fund for monies received by the rents collected from the Market Rate Rentals; and

FURTHER BE IT RESOLVED that any remaining funds in the Housing Department's Market Rate Rental program will carry over each fiscal year to be used solely by the Housing Department for administrative, maintenance and acquisition of Market Rate Rental Program; and

FINALLY, BE IT RESOLVED that that in accordance with the Constitution the Executive Branch shall administer such funds as authorized by Tribal Council.
