**TRIBAL RESOLUTION # 071422- 02**

**Supplemental Funding in the Amount of \$7,000.00 to Pay Detention Costs to come from  
the General Fund -Fund Balance**

**WHEREAS,** the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;

**WHEREAS,** the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

**WHEREAS,** the FY2022 detention cost allocation has been exceeded and additional funding is required to cover expenses for the remainder of the year;

**WHEREAS,** in accordance with the WOS 2015-2016 Tribal Government Budget Formulation and Modification Statute;

**THEREFORE, BE IT RESOLVED** that the Tribal Council appropriates supplemental funding in the amount of \$7,000.00 for the purpose of paying detention costs which shall come from the General Funds – Fund Balance.

**FURTHER, BE IT RESOLVED** that in accordance with the Constitution the Executive Branch shall administer such funds as appropriated by Tribal Council.

## CERTIFICATION
