Use of Third-Party Support Revenue in the Amount of \$1,307,593.00 to Fund the Crooked Tree Wellness Clinic FY2023 Budget

- WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance; and
- WHEREAS the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which is the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- WHEREAS Tribal Council authorizes the use of the third-party Support Revenues through Tribal Resolution; and
- **WHEREAS** Tribal Council appropriated \$550,000 from third-party billing revenue to be used to fund the start-up expenses for a Medicaid-only Clinic.
- **WHEREAS** additional funding is needed to support the operations and services provided by the Crooked Tree Wellness Clinic in FY 2023.

THEREFORE, BE IT RESOLVED that the Tribal Council authorizes the use of third-party billing revenue in the amount of \$1,307,593.00 for the purpose of funding the Crooked Tree Wellness Clinic FY2023 budget.

FURTHER BE IT RESOLVED that in accordance with the Constitution, the Executive Branch shall administer such funds as appropriated by Tribal Council.
