Crooked Tree Wellness Clinic Services to Non-Beneficiaries

- WHEREAS, the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and rights of self-governance; and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which are the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- **WHEREAS**, the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and
- WHEREAS, Tribal Council authorizes and appropriates budgets through Tribal Resolutions; and
- WHEREAS, The Tribe proposes to offer services to otherwise non-eligible individuals as authorized and provided for and in compliance with Section 813(c) of the IHCIA, as amended, 25 U.S.C. § 1680c(c). The Little Traverse Bay Band affirms that the provision of services to non-eligible beneficiaries will not result in a denial or diminution of health services to eligible Indians.

THEREFORE, **BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and approves services to be offered to non-tribal patients at the Crooked Tree Wellness Clinic.

FINALLY, BE IT RESOLVED that in accordance with the Constitution, the Executive Branch shall administer such funds as appropriated by Tribal Council.
