- I. Introduction.** The purpose of these regulations is to establish the fee schedule for Limited Liability Company (LLC) documents filed with the LTBB Department of Commerce.
- II. Definitions:**
- A. **Military Veteran:** means a person who served in the active military, naval, or air service, and who was discharged or released therefrom under conditions other than dishonorable this includes United States Army, Navy, Marine Corps, Air Force, Coast Guard service, and members of the Reserves, Air or Army National Guard.
- III. Fee Schedule**
- A. The following fees are hereby established:
1. Filing an application to organize an LLC: \$20.00
 2. Filing articles of operation: \$10.00
 3. Filing an application to reserve a name: \$10.00
 4. Filing a certificate of assumed name or certificate of termination of assumed name: \$10.00
 5. Filing an application for an amendment to the articles of organization or operation: \$5.00
 6. Filing a statement of change of name or address of registered agent: \$5.00
 7. Filing any other statement or report of an LLC, including a certificate of merger or dissolution:
 - a. Merger: \$20.00 for each entity involved in the merger

- b. Dissolution: no cost
 - c. Annual Renewal: \$10.00
 - d. Other: \$10.00
8. Furnishing a certified copy of any document, instrument report, or other paper related to the LLC: \$10.00
9. Furnishing a certificate as to the status of an LLC or as to the existence or non-existence of facts relating to the LLC:
- a. Certificate of Good Standing or other status of LLC: \$10.00
 - b. Certificate of Fact listing all documents filed: \$25.00
 - c. Certificate of Fact stating a particular fact or no fact on record: \$10.00
10. Furnishing uncertified copies, including copies sent electronically, to any person or group: \$5.00 per document requested
11. Furnishing a certificate of organization in accordance with this Statute: \$10.00
- B. In accordance with Waganakising Odawak Statute 2021-009: Waiver of Fees for Military Veterans, all fees listed in this section are waived for Military Veterans.

IV. Payments

- A. Payments can be made via cash, check, or money order made payable to the LTBB Department of Commerce.
