Supplemental Funding in the Amount of \$12,000.00 for a Water and Wastewater Systems Engineering Study of the LTBB Government Center to come from the General Fund-Fund Balance

- WHEREAS section XIV of the Tribal Government Budget Formulation and Modification Statute, WOS 2020-006, requires supplemental funding to be appropriated by Resolution; and
- WHEREAS a request for supplemental funding must include (1) the reason for requesting the supplemental funding, (2) a brief narrative, (3) the amount requested, (4) required signatures, and (5) the funding source; and
- whereas the Planning Department requests the supplemental funding to engage the services of Wade Trim, Inc. at a total estimated fee of \$12,000 to perform the specific additional service of evaluating the potable water supply and distribution and onsite sewage disposal systems to facilitate master planning for building out the Little Traverse Bay Bands of Odawa Indians Government Center;
- WHEREAS the Appropriations and Finance Committee passed a motion on February 21, 2023 to recommend to the Tribal Council to supplement the Planning Department budget to contract with engineering services firm Wade Trim, Inc. to evaluate capacity and capabilities of the water and sewage systems in the Little Traverse Bay Bands of Odawa Indians Government Center; and

**THEREFORE, BE IT RESOLVED** that, as recommended by the Appropriations and Finance Committee, the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and supplements funding to the Executive Branch in the amount of \$12,000 funding to come from the General Fund-Fund Balance.

**BE IT FURTHER RESOLVED,** that in accordance with the appropriation, Tribal Council approves the attached Professional Services Agreement and authorizes Planning Director Amanda Swiss to sign on behalf of the Little Traverse Bay Bands of Odawa Indians.
