TRIBAL RESOLUTION # 032323- 02

Authorizes and approves approximately \$11,600,000.00, not to exceed \$12,000,000.00, in supplemental funding to come from the Short-Term Investment Account to pay off Odawa Casino Resort's loan with PNC

- WHEREAS, the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and rights of self-governance; and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which are the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and
- WHEREAS, Tribal Council authorizes and appropriates budgets through Tribal Resolutions; and
- WHEREAS, Odawa Casino Resort refinanced a remaining balance of a loan payable to Wells Fargo of \$13,000,000 and received working capital of \$13,500,000 for Mackinaw Phase III, the Ozone renovation to Victories Sports & Entertainment, and a new hotel roof in July of 2020 totaling \$26,500,000.
- WHEREAS, in February 2023, Odawa Casino Resort paid off the \$13,000,000 that was originally from Wells Fargo, but refinanced through PNC in July of 2020.
- WHEREAS, Odawa Casino Resort has presented to Tribal Council a plan for significant interest savings and increased tribal distributions by paying off the balance of the working capital loan with PNC.

Tribal Resolution: Authorizes and approves approximately \$11,600,000.00, not to exceed \$12,000,000.00, in supplemental

WHEREAS, Odawa Casino Resort has a loan balance of \$11,597,574.08 as of March 8, 2023.

THEREFORE, BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council Authorizes and approves approximately \$11,600,000.00, not to exceed \$12,000,000.00, in supplemental funding to come from the Short-Term Investment Account to pay off Odawa Casino Resort's loan with PNC

FINALLY, BE IT RESOLVED that in accordance with the Constitution, the Executive Branch shall administer such funds as appropriated by Tribal Council.
