- WHEREAS, Section XIV of the Tribal Government Budget Formulation and Modification Statute, WOS 2020-006, requires supplemental funding to be approved by Resolution, and
- WHEREAS, a request for supplemental funding must include (1) the reason for requesting the supplemental funding, (2) a brief narrative, (3) the amount requested (4) required signatures, and (5) the funding source, and
- WHEREAS, The Planning Department requests the supplemental funding to acquire an architectural firm to assist with ongoing architectural and site design, construction administration and/or management services, as well as sealed construction drawings for a possible variety of smaller construction projects, design studies and feasibility analyses, and
- WHEREAS, The Appropriations and Finance Committee passed a motion to recommend to Tribal Council to supplement the Planning Department Budget to contract with an architectural firm to provide professional services to the tribe for site, building and feasibility analyses and construction administration and management service, and

THEREFORE, BE IT RESOLVED that as recommended by the Appropriations and Finance Committee, the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and supplements funding to the Planning Department in the amount of \$100,000 funding to come from the General Fund- Fund Balance for FY2023 and FY2024.
