- WHEREAS, Section XIV of the Tribal Government Budget Formulation and Modification Statute, WOS 2020-006, requires supplemental funding to be approved by Resolution, and
- WHEREAS, a request for supplemental funding must include (1) the reason for requesting the supplemental funding, (2) a brief narrative, (3) the amount requested (4) required signatures, and (5) the funding source, and
- WHEREAS, A means of egress is required by the LTBB Building code Reg WOS 2009-007 02172022-02, and
- WHEREAS, The Planning Department requests the supplemental funding to engage the services of a design professional and general contractor to design and construct a means of egress for 911 Spring Street to replace the existing unsafe structure, and
- WHEREAS, The Appropriations and Finance Committee passed a motion to recommend to Tribal Council to supplement the Planning Department Budget to contract with a design profession and general contractor to design and construct an exterior staircase that meets the requirements for egress at the 911 Spring Street building, and

THEREFORE, BE IT RESOLVED that as recommended by the Appropriations and Finance Committee, the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and supplements funding to the Planning Department in the amount of \$120,000 funding to come from the General Fund-Fund Balance. Funds are available until completion of the project.
